- LB 578 (*McDonald*) Change alcohol excise tax provisions, prohibited interests in alcoholic liquor wholesalers and business premises, and penalties for driving under the influence
- *LB 588 (*Business and Labor Committee*) Change provisions relating to the workers' compensation hospital fee schedule, payment of providers, and disability compensation
- LB 588A (*Cornett*) Appropriation bill
