A BILL

- 1 FOR AN ACT relating to appropriations; to appropriate funds to aid
2 in carrying out the provisions of Legislative Bill 1147,
3 One Hundredth Legislature, Second Session, 2008.
4 Be it enacted by the people of the State of Nebraska,

1 Section 1. There is hereby appropriated (1) \$16,800 from
2 the Judges Expense Fund for FY2008-09 and (2) \$-0- from the Judges
3 Expense Fund for FY2009-10 to the Public Employees Retirement
4 Board, for Program 41, to aid in carrying out the provisions of
5 Legislative Bill 1147, One Hundredth Legislature, Second Session,
6 2008.

7 No expenditures for permanent and temporary salaries and
8 per diems for state employees shall be made from funds appropriated
9 in this section.

10 Sec. 2. There is hereby appropriated (1) \$11,200 from
11 the School Expense Fund for FY2008-09 and (2) \$-0- from the School
12 Expense Fund for FY2009-10 to the Public Employees Retirement
13 Board, for Program 41, to aid in carrying out the provisions of
14 Legislative Bill 1147, One Hundredth Legislature, Second Session,
15 2008.

16 No expenditures for permanent and temporary salaries and
17 per diems for state employees shall be made from funds appropriated
18 in this section.

19 Sec. 3. There is hereby appropriated (1) \$136,869 from
20 the General Fund for FY2008-09 and (2) \$136,869 from the General
21 Fund for FY2009-10 to the Public Employees Retirement Board, for
22 Program 515, to aid in carrying out the provisions of Legislative
23 Bill 1147, One Hundredth Legislature, Second Session, 2008.

24 No expenditures for permanent and temporary salaries and
25 per diems for state employees shall be made from funds appropriated

1 in this section.

2 Sec. 4. There is hereby appropriated (1) \$100,000 from
3 the State Investment Officer's Cash Fund for FY2008-09 and (2)
4 \$-0- from the State Investment Officer's Cash Fund for FY2009-10
5 to the Nebraska Investment Council, for Program 610, to aid in
6 carrying out the provisions of Legislative Bill 1147, One Hundredth
7 Legislature, Second Session, 2008.

8 No expenditures for permanent and temporary salaries and
9 per diems for state employees shall be made from funds appropriated
10 in this section.
