A BILL

1 FOR AN ACT relating to land surveyors; to amend section
2 81-8,118, Reissue Revised Statutes of Nebraska; to change
3 application, examination, and registration fees; and to
4 repeal the original section.
5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 81-8,118, Reissue Revised Statutes of
2 Nebraska, is amended to read:

3 81-8,118 To pay the expense of the operation and
4 enforcement of sections 81-8,108 to 81-8,127, the examining board
5 shall, ~~at the time application for registration is submitted,~~
6 ~~collect from the applicant an examination fee of not less than~~
7 ~~twenty-five dollars and not more than one hundred fifty dollars~~
8 ~~as set forth in the rules or bylaws. If the applicant fails~~
9 ~~to qualify, the fee shall not be returned but the applicant~~
10 ~~may be reexamined with the payment of a reexamination fee as~~
11 ~~set forth in the rules or bylaws. establish application and~~
12 ~~registration fees. Total application and registration fees shall~~
13 ~~not exceed two hundred dollars and shall be in addition to~~
14 ~~the examination fee which shall be set to recover the costs~~
15 ~~of the examination and its administration. The board may direct~~
16 ~~applicants to pay the examination fee directly to a third party~~
17 ~~who has contracted to administer the examination. At the time~~
18 ~~the application for registration is submitted the board shall~~
19 ~~collect from the applicant a nonrefundable application fee. If~~
20 ~~the applicant successfully qualifies by examination, he or she~~
21 ~~shall be registered until April 1 of the immediately following~~
22 ~~odd-numbered year upon payment of a registration fee as set forth~~
23 ~~in the rules or regulations. After the issuance of a certificate~~
24 ~~of registration, a biennial fee of not less than five nor more~~
25 ~~than one hundred fifty dollars, as the examining board shall~~

1 direct, shall be due and payable on or before January 1 of each
2 odd-numbered year. Failure to remit biennial fees when due shall
3 automatically cancel the registration effective the immediately
4 following April 1, but otherwise the registration shall remain
5 in full force and effect continuously from the date of issuance,
6 unless suspended or revoked by the examining board for just cause.
7 A registration which has been canceled for failure to pay the
8 biennial fee when due may be reinstated within one year, but
9 the biennial fee shall be increased ten percent for each month
10 or fraction of a month that payment is delayed. Nothing in this
11 section shall prevent the examining board from suspending or
12 revoking any registration for just cause.
