1 Section 1. Section 49-1458, Revised Statutes Cumulative

- 2 Supplement, 2006, is amended to read:
- 3 49-1458 (1) A committee which receives a late
- 4 contribution shall report the contribution to the commission by
- 5 filing a report within two days after the date of its receipt.
- 6 The report may be filed by hand delivery, facsimile transmission,
- 7 telegraph, express delivery service, or any other written means
- 8 of communication, including electronic means approved by the
- 9 commission, and need not contain an original signature.
- 10 (2) The report shall include the full name, street
- 11 address, occupation, employer, and principal place of business of
- 12 the contributor, the amount of the contribution, and the date of
- 13 receipt.
- 14 (3) A late contribution shall be reported on subsequent
- 15 campaign statements without regard to reports filed pursuant to
- 16 this section.
- 17 (4) Any committee which fails to file a report of late
- 18 contributions with the commission as required by this section
- 19 shall pay to the commission a late filing fee of one hundred
- 20 dollars for each day of the first ten days the report remains
- 21 not filed in violation of this section. After the tenth day, such
- 22 committee shall pay, for each day the report remains not filed,
- 23 an additional late filing fee of one percent of the amount of the
- 24 late contribution which was required to be reported, not to exceed
- 25 three thousand dollars or ten percent of the amount of the late

1 contribution which was required to be reported. 7 whichever is

- 3 (5) For purposes of this section, late contribution means
- 4 a contribution of one thousand dollars or more received after the
- 5 closing date for campaign statements as provided in subdivision
- 6 (1)(b) of section 49-1459.
- 7 Sec. 2. Section 49-1478.01, Reissue Revised Statutes of
- 8 Nebraska, is amended to read:
- 9 49-1478.01 (1) An independent committee, including a
- 10 separate segregated political fund, which makes a late independent
- 11 expenditure shall report the expenditure to the commission by
- 12 filing within two days after the date of the expenditure the
- 13 committee's full name and street address, the amount of the
- 14 expenditure, and the date of the expenditure. The report shall
- 15 include (a) the full name and street address of the recipient of
- 16 the expenditure, (b) the name and office sought of the candidate
- 17 whose nomination or election is supported or opposed by the
- 18 expenditure, and (c) the identification of the ballot question, the
- 19 qualification, passage, or defeat of which is supported or opposed.
- 20 Filing of a report of a late independent expenditure may be by any
- 21 written means of communication, including electronic means approved
- 22 by the commission, and need not contain an original signature.
- 23 A late independent expenditure shall be reported on subsequent
- 24 campaign statements without regard to reports filed pursuant to
- 25 this section.

1 (2) A committee which fails to file a report of a late

- 2 independent expenditure with the commission as required by this
- 3 section shall pay to the commission a late filing fee of one
- 4 hundred dollars for each day of the first ten days the report
- 5 remains not filed in violation of this section. After the tenth
- 6 day, such committee shall pay, for each day the report remains
- 7 not filed, an additional late filing fee of one percent of the
- 8 amount of the late independent expenditure which was required to be
- 9 reported, not to exceed three thousand dollars or ten percent of
- 10 the amount of the late independent expenditure which was required
- 11 to be reported. 7 whichever is greater.
- 12 (3) For purposes of this section, late independent
- 13 expenditure means an independent expenditure as defined in section
- 14 49-1428 of one thousand dollars or more made after the closing
- 15 date for campaign statements as provided in subdivision (1)(b) of
- 16 section 49-1459.
- 17 Sec. 3. Section 49-1479.02, Revised Statutes Cumulative
- 18 Supplement, 2006, is amended to read:
- 19 49-1479.02 (1) A major out-of-state contributor shall
- 20 file with the commission an out-of-state contribution report.
- 21 An out-of-state contribution report shall be filed on a form
- 22 prescribed by the commission within ten days after the end of
- 23 the calendar month in which a person becomes a major out-of-state
- 24 contributor. For the remainder of the calendar year, a major
- 25 out-of-state contributor shall file an out-of-state contribution

1 report with the commission within ten days after the end of each

- 2 calendar month in which the contributor makes a contribution or
- 3 expenditure.
- 4 (2) An out-of-state contribution report shall disclose as
- 5 to each contribution or expenditure not previously reported (a) the
- 6 amount, nature, value, and date of the contribution or expenditure,
- 7 (b) the name and address of the committee, candidate, or person
- 8 who received the contribution or expenditure, (c) the name and
- 9 address of the person filing the report, and (d) the name, address,
- 10 occupation, and employer of each person making a contribution of
- 11 more than two hundred dollars in the calendar year to the person
- 12 filing the report.
- 13 (3) This section shall not apply to (a) a person who
- 14 files a report of a contribution or an expenditure pursuant to
- 15 subsection (2) of section 49-1469, (b) a person required to file
- 16 a report or campaign statement pursuant to section 49-1469.07,
- 17 (c) a committee having a statement of organization on file with
- 18 the commission, or (d) a person or committee registered with the
- 19 Federal Election Commission.
- 20 (4) Any person who fails to file an out-of-state
- 21 contribution report with the commission as required by this section
- 22 shall pay to the commission a late filing fee of one hundred
- 23 dollars for each day of the first ten days the report remains
- 24 not filed in violation of this section. After the tenth day, such
- 25 person shall pay, for each day the report remains not filed, an

1 additional late filing fee of one percent of the amount of the

- 2 contributions or expenditures which were required to be reported,
- 3 not to exceed three thousand dollars or ten percent of the amount
- 4 of the contributions or expenditures which were required to be
- 5 reported. 7 whichever is greater.
- 6 Sec. 4. Section 49-1483.03, Reissue Revised Statutes of
- 7 Nebraska, is amended to read:
- 8 49-1483.03 (1) Any lobbyist or principal who receives
- 9 or expends more than five thousand dollars for lobbying purposes
- 10 during any calendar month in which the Legislature is in session
- 11 shall, within fifteen days after the end of such calendar month,
- 12 file a special report disclosing for that calendar month all
- 13 information required by section 49-1483. All information disclosed
- 14 in a special report shall also be disclosed in the next quarterly
- 15 report required to be filed. The requirement to file a special
- 16 report shall not apply to a receipt or expenditure for lobbyist
- 17 fees for lobbying services which have otherwise been disclosed in
- 18 the lobbyist's application for registration.
- 19 (2) Any lobbyist who fails to file a special report
- 20 required by this section with the Clerk of the Legislature or the
- 21 commission shall pay to the commission a late filing fee of one
- 22 hundred dollars for each day of the first ten days the statement
- 23 report remains not filed in violation of this section. After the
- 24 tenth day, such lobbyist shall pay, for each day the report remains
- 25 not filed, an additional late filing fee of one percent of the

1 amount of the receipts and expenditures which were required to be

- 2 reported, not to exceed three thousand dollars or ten percent of
- 3 the amount of the receipts and expenditures which were required to
- 4 <u>be</u>reported. 7 whichever is greater.
