FOR AN ACT relating to personal property; to amend section
69-1305.03, Revised Statutes Cumulative Supplement, 2006;
to eliminate provisions relating to gift cards and gift
certificates as prescribed; and to repeal the original
section.

Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 69-1305.03, Revised Statutes

- 2 Cumulative Supplement, 2006, is amended to read:
- 3 69-1305.03 (a) A gift certificate or gift card which has
- 4 a face value of less than one hundred dollars and is not assessed
- 5 any fees and does not have an expiration date shall not be presumed
- 6 to be abandoned.
- 7 (b) A gift certificate or gift card which has a face
- 8 value of one hundred dollars or more which is unredeemed for a
- 9 period of three years from the date of issuance shall be presumed
- 10 abandoned.
- 11 (c) (b) A gift certificate or gift card which contains an
- 12 expiration date or requires any type of post-sale finance charge or
- 13 fee which is unredeemed for a period of three years from the date
- 14 of issuance shall be presumed abandoned.
- 15 (d) (c) A gift certificate or gift card issued prior
- 16 to November 2, 2006, with a face value of less than one hundred
- 17 dollars and which contains an expiration date or requires any type
- 18 of post-sale finance charge or fee and has not been redeemed shall
- 19 not be presumed abandoned if the issuer's policy and practice as
- 20 of July 1, 2006, is to waive all post-sale charges or fees and
- 21 to honor such gift certificate or gift card, at no additional
- 22 cost to the holder whenever presented at full face value or the
- 23 value remaining after any applicable purchases, expiration date
- 24 notwithstanding. A written notice of such policy and practice shall
- 25 be posted conspicuously by July 1, 2006, in not smaller than

1 ten-point type, at each site in all Nebraska locations at which the

- 2 issuer distributes or redeems a gift certificate or gift card.
- 3 (e) (d) In the case of a gift certificate or gift card,
- 4 the amount presumed abandoned is the face amount of the certificate
- 5 or card itself, less the total amount of any applicable purchases
- 6 and fees.
- 7 (f) (e) A gift certificate or gift card subject to a
- 8 fee shall contain a statement clearly and conspicuously printed on
- 9 it stating whether there is a fee, the amount of the fee, how
- 10 often the fee will occur, that the fee is triggered by inactivity
- 11 of the gift certificate or gift card, and when the fee will be
- 12 assessed. The statement may appear on the front or back of the gift
- 13 certificate or gift card in a location where it is visible to a
- 14 purchaser prior to the purchase.
- 15 (g) (f) A gift certificate or gift card subject to an
- 16 expiration date shall contain a statement clearly and conspicuously
- 17 printed on the gift certificate or gift card stating the expiration
- 18 date. The statement may appear on the front or back of the gift
- 19 certificate or gift card in a location where it is visible to a
- 20 purchaser prior to the purchase.
- 21 (h) (g) This section does not apply to a general-use
- 22 prepaid card.
