Section 1. Section 81-1108.32, Revised Statutes
Cumulative Supplement, 2006, is amended to read:

3 81-1108.32 The Nebraska Capitol Commission is hereby created. The commission shall consist of the Governor, the Speaker 4 5 of the Legislature, the State Court Administrator, the dean of the College of Architecture at the University of Nebraska-Lincoln, the 6 7 Director of the Nebraska State Historical Society, and three other 8 residents of Nebraska appointed by the Governor. One appointive 9 member shall be appointed from each congressional district. The 10 terms of the appointive members shall be staggered so that one term 11 expires on March 1, 1994, one term expires on March 1, 1995, and 12 one term expires on March 1, 1996. As the terms of the appointive 13 members expire, the Governor shall, on or before March 1 of each 14 year, appoint or reappoint a member of the commission for a term 15 of three years to succeed the member whose term expires. Any member 16 appointed after March 1 shall serve for the remaining portion of 17 the three-year term.

18 The Governor shall serve as the chairperson of the 19 Nebraska Capitol Commission, the Speaker of the Legislature shall 20 serve as the vice-chairperson of the commission, and the State 21 Capitol Administrator or his or her representative shall serve as 22 the nonvoting secretary of the commission.

23 <u>In the absence of the Governor, he or she may designate</u> 24 <u>the Lieutenant Governor as his or her representative. In the</u> 25 absence of the Speaker of the Legislature, he or she may designate

the chairperson of the Executive Board of the Legislative Council 1 2 or the Clerk of the Legislature as his or her representative. 3 Representatives of the Governor and the Speaker of the Legislature shall have full voting privileges for the meeting in attendance. 4 5 The members of such commission shall be reimbursed for their actual and necessary expenses while away from home engaged 6 7 in the performance of their duties as members of the commission as 8 provided in sections 81-1174 to 81-1177.
