A BILL

1	FOR AN ACT relating to claims against the state; to appropriate

5	Be it enacted by the people of the State of Nebraska,

1	Section 1. There is hereby appropriated the following

16	authorized and directed to draw his or her warrants on or before
17	June 30, 2007, upon the funds in the state treasury enumerated
18	in this act, in favor of the several beneficiaries named in
19	this act for the amount set opposite their respective names upon
20	the presentation of proper vouchers therefor. The several amounts
21	appropriated in this act shall be in full payment of any and all
22	claims, rights, causes of action, damages, and demands of every
23	character and kind owing by or against the State of Nebraska, its
24	officers, agents, and employees, and their successors and assigns
25	with respect to each of the beneficiaries respectively in whose

1	favor the appropriations are made. The director shall not deliver
2	any warrant for any items appropriated in this act until a receipt
3	and release in full, releasing the State of Nebraska, its officers,
4	employees, and agents, and their successors and assigns, has been
5	filed by each of the beneficiaries respectively. Upon presentation
6	of the warrants, the State Treasurer is hereby directed to pay the
7	same out of money in the General Fund or out of money in other
8	funds indicated in this act not otherwise appropriated.
