A BILL

1 FOR AN ACT relating to appropriations; to appropriate funds to aid
2 in carrying out the provisions of Legislative Bill 928,
3 One Hundredth Legislature, Second Session, 2008; and to
4 reduce certain appropriations.
5 Be it enacted by the people of the State of Nebraska,

1 Section 1. There is hereby appropriated (1) \$56,101 from
 2 the Health and Human Services Cash Fund for FY2008-09 and (2)
 3 \$97,949 from the Health and Human Services Cash Fund for FY2009-10
 4 to the Department of Health and Human Services, for Program 33, to
 5 aid in carrying out the provisions of Legislative Bill 928, One
 6 Hundredth Legislature, Second Session, 2008.

7 Sec. 2. There is hereby appropriated (1) \$25,000 from the
 8 General Fund for FY2008-09 and (2) \$9,000 from the General Fund for
 9 FY2009-10 to the University of Nebraska, for Program 781, to aid in
 10 carrying out the provisions of Legislative Bill 928, One Hundredth
 11 Legislature, Second Session, 2008.

12 Sec. 3. There is hereby appropriated \$10,000 from the
 13 Nebraska Health Care Cash Fund for FY2008-09 to the Department of
 14 Health and Human Services, for Program 33, to aid in carrying out
 15 the provisions of Legislative Bill 928, One Hundredth Legislature,
 16 Second Session, 2008.

17 No expenditures for permanent and temporary salaries and
 18 per diems for state employees shall be made from funds appropriated
 19 in this section.

20 Sec. 4. The General Fund appropriation for FY2009-10 to
 21 the Department of Health and Human Services, for Program 33, is
 22 hereby reduced by \$42,000.

23 Sec. 5. (1) The General Fund appropriation for FY2008-09
 24 to the Department of Health and Human Services, for Program 348,
 25 is hereby reduced by \$144,402. The federal fund appropriation for

1 FY2008-09 to the Department of Health and Human Services, for
2 Program 348, is hereby reduced by \$216,603.

3 (2) The General Fund appropriation for FY2009-10 to the
4 Department of Health and Human Services, for Program 348, is hereby
5 reduced by \$204,570. The federal fund appropriation for FY2009-10
6 to the Department of Health and Human Services, for Program 348, is
7 hereby reduced by \$306,854.

8 The reductions made pursuant to this section are to
9 aid in carrying out the provisions of Legislative Bill 928, One
10 Hundredth Legislature, Second Session, 2008.
