A BILL

- FOR AN ACT relating to change of name; to amend sections 25-21,271,

 28-718, and 29-4004, Revised Statutes Cumulative

 Supplement, 2006; to provide name change court orders to

 update the child abuse central register and the central

 registry of sex offenders; and to repeal the original

 sections.
- Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 25-21,271, Revised Statutes Cumulative

- 2 Supplement, 2006, is amended to read:
- 3 25-21,271 (1) Any person desiring to change his or her
- 4 name may file a petition in the district court of the county in
- 5 which such person may be a resident, setting forth (a) that the
- 6 petitioner has been a bona fide citizen of such county for at least
- 7 one year prior to the filing of the petition, (b) the cause for
- 8 which the change of petitioner's name is sought, and (c) the name
- 9 asked for.

10 (2) Notice of the filing of the petition shall be 11 published in a newspaper in the county, and if no newspaper is 12 printed in the county, then in a newspaper of general circulation 13 therein. The notice shall be published (a) once a week for four 14 consecutive weeks if the petitioner is nineteen years of age 15 or older at the time the action is filed and (b) once a week 16 for two consecutive weeks if the petitioner is under nineteen years of age at the time the action is filed. In an action 17 18 involving a petitioner under nineteen years of age who has a 19 noncustodial parent, notice of the filing of the petition shall be 20 sent by certified mail within five days after publication to the 21 noncustodial parent at the address provided to the clerk of the 22 district court pursuant to subsection (1) of section 42-364.13 for 23 the noncustodial parent if he or she has provided an address. The 24 clerk of the district court shall provide the petitioner with the

1 (3) It shall be the duty of the district court, upon

- 2 being duly satisfied by proof in open court of the truth of the
- 3 allegations set forth in the petition, that there exists proper
- 4 and reasonable cause for changing the name of the petitioner,
- 5 and that notice of the filing of the petition has been given as
- 6 required by this section, to order and direct a change of name of
- 7 such petitioner and that an order for the purpose be made in the
- 8 journals of the court.
- 9 (4) The clerk of the district court shall deliver a copy
- 10 of any name-change order issued by the court pursuant to this
- 11 <u>section to the Department of Health and Human Services for use</u>
- 12 pursuant to section 28-718 and to the sex offender registration and
- 13 notification division of the Nebraska State Patrol for use pursuant
- 14 to section 29-4004.

- 16 Supplement, 2006, is amended to read:
- 17 28-718 (1) There shall be a central register of child
- 18 protection cases maintained in the department containing records
- 19 of all reports of child abuse or neglect opened for investigation
- 20 as provided in section 28-713 and classified as either court
- 21 substantiated or inconclusive as provided in section 28-720.
- 22 (2) The department shall determine whether a name-change
- 23 order received from the clerk of a district court pursuant to
- 24 section 25-21,271 is for a person on the central register of child
- 25 protection cases and, if so, shall include the changed name with

1 the former name in the register and file or cross-reference the

- 2 information under both names.

- 5 29-4004 (1) Any person subject to the Sex Offender
- 6 Registration Act shall register with the sheriff of the county in
- 7 which the person resides or is temporarily domiciled within five
- 8 working days of becoming subject to the act.
- 9 (2) Any person required to register under the act shall
- 10 inform the sheriff of the county in which he or she resides,
- 11 in writing, if he or she has a new address within such county
- 12 within five working days after the address change. The sheriff
- 13 shall forward such information to the sex offender registration and
- 14 community notification division of the Nebraska State Patrol within
- 15 five working days after receipt of the new address.
- 16 (3) Any person required to register under the act shall
- 17 inform the sheriff of the county in which he or she resides, in
- 18 writing, if he or she has a new address in a different county
- 19 in this state within five working days after the address change.
- 20 The sheriff shall forward the new address to the sex offender
- 21 registration and community notification division of the Nebraska
- 22 State Patrol within five working days after receipt of the new
- 23 address. The division shall notify the sheriff of the county to
- 24 which the person is relocating of the new address. The person shall
- 25 report to the county sheriff of his or her new county of residence

1 and register with such county sheriff within five working days

- 2 after the address change.
- 3 (4) Any person required to register under the act shall
- 4 inform the sheriff of the county in which he or she resides,
- 5 in writing, if he or she moves to a new out-of-state address
- 6 within five working days after the address change. The sheriff
- 7 shall forward the new out-of-state address to the sex offender
- 8 registration and notification division of the Nebraska State Patrol
- 9 within five working days after receipt of the new out-of-state
- 10 address. The division shall forward the new out-of-state address to
- 11 the other state's central repository for sex offender registration.
- 12 (5) Any person required to register under the act who
- 13 is residing in another state or is temporarily domiciled in
- 14 another state, and is employed, carries on a vocation, or attends
- 15 school in this state shall report and register with the sheriff
- 16 of the county in which he or she is employed, carries on a
- 17 vocation, or attends school in this state within five working
- 18 days after becoming employed, carrying on a vocation, or attending
- 19 school. The person shall also notify the sheriff of any changes in
- 20 employment, vocation, or school of attendance, in writing, within
- 21 five working days after the change. The sheriff shall forward
- 22 this information to the sex offender registration and community
- 23 notification division of the Nebraska State Patrol within five
- 24 working days after receipt of such information. For purposes of
- 25 this subsection:

1 (a) Attends school means enrollment in any educational

- 2 institution in this state on a full-time or part-time basis;
- 3 (b) Is employed or carries on a vocation means any
- 4 full-time or part-time employment, with or without compensation,
- 5 which lasts for a duration of more than fourteen days or for an
- 6 aggregate period exceeding thirty days in a calendar year; and
- 7 (c) Temporarily domiciled means a place at which the
- 8 person actually lives or stays on a temporary basis even though
- 9 he or she may plan to return to his or her permanent address
- 10 or to another temporary address. For purposes of this section, a
- 11 temporary domicile means any place at which the person actually
- 12 lives or stays for a period of at least five working days.
- 13 (6) Any person incarcerated for a registrable offense
- 14 under section 29-4003 in a jail, penal or correctional facility, or
- 15 other public or private institution who is not already registered
- 16 shall be registered by the jail, penal or correctional facility,
- 17 or public or private institution prior to his or her discharge,
- 18 parole, furlough, work release, or release. The person shall be
- 19 informed and information shall be obtained as required in section
- 20 29-4006.
- 21 (7) Any person required to register under the act shall
- 22 inform the sheriff of the county in which he or she resides, in
- 23 writing, of each postsecondary educational institution at which
- 24 he or she is employed, carries on a vocation, or attends school,
- 25 within five working days after such employment or attendance.

1 The person shall also notify the sheriff of any change in such

- 2 employment or attendance status at the postsecondary educational
- 3 institution, in writing, within five working days after such
- 4 change. The sheriff shall forward the information regarding such
- 5 employment or attendance to the sex offender registration and
- 6 community notification division of the Nebraska State Patrol within
- 7 five working days after receipt of the information.
- 8 (8) Any person required to register or who is registered
- 9 under the act, but is incarcerated for more than five days, whether
- 10 or not in his or her own county of residence or temporary domicile,
- 11 shall inform the sheriff of the county in which such person would
- 12 reside or would be temporarily domiciled if he or she was not
- 13 incarcerated, within five working days after incarceration, of his
- 14 or her incarceration and his or her expected release date, if any
- 15 such date is available. The sheriff shall forward the information
- 16 regarding incarceration to the sex offender registration and
- 17 community notification division of the Nebraska State Patrol within
- 18 five working days after receipt of the information.
- 19 (9) Any person required to register or who is registered
- 20 under the act who no longer has a residence or temporary domicile
- 21 shall notify the county sheriff of the county in which he or she
- 22 is located, in writing, within five working days after such change
- 23 in residence or temporary domicile. Such person shall update his
- 24 or her registration, in writing, on a form approved by the sex
- 25 offender registration and community notification division of the

1 Nebraska State Patrol at least once every thirty calendar days

- 2 during the time he or she remains without residence or temporary
- 3 domicile.
- 4 (10) Each registering entity shall forward all written
- 5 information, photographs, and fingerprints obtained pursuant to the
- 6 act to the sex offender registration and community notification
- 7 division of the Nebraska State Patrol within five working days. The
- 8 information shall be forwarded on forms furnished by the division.
- 9 The division shall maintain a central registry of sex offenders
- 10 required to register under the act.
- 11 (11) The sex offender registration and community
- 12 <u>notification division of the Nebraska State Patrol shall determine</u>
- 13 whether a name-change order received from the clerk of a district
- 14 court pursuant to section 25-21,271 is for a person in the central
- 15 registry of sex offenders and, if so, shall include the changed
- 16 name with the former name in the registry, file or cross-reference
- 17 the information under both names, and notify the sheriff of the
- 18 county in which such person then resides.
