 81-1108.17, Revised Statutes Cumulative Supplement, 2006;

 to authorize leases of state property as prescribed; and

 to repeal the original section.

Section 1. Section 81-1108.17, Revised Statutes

- 2 Cumulative Supplement, 2006, is amended to read:
- 3 81-1108.17 (1) The Department of Administrative Services
- 4 shall be the custodian of the state laboratory and laboratory
- 5 grounds, the Governor's Mansion and grounds, and all other
- 6 buildings and lands owned or leased by the State of Nebraska except
- 7 as exempted under subsections (5) and (6) of section 81-1108.15
- 8 or as provided in the Nebraska State Capitol Preservation and
- 9 Restoration Act.
- 10 (2) To aid in the performance of his or her duties, the
- 11 Director of Administrative Services shall appoint an administrator.
- 12 The administrator, under the direction of the director, shall have
- 13 complete control and all powers necessary to properly maintain the
- 14 state laboratory and laboratory grounds, the Governor's Mansion and
- 15 grounds, and all other buildings and lands owned or leased by the
- 16 State of Nebraska except as exempted under subsections (5) and (6)
- 17 of section 81-1108.15 or as provided in the Nebraska State Capitol
- 18 Preservation and Restoration Act.
- 19 (3) Except as provided in the act, the administrator,
- 20 under the direction of the director, is authorized to (a) lease
- 21 space or provide facilities for the parking of state officers'
- 22 and employees' vehicles as well as state-owned vehicles, and (b)
- 23 lease, rent, or permit for use as apartments, dwellings, offices,
- 24 and parking areas any or all of the property acquired for parking
- 25 or for future building needs, and (c) lease state property to the

federal government or political subdivisions of the state using the 1 2 system of charges in subsection (4) of this section. All leases 3 shall contain the provision that upon notice that such property is needed for public use, the use or occupancy of the property 4 5 shall cease. All money received as rent from any property acquired shall be remitted to the State Treasurer and credited to the State 6 Building Revolving Fund, except that receipts from parking charges 7 8 for employee, public, and state vehicle parking shall be credited 9 to the Capitol Buildings Parking Revolving Fund, which fund is 10 hereby created, for the purposes of providing and maintaining 11 parking for state employees and visitors. 12 (4) The system of charges for state buildings and facilities shall include an amount sufficient to (a) accurately reflect operating costs, including routine maintenance and repair

13 14 15 costs, and (b) fund building renewal projects under the Deferred 16 Building Renewal Act and renovation, remodeling, and repair 17 projects beyond the scope of the act. The proceeds received 18 under subdivision (a) of this subsection shall be remitted to the State Treasurer for credit to the State Building Revolving Fund. 19 20 The proceeds received under subdivision (b) of this subsection 21 shall be remitted to the State Treasurer for credit to the State 22 Building Renewal Assessment Fund. The administrator shall develop a system of equitable billings and charges for parking facilities 23 24 under his or her control and used by state employees and state 25 vehicles. The system of charges shall include an amount sufficient

1 to cover the operating, maintenance, and repair costs associated

- 2 with the parking facilities. The administrator, under policies and
- 3 procedures established by the Director of Administrative Services,
- 4 may expend funds from time to time credited to the Capitol
- 5 Buildings Parking Revolving Fund for the purposes of obtaining,
- 6 operating, and maintaining parking facilities for employees and
- 7 visitors. All money derived from any source other than that to
- 8 be credited to the State Building Revolving Fund, the Capitol
- 9 Buildings Parking Revolving Fund, the Department of Administrative
- 10 Services Cash Fund, the State Building Renewal Assessment Fund, or
- 11 other appropriate revolving fund shall be remitted to the State
- 12 Treasurer and credited to the General Fund.
- 13 (5) The administrator shall see that all parts and
- 14 apartments of the buildings leased are properly ventilated and kept
- 15 clean and in order.
- 16 (6) The administrator shall at all times have charge
- 17 of and supervision over the police, janitors, and other employees
- 18 in and about the state laboratory and laboratory grounds, the
- 19 Governor's Mansion and grounds, and all other buildings and lands
- 20 owned or leased by the State of Nebraska except as exempted under
- 21 subsections (5) and (6) of section 81-1108.15 or as provided in
- 22 the Nebraska State Capitol Preservation and Restoration Act. The
- 23 administrator shall institute, in the name of the state and with
- 24 the advice of the Attorney General, civil and criminal proceedings
- 25 against any person for injury or threatened injury to any public

1 property in the state laboratory and laboratory grounds, the

- 2 Governor's Mansion and grounds, and all other buildings and lands
- 3 owned or leased by the State of Nebraska under his or her control,
- 4 or for committing or threatening to commit a nuisance in or on the
- 5 buildings or lands.
- 6 (7) The administrator shall keep in his or her office
- 7 a complete record containing all plans and surveys of the state
- 8 laboratory and grounds, the Governor's Mansion and grounds, and all
- 9 other buildings and lands owned or leased by the State of Nebraska
- 10 and of underground construction under such buildings and lands.
- 11 This subsection shall not apply to the State Capitol and capitol
- 12 grounds.
