A BILL

1 FOR AN ACT relating to the Nebraska Rules of the Road; to
2 amend section 60-682.01, Revised Statutes Cumulative
3 Supplement, 2008; to change provisions relating to fines
4 for speeding in a construction zone; to repeal the
5 original section; and to declare an emergency.
6 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-682.01, Revised Statutes Cumulative
2 Supplement, 2008, is amended to read:

3 60-682.01 (1) Any person who operates a vehicle in
4 violation of any maximum speed limit established for any highway or
5 freeway is guilty of a traffic infraction and upon conviction shall
6 be fined:

7 (a) Ten dollars for traveling one to five miles per hour
8 over the authorized speed limit;

9 (b) Twenty-five dollars for traveling over five miles per
10 hour but not over ten miles per hour over the authorized speed
11 limit;

12 (c) Seventy-five dollars for traveling over ten miles per
13 hour but not over fifteen miles per hour over the authorized speed
14 limit;

15 (d) One hundred twenty-five dollars for traveling over
16 fifteen miles per hour but not over twenty miles per hour over the
17 authorized speed limit;

18 (e) Two hundred dollars for traveling over twenty miles
19 per hour but not over thirty-five miles per hour over the
20 authorized speed limit; and

21 (f) Three hundred dollars for traveling over thirty-five
22 miles per hour over the authorized speed limit.

23 (2) The fines prescribed in subsection (1) of this
24 section shall be doubled if the violation occurs within a
25 maintenance, repair, or construction zone established pursuant

1 to section 60-6,188. For purposes of this subsection, maintenance,
2 repair, or construction zone means ~~(a)~~ (a)(i) the portion of
3 a highway identified by posted or moving signs as being under
4 maintenance, repair, or construction or ~~(b)~~ (ii) the portion of
5 a highway identified by maintenance, repair, or construction zone
6 speed limit signs displayed pursuant to section 60-6,188 and (b)
7 within such portion of a highway where road construction workers
8 are present. The maintenance, repair, or construction zone starts
9 at the location of the first sign identifying the maintenance,
10 repair, or construction zone and continues until a posted or moving
11 sign indicates that the maintenance, repair, or construction zone
12 has ended.

13 (3) The fines prescribed in subsection (1) of this
14 section shall be doubled if the violation occurs within a school
15 crossing zone as defined in section 60-658.01.

16 Sec. 2. Original section 60-682.01, Revised Statutes
17 Cumulative Supplement, 2008, is repealed.

18 Sec. 3. Since an emergency exists, this act takes effect
19 when passed and approved according to law.
