#### A BILL

- FOR AN ACT relating to the Department of Administrative Services;

  to amend section 81-1174, Reissue Revised Statutes of
- Nebraska; to change provisions relating to expense
- 4 reimbursement; to repeal the original section; and to
- 5 declare an emergency.
- 6 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 81-1174, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 81-1174 Whenever any state officer, state employee, or
- 4 member of any commission, council, committee, or board of the
- 5 state is entitled to be reimbursed seeking reimbursement for actual
- 6 expenses incurred by him or her in the line of duty, he or she
- 7 shall be required to present a request for payment or reimbursement
- 8 each month to the Director of Administrative Services not later
- 9 than sixty days after the final day on which expenses were incurred
- 10 for which reimbursement is sought. Each request shall be fully
- 11 itemized, including when, where, and why the expense was incurred
- 12 and the actual amount involved. the amount, date, place, and
- 13 <u>essential character of the expense incurred.</u>
- 14 When reimbursement is requested for mileage by
- 15 automobile, air travel by commercial carrier, air travel in
- 16 airplanes chartered by the department or agency, or air travel by
- 17 personally rented airplane, the points between which such travel
- 18 occurred, the times of arrival and departure, and the necessity and
- 19 purpose of such travel shall be shown stated on such request. When
- 20 reimbursement is requested for mileage by automobile, the motor
- 21 vehicle license plate number, the owner of the automobile used,
- 22 total miles traveled, and the rate per mile being requested shall
- 23 also be shown on each request.
- 24 The Accounting Administrator may require less supporting
- 25 detail for requests covered in this section but shall not

1 impose reporting requirements which exceed those listed unless

- 2 specifically authorized by other provisions of law. No request
- 3 shall be submitted by an individual for an expense when such
- 4 expense has been paid by the agency or department concerned.
- 5 When reimbursement for expenses incurred in air travel
- 6 by privately owned airplane is requested, the cost of operating
- 7 the airplane at rates per mile as established by the Department
- 8 of Administrative Services shall be shown on such request. Travel
- 9 by privately owned airplane or personally rented airplane shall
- 10 only be authorized when it is more economical than surface
- 11 transportation or will result in a substantial savings of expense
- 12 or productive time.
- 13 The statement of expenses shall be duly verified and
- 14 supported by receipts for all of such expenditures, except
- 15 meals and immaterial items identified by the director, for which
- 16 reimbursement is requested.
- 17 No charge for mileage shall be allowed when such mileage
- 18 accrues while using an automobile owned by the State of Nebraska.
- 19 No personal maintenance expenses shall be allowed to
- 20 any state officer, state employee, or member of any commission,
- 21 council, committee, or board of the state when such expenses are
- 22 incurred in the city or town in which the residence or primary work
- 23 location of such individual is located, except that individuals
- 24 required to attend official functions, conferences, or hearings
- 25 within such location, not to include normal day-to-day operations

1 of the department, agency, commission, council, committee, or

- 2 board, may be paid or reimbursed in accordance with policies
- 3 established by the Director of Administrative Services. The
- 4 approval to attend a function, conference, or hearing shall be
- 5 obtained from the director of the department, agency, commission,
- 6 council, committee, or board prior to an individual's attendance at
- 7 such function, conference, or hearing.
- 8 Nothing in this section shall be construed to prohibit
- 9 the furnishing of coffee, tea, and any similar beverage by the
- 10 Legislature or the Legislative Council to its employees or guests.
- 11 Sec. 2. Original section 81-1174, Reissue Revised
- 12 Statutes of Nebraska, is repealed.
- Sec. 3. Since an emergency exists, this act takes effect
- 14 when passed and approved according to law.
