**LEGISLATIVE BILL 219A**

A BILL

1 FOR AN ACT relating to appropriations; to appropriate funds to aid  
2 in carrying out the provisions of Legislative Bill 219,  
3 One Hundred First Legislature, First Session, 2009; to  
4 reduce an appropriation; to provide an operative date;  
5 and to declare an emergency.  
6 Be it enacted by the people of the State of Nebraska,

1           Section 1. There is hereby appropriated (1) \$150,734 from  
2 the Roads Operations Cash Fund and \$2,648,418 from federal funds  
3 for FY2009-10 and (2) \$150,734 from the Roads Operations Cash Fund  
4 and \$2,648,418 from federal funds for FY2010-11 to the Department  
5 of Roads, for Program 568, to aid in carrying out the provisions of  
6 Legislative Bill 219, One Hundred First Legislature, First Session,  
7 2009.

8           Total expenditures for permanent and temporary salaries  
9 and per diems from funds appropriated in this section shall not  
10 exceed \$392,540 for FY2009-10 or \$392,540 for FY2010-11.

11           There is included in the appropriation to this program  
12 for FY2009-10 \$1,907,898 federal funds estimate for state aid,  
13 which shall only be used for such purpose. There is included in  
14 the appropriation to this program for FY2010-11 \$1,907,898 federal  
15 funds estimate for state aid, which shall only be used for such  
16 purpose.

17           Sec. 2. The appropriation for FY2009-10 to the Department  
18 of Motor Vehicles, for Program 644 - Highway Safety, shall be  
19 reduced by \$150,734 cash funds and \$2,648,418 federal funds  
20 estimate. The appropriation for FY2010-11 to the Department of  
21 Motor Vehicles, for Program 644 - Highway Safety, shall be reduced  
22 by \$150,734 cash funds and \$2,648,418 federal funds estimate.

23           The limitation on total expenditures for permanent and  
24 temporary salaries and per diems for FY2009-10 for the Department  
25 of Motor Vehicles, for Program 644 - Highway Safety, is hereby

1 reduced by \$392,540. The limitation on total expenditures for  
2 permanent and temporary salaries and per diems for FY2010-11 for  
3 the Department of Motor Vehicles, for Program 644 - Highway Safety,  
4 is hereby reduced by \$392,540.

5 The federal funds estimate provided as state aid for  
6 FY2009-10 to the Department of Motor Vehicles, for Program 644 -  
7 Highway Safety, shall be reduced by \$1,907,898. The federal funds  
8 estimate provided as state aid for FY2010-11 to the Department of  
9 Motor Vehicles, for Program 644 - Highway Safety, shall be reduced  
10 by \$1,907,898.

11 The reductions made by this section are made to aid in  
12 carrying out the provisions of Legislative Bill 219, One Hundred  
13 First Legislature, First Session, 2009.

14 Sec. 3. This act becomes operative on July 1, 2009.

15 Sec. 4. Since an emergency exists, this act takes effect  
16 when passed and approved according to law.
