Any Nebraska Workers' Compensation Court 2 document or information available by electronic means which reveals 3 the identity of an employee, the nature of an employee's alleged injury, an employee's past or present medical condition, the extent 5 of an employee's disability, the amount, type, or duration of 6 benefits paid to an employee, or the application information for 7 self-insurance is confidential and not open to public inspection or copying, except as otherwise provided in this section. The compensation court shall deny any request to inspect or copy a 9 10 record that is confidential under this section unless: 11 (1) The requester is the employee who is the subject of 12 the record or an attorney or authorized agent of such employee. 13 An attorney or authorized agent of the employee shall provide a 14 written authorization from the employee for such inspection or 15 copying; 16 (2) The requester is the employer, insurance carrier, 17 or third-party administrator that is a party to the record or an 18 attorney or authorized agent of such employer, insurance carrier, 19 or third-party administrator.
