- FOR AN ACT relating to the Nebraska Liquor Control Act; to amend section 53-186, Reissue Revised Statutes of Nebraska; to provide for consumption and sale of liquor on real property in the state park system; and to repeal the original section.

1 Section 1. Section 53-186, Reissue Revised Statutes of

- 3 53-186 (1) Except as provided in subsection (2) or (3)
- 4 of this section, it shall be unlawful for any person to consume
- 5 alcoholic liquor upon property owned or controlled by the state
- 6 or any governmental subdivision thereof unless authorized by the
- 7 governing bodies having jurisdiction over such property.
- 8 $\frac{(2)}{(2)}$ (2) (a) The commission may issue licenses for the sale
- 9 of alcoholic liquor at retail:
- 10 (a) on (i) On lands owned by public power districts,
- 11 public power and irrigation districts, the Bureau of Reclamation,
- 12 or the Corps of Army Engineers; or (b) for
- 13 <u>(ii) Except as otherwise provided in subsection (3) of</u>
- 14 <u>this section, for locations within or on structures on land owned</u>
- 15 by the state, cities, or villages or on lands controlled by airport
- 16 authorities.
- 17 (b) The issuance of a license under this subsection shall
- 18 be subject to the consent of the local governing body having
- 19 jurisdiction over the site for which the license is requested as
- 20 provided in the Nebraska Liquor Control Act.
