Section 1. Section 81-405, Reissue Revised Statutes of
 Nebraska, is amended to read:

LB 729

3 81-405 The Mechanical Safety Inspection Fund is created. All fees collected by the Department of Labor pursuant to the 4 5 Nebraska Amusement Ride Act and the Conveyance Safety Act shall be remitted to the State Treasurer for credit to the Mechanical 6 7 Safety Inspection Fund. Fees so collected shall not lapse into the 8 General Fund. Fees so collected shall be used for the sole purpose 9 of administering the provisions of the Nebraska Amusement Ride Act. 10 and the Conveyance Safety Act. Any money in the Mechanical Safety 11 Inspection Fund available for investment shall be invested by the 12 state investment officer pursuant to the Nebraska Capital Expansion 13 Act and the Nebraska State Funds Investment Act. All funds existing 14 in the Elevator Inspection Fund and the Nebraska Amusement Ride 15 Fund on January  $1_7$  2008, shall be transferred to the Mechanical 16 Safety Inspection Fund.
