A BILL

FOR AN ACT relating to the Cash Reserve Fund; to amend section

84-612, Revised Statutes Supplement, 2011; to delete

obsolete transfer provisions; to provide for transfers of

funds; to repeal the original section; and to declare an

emergency.

Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 84-612, Revised Statutes Supplement,

- 2 2011, is amended to read:
- 3 84-612 (1) There is hereby created within the state
- 4 treasury a fund known as the Cash Reserve Fund which shall be under
- 5 the direction of the State Treasurer. The fund shall only be used
- 6 pursuant to this section.
- 7 (2) The State Treasurer shall transfer funds from the
- 8 Cash Reserve Fund to the General Fund upon certification by the
- 9 Director of Administrative Services that the current cash balance in
- 10 the General Fund is inadequate to meet current obligations. Such
- 11 certification shall include the dollar amount to be transferred. Any
- 12 transfers made pursuant to this subsection shall be reversed upon
- 13 notification by the Director of Administrative Services that
- 14 sufficient funds are available.
- 15 (3) In addition to receiving transfers from other funds,
- 16 the Cash Reserve Fund shall receive federal funds received by the
- 17 State of Nebraska for undesignated general government purposes,
- 18 federal revenue sharing, or general fiscal relief of the state.
- 19 (4) The State Treasurer, at the direction of the budget
- 20 administrator of the budget division of the Department of
- 21 Administrative Services, shall transfer such amounts, as certified by
- 22 the Director of Administrative Services, for employee health
- 23 insurance claims and expenses, not to exceed twelve million dollars
- 24 in total from the Cash Reserve Fund to the State Employees Insurance
- 25 Fund between May 1, 2007, and June 30, 2011.

- 19 dollars in total between July 1, 2011, and November 30, 2012, from
- 20 the Cash Reserve Fund to the Ethanol Production Incentive Cash Fund,
- 21 for ethanol production incentive credits, on such dates and in such
- 22 amounts as certified by the Tax Commissioner.
- 23 (15) (8) The State Treasurer, at the direction of the
- 24 budget administrator of the budget division of the Department of
- 25 <u>Administrative Services</u>, shall transfer an amount equal to the total

- 2 from the Ethanol Production Incentive Cash Fund to the Cash Reserve
- 3 Fund in such amounts as certified by the Tax Commissioner on or
- 4 before November 30, 2012.
- 5 (9) The State Treasurer, at the direction of the budget
- 6 administrator of the budget division of the Department of
- 7 Administrative Services, shall transfer eighty million dollars from
- 8 the Cash Reserve Fund to the Nebraska Capital Construction Fund on or
- 9 <u>before August 15, 2012.</u>
- 10 (10) The State Treasurer, at the direction of the budget
- 11 administrator of the budget division of the Department of
- 12 Administrative Services, shall transfer one million dollars from the
- 13 <u>Cash Reserve Fund to the Affordable Housing Trust Fund on or before</u>
- 14 August 15, 2012.
- 15 <u>(11) The State Treasurer shall transfer ten million</u>
- 16 dollars from the Cash Reserve Fund to the General Fund on or before
- 17 June 30, 2013, on such date as directed by the budget administrator
- 18 of the budget division of the Department of Administrative Services.

- 21 Sec. 3. Since an emergency exists, this act takes effect
- 22 when passed and approved according to law.
