A BILL

1	FOR AN ACT	relating to the Motor Vehicle Registration Act; to amend
2		section 60-3,104, Reissue Revised Statutes of Nebraska,
3		and sections 60-301 and 60-3,100, Revised Statutes
4		Supplement, 2011; to provide for special interest motor
5		vehicle license plates; to provide for a fee; to provide
6		a penalty; to define special interest motor vehicle; to
7		harmonize provisions; to provide an operative date; and
8		to repeal the original sections.

9 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-301, Revised Statutes Supplement,

- 4 <u>act</u>shall be known and may be cited as the Motor Vehicle Registration
- 5 Act.
- 6 Sec. 2. Section 60-3,100, Revised Statutes Supplement,

- 8 60-3,100 (1) The department shall issue to every person
- 9 whose motor vehicle or trailer is registered fully reflectorized
- 10 license plates upon which shall be displayed (a) the registration
- 11 number consisting of letters and numerals assigned to such motor
- 12 vehicle or trailer in figures not less than two and one-half inches
- 13 nor more than three inches in height and (b) also the word Nebraska
- 14 suitably lettered so as to be attractive. Two license plates shall be
- issued for every motor vehicle, except that one plate shall be issued
- 16 for dealers, motorcycles, minitrucks, truck-tractors, trailers,
- 17 buses, and apportionable vehicles, and special interest motor
- 18 vehicles that use the special interest motor vehicle license plate
- 19 authorized by and issued under section 4 of this act. The license
- 20 plates shall be of a color designated by the director. The color of
- 21 the plates shall be changed each time the license plates are changed.
- 22 Each time the license plates are changed, the director shall secure
- 23 competitive bids for materials pursuant to sections 81-145 to 81-162.
- 24 Motorcycle, minitruck, low-speed vehicle, and trailer license plate
- 25 letters and numerals may be one-half the size of those required in

- 1 this section.
- 2 (2) When two license plates are issued, one shall be
- 3 prominently displayed at all times on the front and one on the rear
- 4 of the registered motor vehicle or trailer. When only one plate is
- 5 issued, it shall be prominently displayed on the rear of the
- 6 registered motor vehicle or trailer. When only one plate is issued
- 7 for motor vehicles registered pursuant to section 60-3,198 and truck-
- 8 tractors, it shall be prominently displayed on the front of the
- 9 apportionable vehicle.

- 2 Sec. 4. (1) The department shall either modify an
- 3 existing plate design or design license plates to identify special
- 4 interest motor vehicles, to be known as special interest motor
- 5 vehicle license plates. The department, in designing such special
- 6 interest motor vehicle license plates, shall include the words
- 7 special interest and limit the manufacturing cost of each plate to an
- 8 amount less than or equal to the amount charged for license plates
- 9 pursuant to section 60-3,102. The department shall choose the design
- 10 of the plate. The department shall make applications available for
- 11 this type of plate when it is designed.
- 12 (2) One type of special interest motor vehicle license
- 13 plate shall be alphanumeric plates. The department shall:
- 14 (a) Assign a designation up to seven characters; and
- 15 (b) Not use a county designation.
- 16 (3) One type of special interest motor vehicle license
- 17 plate shall be personalized message plates. Such plates shall be
- 18 issued subject to the same conditions specified for personalized
- 19 message license plates in section 60-3,118.
- 20 (4) A person may apply to the department for a special
- 21 interest motor vehicle license plate in lieu of regular license
- 22 plates on an application prescribed and provided by the department
- 23 for any special interest motor vehicle, except for a motor vehicle
- 24 registered under section 60-3,198, motorcycle, or trailer. The
- 25 <u>department shall make forms available for such applications through</u>

- 1 the county treasurers.
- 2 (5) The form shall contain a description of the special
- 3 interest motor vehicle owned and sought to be registered, including
- 4 the make, body type, model, serial number, and year of manufacture.
- 5 (6)(a) In addition to all other fees required to register
- 6 a motor vehicle, each application for initial issuance or renewal of
- 7 a special interest motor vehicle license plate shall be accompanied
- 8 by a special interest motor vehicle license plate fee of fifty
- 9 dollars. Twenty-five dollars of the special interest motor vehicle
- 10 license plate fee shall be remitted to the State Treasurer for credit
- 11 to the Department of Motor Vehicles Cash Fund, and twenty-five
- 12 dollars of the special interest motor vehicle license plate fee shall
- 13 be remitted to the State Treasurer for credit to the Highway Trust
- 14 Fund.
- 15 (b) If a special interest motor vehicle license plate is
- 16 lost, stolen, or mutilated, the owner shall be issued a replacement
- 17 <u>license plate pursuant to section 60-3,157.</u>
- 18 (7) When the department receives an application for a
- 19 special interest motor vehicle license plate, the department shall
- 20 deliver the plate to the county treasurer of the county in which the
- 21 special interest motor vehicle is registered. The county treasurer
- 22 shall issue the special interest motor vehicle license plate in lieu
- 23 of regular license plates when the applicant complies with the other
- 24 provisions of the Motor Vehicle Registration Act for registration of
- 25 <u>the special interest motor vehicle.</u>

(8) If the cost of manufacturing special interest motor 1 2 vehicle license plates at any time exceeds the amount charged for 3 license plates pursuant to section 60-3,102, any money to be credited 4 to the Department of Motor Vehicles Cash Fund under this section 5 shall instead be credited first to the Highway Trust Fund in an amount equal to the difference between the manufacturing costs of 6 7 special interest motor vehicle license plates and the amount charged 8 pursuant to section 60-3,102 with respect to such license plates and 9 the remainder shall be credited to the Department of Motor Vehicles 10 Cash Fund. (9) The special interest motor vehicle license plate 11 12 shall be affixed to the rear of the special interest motor vehicle. 13 (10) A special interest motor vehicle shall not be used 14 for the same purposes and under the same conditions as other motor vehicles of the same type and shall not be used for business or 15 16 occupation or regularly for transportation to and from work. A 17 special interest motor vehicle may be driven on the public streets and roads only for occasional transportation, public displays, 18 19 parades, and related pleasure or hobby activities. 20 (11) It shall be unlawful to own or operate a motor 21 vehicle with special interest motor vehicle license plates in violation of this section. Upon conviction of a violation of any 22 provision of this section, a person shall be guilty of a Class V 23 24 misdemeanor. (12) For purposes of this section, special interest motor 25

- 1 vehicle means a motor vehicle of any age which is being collected,
- 2 preserved, restored, or maintained by the owner as a leisure pursuit
- 3 and not used for general transportation of persons or cargo.
