and 31-409.02, Reissue Revised Statutes of Nebraska; to
change provisions relating to the hours of and notice
requirements for annual elections as prescribed; and to
repeal the original sections.

1 Section 1. Section 31-409, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 31-409 A majority of the directors shall be residents of
- 4 the county or counties in which the district is located. Except as
- 5 provided in section 31-409.03, any person or the officer or
- 6 representative of any corporation owning or controlling any land
- 7 assessed for benefits may be a director. The person elected a
- 8 director receiving the least number of votes shall hold office for
- 9 one year, the next higher for two years, and so on, and the term of
- 10 each shall be adjusted so as to make the term of one director expire
- 11 each year. The officers, consisting of a president, a treasurer, and
- 12 a secretary, shall be chosen by the directors from their own number
- 13 and for a term of one year. Unless the directors choose by February
- 14 fifteenth of a given year to use the procedures provided in section
- 15 31-409.01, annual elections of directors shall be held from 8 a.m.
- 16 until 6 p.m., on the second Tuesday of April each year, at the county
- 17 courthouse or at such other place designated by the board pursuant to
- 18 section 31-409.03. The , but the annual election shall be omitted if
- 19 such date occurs less than nine months after the first election.
- 20 Vacancies in the office of directors may be filled by the remaining
- 21 directors until the next election. All directors and officers shall
- 22 hold office until their successors are elected and qualified.

- 25 31-409.02 Notice of an annual election held pursuant to

1 section 31-409, 31-409.01, or 31-409.03 shall be published once each

- 2 week for two consecutive weeks in a newspaper of general circulation
- 3 in the district, or the precinct if the district has been divided
- 4 into voting precincts as provided in section 31-409.03, designated by
- 5 the district. The last publication shall not be less than thirty days
- 6 prior to the election. The notice shall include the date and location
- 7 or locations of the election and the hours for voting, the number of
- 8 directors to be elected, the names of those whose terms will expire,
- 9 and the procedure for filing as a candidate.
- 10 Sec. 3. Original sections 31-409 and 31-409.02, Reissue
- 11 Revised Statutes of Nebraska, are repealed.
