A BILL

1 FOR AN ACT relating to redistricting; to amend sections 85-103.01 and  
2 85-103.02, Reissue Revised Statutes of Nebraska; to  
3 change district boundaries for members of the Board of  
4 Regents of the University of Nebraska by the adoption of  
5 maps by reference; to harmonize provisions; to repeal the  
6 original sections; and to declare an emergency.  
7 Be it enacted by the people of the State of Nebraska,

1           Section 1. Section 85-103.01, Reissue Revised Statutes of  
2 Nebraska, is amended to read:

3           85-103.01 (1) For the purpose of section 85-103, the  
4 state is divided into eight districts. Each district shall be  
5 entitled to one regent on the board. ~~The limits and designations of~~

14 (2) The numbers and boundaries of the districts are  
15 designated and established by maps identified and labeled as maps  
16 REG11-1, REG11-2, REG11-3, REG11-4, REG11-5, REG11-5A, REG11-6,  
17 REG11-7, and REG11-8, filed with the Clerk of the Legislature, and  
18 incorporated by reference as part of this legislative bill.

19 (3)(a) The Clerk of the Legislature shall transfer  
20 possession of the maps referred to in subsection (2) of this section  
21 to the Secretary of State on the effective date of this act.

22 (b) When questions of interpretation of district  
23 boundaries arise, the maps referred to in subsection (2) of this  
24 section in possession of the Secretary of State shall serve as the  
25 indication of the legislative intent in drawing the district

1 boundaries.

2 (c) Each election commissioner or county clerk shall  
3 obtain copies of the maps referred to in subsection (2) of this  
4 section for the election commissioner's or clerk's county from the  
5 Secretary of State.

6 (d) The Secretary of State shall also have available for  
7 viewing on his or her web site the maps referred to in subsection (2)  
8 of this section identifying the boundaries for the districts.

9 Sec. 2. Section 85-103.02, Reissue Revised Statutes of  
10 Nebraska, is amended to read:

11 85-103.02 ~~The descriptions of districts in~~ For purposes  
12 of section 85-103.01, the Legislature adopts the official population  
13 figures and maps are taken from the 2000-2010 Census Redistricting  
14 (Public Law 94-171) TIGER/Line files-Shapefiles published by the  
15 United States Department of Commerce, Bureau of the Census.

16 Sec. 3. Original sections 85-103.01 and 85-103.02,  
17 Reissue Revised Statutes of Nebraska, are repealed.

18 Sec. 4. Since an emergency exists, this act takes effect  
19 when passed and approved according to law.
