- FOR AN ACT relating to the State Fire Marshal; to amend sections 2 28-1239.01 and 28-1246, Revised Statutes Cumulative Supplement, 2010; to remove the social security number 3 requirement from certain fireworks permit and license 5 applications; and to repeal the original sections. Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 28-1239.01, Revised Statutes

- 2 Cumulative Supplement, 2010, is amended to read:
- 3 28-1239.01 (1) No person shall conduct a public
- 4 exhibition or display of display fireworks without first procuring a
- 5 display permit from the State Fire Marshal. If the applicant is an
- 6 individual, the application for a display permit shall include the
- 7 applicant's social security number. Such application for a display
- 8 permit shall be accompanied by a fee of ten dollars to be deposited
- 9 in the State Fire Marshal Cash Fund.
- 10 (2) No display fireworks shall be sold or delivered by a
- 11 licensed distributor to any person who is not in possession of an
- 12 approved display permit. Sales of display fireworks to persons
- 13 without an approved display permit shall be subject to sections
- 14 28-1213 to 28-1239.
- Sec. 2. Section 28-1246, Revised Statutes Cumulative
- 16 Supplement, 2010, is amended to read:
- 17 28-1246 (1) It shall be unlawful for any person to sell,
- 18 hold for sale, or offer for sale as a distributor, jobber, or
- 19 retailer any fireworks in this state unless such person has first
- 20 obtained a license as a distributor, jobber, or retailer. Application
- 21 for each such license shall be made to the State Fire Marshal on
- 22 forms prescribed by him or her. If the applicant is an individual,
- 23 each application shall include the applicant's social security
- 24 number. Each application shall be accompanied by the required fee,
- 25 which shall be five hundred dollars for a distributor's license, two

1 hundred dollars for a jobber's license, and twenty-five dollars for a

- 2 retailer's license. Each application for a retailer's license shall
- 3 be received by the State Fire Marshal at least ten business days
- 4 prior to the sales period, as set forth in section 28-1249, in which
- 5 the retailer wishes to sell consumer fireworks. A retailer's license
- 6 shall be good only for the specific sales period listed on the
- 7 application and within the calendar year in which issued. The
- 8 retailer's license shall at all times be displayed at the place of
- 9 business of the holder thereof.
- 10 (2) The funds received pursuant to this section shall be
- 11 remitted to the State Treasurer for credit to the State Fire Marshal
- 12 Cash Fund.
