A BILL

FOR AN ACT relating to the Nebraska Behavioral Health Services Act;

to amend sections 71-806, 71-809, and 83-368, Reissue

Revised Statutes of Nebraska; to provide for policies

relating to financial eligibility of consumers and

schedules of fees and copays; to harmonize provisions;

and to repeal the original sections.

Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 71-806, Reissue Revised Statutes of 2 Nebraska, is amended to read:

3 71-806 (1) The division shall act as the chief behavioral health authority for the State of Nebraska and shall direct the 4 5 administration and coordination of the public behavioral health system, including, but not limited to: (a) Administration and 6 7 management of the division, regional centers, and any other 8 facilities and programs operated by the division; (b) integration and 9 coordination of the public behavioral health system; 10 comprehensive statewide planning for the provision of an appropriate array of community-based behavioral health services and continuum of 11 12 care; (d) coordination and oversight of regional behavioral health 13 authorities, including approval of regional budgets and audits of 14 behavioral health authorities; (e) regional development 15 management of data and information systems; (f) prioritization and 16 approval of all expenditures of funds received and administered by the division, including: The the establishment of rates to be paid: 17 and—reimbursement methodologies for behavioral health services: 18 methodologies to be used by regional behavioral health authorities in 19 20 determining a consumer's financial eligibility as provided in subsection (2) of section 71-809; and fees and copays to be paid by 21 22 consumers of such services; (g) cooperation with the department in 23 the licensure and regulation of behavioral health professionals, 24 programs, and facilities; (h) cooperation with the department in the 25 provision of behavioral health services under the medical assistance

1 program; (i) audits of behavioral health programs and services; and

- 3 quality of behavioral health services, recruitment and retention of
- 4 behavioral health professionals, and access to behavioral health
- 5 programs and services.

- 6 (2) The department shall adopt and promulgate rules and
- 7 regulations to carry out the Nebraska Behavioral Health Services Act.
- 8 Sec. 2. Section 71-809, Reissue Revised Statutes of
- 9 Nebraska, is amended to read:
- 71-809 (1) Each regional behavioral health authority 10 shall be responsible for the development and coordination of publicly 11 12 funded behavioral health services within the behavioral health region 13 pursuant to rules and regulations adopted and promulgated by the 14 department, including, but not limited to, (a) administration and 15 management of the regional behavioral health authority, (b) integration and coordination of the public behavioral health system 16 within the behavioral health region, (c) comprehensive planning for 17 the provision of an appropriate array of community-based behavioral 18 health services and continuum of care for the region, (d) submission 19 20 for approval by the division of an annual budget and a proposed plan 21 for the funding and administration of publicly funded behavioral

health services within the region, (e) submission of annual reports

and other reports as required by the division, (f) initiation and

oversight of contracts for the provision of publicly funded

behavioral health services, and (g) coordination with the division in

1 conducting audits of publicly funded behavioral health programs and

- 2 services.
- 3 (2) Each regional behavioral health authority shall adopt
- 4 a policy for use in determining the financial eligibility of all
- 5 consumers and shall adopt a uniform schedule of fees and copays,
- 6 based on the policy and schedule developed by the division, to be
- 7 assessed against consumers utilizing community-based behavioral
- 8 health services in the region. The methods used to determine the
- 9 financial eligibility of all consumers shall take into account
- 10 taxable income, the number of family members dependent on the
- 11 consumer's income, liabilities, and other factors as determined by
- 12 the division. The policy and the schedule of fees and copays shall be
- 13 approved by the regional governing board and included with the budget
- 14 plan submitted to the division annually. Providers shall charge fees
- 15 consistent with the schedule of fees and copays in accordance with
- 16 the financial eligibility of all consumers but not in excess of the
- 17 <u>actual cost of the service. Each regional behavioral health authority</u>
- 18 shall assure that its policy and schedule of fees and copays are
- 19 applied uniformly by the providers in the region.
- 20 $\frac{(2)}{(3)}$ Except for services being provided by a regional
- 21 behavioral health authority on July 1, 2004, under applicable state
- 22 law in effect prior to such date, no regional behavioral health
- 23 authority shall provide behavioral health services funded in whole or
- 24 in part with revenue received and administered by the division under
- 25 the Nebraska Behavioral Health Services Act unless:

1 (a) There has been a public competitive bidding process

- 2 for such services;
- 3 (b) There are no qualified and willing providers to
- 4 provide such services; and
- 5 (c) The regional behavioral health authority receives
- 6 written authorization from the director and enters into a contract
- 7 with the division to provide such services.
- 8 $\frac{(3)-(4)}{}$ Each regional behavioral health authority shall
- 9 comply with all applicable rules and regulations of the department
- 10 relating to the provision of behavioral health services by such
- 11 authority, including, but not limited to, rules and regulations which
- 12 (a) establish definitions of conflicts of interest for regional
- 13 behavioral health authorities and procedures in the event such
- 14 conflicts arise, (b) establish uniform and equitable public bidding
- 15 procedures for such services, and (c) require each regional
- 16 behavioral health authority to establish and maintain a separate
- 17 budget and separately account for all revenue and expenditures for
- 18 the provision of such services.
- 19 Sec. 3. Section 83-368, Reissue Revised Statutes of
- 20 Nebraska, is amended to read:
- 21 83-368 The Except as provided in section 71-809, the
- 22 department shall determine the ability of a patient to pay by
- 23 consideration of the following factors: (1) Taxable income reportable
- 24 under Nebraska law; (2) the patient's age; (3) the number of his or
- 25 her dependents and their ages and mental and physical conditions; (4)

1 the patient's length of care or treatment; (5) his or her

- 2 liabilities; and (6) his or her assets including health insurance
- 3 coverage.
