## A BILL

- FOR AN ACT relating to minitrucks; to amend sections 60-121.01,
  60-337.01, and 60-636.01, Reissue Revised Statutes of
  Nebraska, and section 60-501, Revised Statutes
  Supplement, 2011; to redefine minitruck; and to repeal
  the original sections.
- 6 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-121.01, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 60-121.01 Minitruck means a foreign-manufactured import
- 4 vehicle or domestic-manufactured vehicle which (1) is powered by an
- 5 internal combustion engine with a piston or rotor displacement of one
- 6 thousand <u>five hundred</u> cubic centimeters or less, (2) is sixty-seven
- 7 inches or less in width, (3) has a dry weight of four thousand two
- 8 hundred pounds or less, (4) travels on four or more tires, (5) has a
- 9 top speed of approximately fifty-five miles per hour, (6) is equipped
- 10 with a bed or compartment for hauling, (7) has an enclosed passenger
- 11 cab, (8) is equipped with headlights, taillights, turnsignals,
- 12 windshield wipers, a rearview mirror, and an occupant protection
- 13 system, and (9) has a four-speed, five-speed, or automatic
- 14 transmission.

- 17 60-337.01 Minitruck means a foreign-manufactured import
- 18 vehicle or domestic-manufactured vehicle which (1) is powered by an
- 19 internal combustion engine with a piston or rotor displacement of one
- 20 thousand five hundred cubic centimeters or less, (2) is sixty-seven
- 21 inches or less in width, (3) has a dry weight of four thousand two
- 22 hundred pounds or less, (4) travels on four or more tires, (5) has a
- 23 top speed of approximately fifty-five miles per hour, (6) is equipped
- 24 with a bed or compartment for hauling, (7) has an enclosed passenger
- 25 cab, (8) is equipped with headlights, taillights, turnsignals,

1 windshield wipers, a rearview mirror, and an occupant protection

- 2 system, and (9) has a four-speed, five-speed, or automatic
- 3 transmission.

- 5 2011, is amended to read:
- 6 60-501 For purposes of the Motor Vehicle Safety
- 7 Responsibility Act, unless the context otherwise requires:
- 8 (1) Department means Department of Motor Vehicles;
- 9 (2) Judgment means any judgment which shall have become
- 10 final by the expiration of the time within which an appeal might have
- 11 been perfected without being appealed, or by final affirmation on
- 12 appeal, rendered by a court of competent jurisdiction of any state or
- 13 of the United States, (a) upon a cause of action arising out of the
- 14 ownership, maintenance, or use of any motor vehicle for damages,
- 15 including damages for care and loss of services, because of bodily
- 16 injury to or death of any person or for damages because of injury to
- 17 or destruction of property, including the loss of use thereof, or (b)
- 18 upon a cause of action on an agreement of settlement for such
- 19 damages;
- 20 (3) License means any license issued to any person under
- 21 the laws of this state pertaining to operation of a motor vehicle
- 22 within this state;
- 23 (4) Low-speed vehicle means a four-wheeled motor vehicle
- 24 (a) whose speed attainable in one mile is more than twenty miles per
- 25 hour and not more than twenty-five miles per hour on a paved, level

1 surface, (b) whose gross vehicle weight rating is less than three

- 2 thousand pounds, and (c) that complies with 49 C.F.R. part 571, as
- 3 such part existed on January 1, 2011;
- 4 (5) Minitruck means a foreign-manufactured import vehicle
- 5 or domestic-manufactured vehicle which (a) is powered by an internal
- 6 combustion engine with a piston or rotor displacement of one thousand
- 7 <u>five hundred</u> cubic centimeters or less, (b) is sixty-seven inches or
- 8 less in width, (c) has a dry weight of four thousand two hundred
- 9 pounds or less, (d) travels on four or more tires, (e) has a top
- 10 speed of approximately fifty-five miles per hour, (f) is equipped
- 11 with a bed or compartment for hauling, (g) has an enclosed passenger
- 12 cab, (h) is equipped with headlights, taillights, turnsignals,
- 13 windshield wipers, a rearview mirror, and an occupant protection
- 14 system, and (i) has a four-speed, five-speed, or automatic
- 15 transmission;
- 16 (6) Motor vehicle means any self-propelled vehicle which
- 17 is designed for use upon a highway, including trailers designed for
- 18 use with such vehicles, minitrucks, and low-speed vehicles. Motor
- 19 vehicle does not include (a) mopeds as defined in section 60-637, (b)
- 20 traction engines, (c) road rollers, (d) farm tractors, (e) tractor
- 21 cranes, (f) power shovels, (g) well drillers, (h) every vehicle which
- 22 is propelled by electric power obtained from overhead wires but not
- 23 operated upon rails, (i) electric personal assistive mobility devices
- 24 as defined in section 60-618.02, and (j) off-road designed vehicles,
- 25 including, but not limited to, golf carts, go-carts, riding

1 lawnmowers, garden tractors, all-terrain vehicles and utility-type

- 2 vehicles as defined in section 60-6,355, minibikes as defined in
- 3 section 60-636, and snowmobiles as defined in section 60-663;
- 4 (7) Nonresident means every person who is not a resident
- 5 of this state;
- 6 (8) Nonresident's operating privilege means the privilege
- 7 conferred upon a nonresident by the laws of this state pertaining to
- 8 the operation by him or her of a motor vehicle or the use of a motor
- 9 vehicle owned by him or her in this state;
- 10 (9) Operator means every person who is in actual physical
- 11 control of a motor vehicle;
- 12 (10) Owner means a person who holds the legal title of a
- 13 motor vehicle, or in the event (a) a motor vehicle is the subject of
- 14 an agreement for the conditional sale or lease thereof with the right
- 15 of purchase upon performance of the conditions stated in the
- 16 agreement and with an immediate right of possession vested in the
- 17 conditional vendee or lessee or (b) a mortgagor of a vehicle is
- 18 entitled to possession, then such conditional vendee or lessee or
- 19 mortgagor shall be deemed the owner for the purposes of the act;
- 20 (11) Person means every natural person, firm,
- 21 partnership, limited liability company, association, or corporation;
- 22 (12) Proof of financial responsibility means evidence of
- 23 ability to respond in damages for liability, on account of accidents
- 24 occurring subsequent to the effective date of such proof, arising out
- 25 of the ownership, maintenance, or use of a motor vehicle, (a) in the

1 amount of twenty-five thousand dollars because of bodily injury to or

- 2 death of one person in any one accident, (b) subject to such limit
- 3 for one person, in the amount of fifty thousand dollars because of
- 4 bodily injury to or death of two or more persons in any one accident,
- 5 and (c) in the amount of twenty-five thousand dollars because of
- 6 injury to or destruction of property of others in any one accident;
- 7 (13) Registration means registration certificate or
- 8 certificates and registration plates issued under the laws of this
- 9 state pertaining to the registration of motor vehicles;
- 10 (14) State means any state, territory, or possession of
- 11 the United States, the District of Columbia, or any province of the
- 12 Dominion of Canada; and
- 13 (15) The forfeiture of bail, not vacated, or of
- 14 collateral deposited to secure an appearance for trial shall be
- 15 regarded as equivalent to conviction of the offense charged.
