A BILL

1 FOR AN ACT relating to state funds; to amend sections 68-965,
2 71-7611, and 71-8805, Reissue Revised Statutes of
3 Nebraska, section 82-332, Revised Statutes Cumulative
4 Supplement, 2010, sections 13-2704, 29-3921, 58-703,
5 66-1345.04, and 82-331, Revised Statutes Supplement,
6 2011, and Laws 2011, LB378, section 14; to state and
7 restate intent; to provide for transfers of funds; to
8 change and eliminate provisions relating to certain
9 transfers of funds; to create funds; to provide for a
10 study; to change the source and use of funds; to provide
11 operative dates; to repeal the original sections; to
12 outright repeal Laws 2011, LB378, sections 8 and 10; and
13 to declare an emergency.

14 Be it enacted by the people of the State of Nebraska,

1 Section 1. The State Treasurer shall transfer \$99,666.37
2 from the State Insurance Fund to the Roads Operations Cash Fund on
3 the operative date of this section or as soon thereafter as
4 administratively possible.

5 Sec. 2. Laws 2011, LB378, section 14, is amended to read:

6 Sec. 14. The State Treasurer shall transfer ~~\$3,800,000~~ up
7 to \$1,000,000 from the General Fund to the Ethanol Production
8 Incentive Cash Fund on or before ~~June 30,~~December 31, 2012, on such
9 ~~date~~ dates and in such amounts as directed by the budget
10 administrator of the budget division of the Department of
11 Administrative Services, pursuant to subdivision (2)(1) of section
12 66-1345.04.

13 Sec. 3. The State Colleges Sport Facilities Cash Fund is
14 created. The fund shall be administered by the Board of Trustees of
15 the Nebraska State Colleges. The fund shall include transfers from
16 the Civic and Community Center Financing Fund, revenue received from
17 gifts, grants, bequests, donations, other similar donation
18 arrangements, or other contributions from public or private sources,
19 and such other revenue as may accrue to the State Colleges Sport
20 Facilities Cash Fund. Expenditures from the fund are authorized to
21 support renovation and construction of or improvements to facilities
22 for intercollegiate athletics and student fitness, recreation, and
23 sport activities at the Nebraska state colleges. Any money in the
24 fund available for investment shall be invested by the state
25 investment officer pursuant to the Nebraska Capital Expansion Act and

1 the Nebraska State Funds Investment Act.

2 Sec. 4. Section 13-2704, Revised Statutes Supplement,
3 2011, is amended to read:

4 13-2704 (1) The Civic and Community Center Financing Fund
5 is created. The fund shall be administered by the department.
6 Transfers may be made from the fund to the General Fund at the
7 direction of the Legislature. Any money in the Civic and Community
8 Center Financing Fund available for investment shall be invested by
9 the state investment officer pursuant to the Nebraska Capital
10 Expansion Act and the Nebraska State Funds Investment Act. The fund
11 may be used for assistance for the construction of new civic centers,
12 the renovation or expansion of existing civic or community centers,
13 or the conversion, rehabilitation, or reuse of historic buildings for
14 purposes consistent with this section. The fund may not be used for
15 programming, marketing, advertising, and related activities.
16 Transfers may be made from the fund to the Department of Revenue
17 Enforcement Fund and to the State Colleges Sport Facilities Cash Fund
18 at the direction of the Legislature.

19 (2) It is the intent of the Legislature that on July 1,
20 2011, or as soon thereafter as is administratively possible the State
21 Treasurer shall transfer forty-two thousand nine hundred dollars from
22 the Civic and Community Center Financing Fund to the Department of
23 Revenue Enforcement Fund.

24 (3) The State Treasurer shall transfer two hundred fifty
25 thousand dollars from the Civic and Community Center Financing Fund

1 to the State Colleges Sport Facilities Cash Fund on October 1 of
2 2012, 2013, and 2014. Commencing October 1, 2015, and every year
3 thereafter, the State Treasurer shall transfer four hundred thousand
4 dollars from the Civic and Community Center Financing Fund to the
5 State Colleges Sport Facilities Cash Fund.

6 Sec. 5. Section 29-3921, Revised Statutes Supplement,
7 2011, is amended to read:

8 29-3921 (1) The Commission on Public Advocacy Operations
9 Cash Fund is created. The fund shall be used for the operations of
10 the commission, except that transfers may be made from the fund to
11 the General Fund at the direction of the Legislature through June 30,
12 2011. The Commission on Public Advocacy Operations Cash Fund shall
13 consist of money remitted pursuant to section 33-156. It is the
14 intent of the Legislature that the commission shall be funded solely
15 from the fund. Any money in the fund available for investment shall
16 be invested by the state investment officer pursuant to the Nebraska
17 Capital Expansion Act and the Nebraska State Funds Investment Act.

18 (2) On July 1, 2011, or as soon thereafter as
19 administratively possible, the State Treasurer shall transfer one
20 hundred thousand dollars from the Commission on Public Advocacy
21 Operations Cash Fund to the Supreme Court Education Fund. The State
22 Court Administrator shall use these funds to assist the juvenile
23 justice system in providing prefiling and diversion programming
24 designed to reduce excessive absenteeism and unnecessary involvement
25 with the juvenile justice system.

1 (3) The State Treasurer shall transfer the following
2 amounts from the Commission on Public Advocacy Operations Cash Fund
3 to the Court Appointed Special Advocate Fund:

4 (a) On July 1, 2011, or as soon thereafter as
5 administratively possible, one hundred thousand dollars; and

6 (b) On July 1, 2012, or as soon thereafter as
7 administratively possible, two hundred thousand dollars.

8 (4) On July 1, 2012, or as soon thereafter as
9 administratively possible, the State Treasurer shall transfer sixty
10 thousand dollars from the Commission on Public Advocacy Operations
11 Cash Fund to the Nebraska State Patrol Cash Fund.

12 The Nebraska State Patrol shall use such funds to
13 contract with the University of Nebraska to study sex offender
14 recidivism data before and after the passage of Laws 2009, LB285,
15 which changed the Nebraska sex offender classification system from an
16 evaluation of risk assessment system to an offense-based assessment
17 system in the attempt by the state to comply with federal
18 requirements under the Adam Walsh Child Protection and Safety Act of
19 2006.

20 Sec. 6. Section 58-703, Revised Statutes Supplement,
21 2011, is amended to read:

22 58-703 The Affordable Housing Trust Fund is created. The
23 fund shall receive money pursuant to sections 8-1120 and 76-903 and
24 may include revenue from sources recommended by the housing advisory
25 committee established in section 58-704, appropriations from the

1 Legislature, transfers authorized by the Legislature, grants, private
2 contributions, repayment of loans, and all other sources, except that
3 ~~before appropriations from the General Fund and transfers from the~~
4 General Fund or the Cash Reserve Fund may not be used as a revenue
5 source for the Affordable Housing Trust Fund after June 30, 2013. ~~or~~
6 ~~for administrative costs of the Department of Economic Development in~~
7 ~~administering the fund, such use must be specifically authorized by a~~

17 Transfers may be made from the Affordable Housing Trust

22 2011, is amended to read:

23 66-1345.04 (1) The State Treasurer shall transfer from
24 the General Fund to the Ethanol Production Incentive Cash Fund, on or
25 before the end of each of fiscal years 1995-96 and 1996-97,

1 \$8,000,000 per fiscal year.

2 (2) It is the intent of the Legislature that the
3 following General Fund amounts be appropriated to the Ethanol
4 Production Incentive Cash Fund in each of the following years:

5 (a) For each of fiscal years 1997-98 and 1998-99,
6 \$7,000,000 per fiscal year;

4 Nebraska, is amended to read:

5 68-965 (1) The Autism Treatment Program Cash Fund is
6 created. The fund shall include ~~revenue transferred from the Nebraska~~
7 ~~Health Care Cash Fund and~~ revenue received from gifts, grants,
8 bequests, donations, other similar donation arrangements, or other
9 contributions from public or private sources. The department shall
10 administer the fund. The ~~Autism Treatment Program Cash Fund~~ fund
11 shall be used as the state's matching share for the waiver
12 established under section 68-966 and for expenses incurred in the
13 administration of the Autism Treatment Program. Any money in the fund
14 available for investment shall be invested by the state investment
15 officer pursuant to the Nebraska Capital Expansion Act and the
16 Nebraska State Funds Investment Act.

17 (2) The program shall utilize private funds deposited in
18 the ~~Autism Treatment Program Cash Fund and funds transferred by the~~

3 Nebraska, is amended to read:

4 71-7611 (1) The Nebraska Health Care Cash Fund is
5 created. The State Treasurer shall transfer (a) fifty-six million one
6 hundred thousand dollars no later than July 15, 2009, ~~and~~ (b) fifty-
7 nine million one hundred thousand dollars ~~beginning on~~ July 15, 2010,
8 ~~and annually thereafter no later than~~ July 15, 2011, and July 15,
9 2012, (c) fifty-six million one hundred forty-five thousand dollars
10 no later than July 15, 2013, (d) fifty-three million one hundred
11 ninety thousand dollars no later than July 15, 2014, and (e) fifty
12 million two hundred thirty-five thousand dollars beginning July 15,
13 2015, and annually thereafter no later than July 15 from the Nebraska

19 Nebraska, is amended to read:

20 71-8805 (1) The Stem Cell Research Cash Fund is created.
21 Any money in the fund available for investment shall be invested by
22 the state investment officer pursuant to the Nebraska Capital
23 Expansion Act and the Nebraska State Funds Investment Act.

24 (2) Money credited to the Stem Cell Research Cash Fund
25 ~~pursuant to section 71-7611~~ shall be used to provide a dollar-for-

1 dollar match, up to five hundred thousand dollars per fiscal year, of
2 funds received by institutions or researchers from sources other than
3 funds provided by the State of Nebraska for nonembryonic stem cell
4 research. Such matching funds shall be awarded through the grant
5 process established pursuant to section 71-8804. No single
6 institution or researcher shall receive more than seventy percent of
7 the funds available for distribution under this section on an annual
8 basis.

9 (3) Up to three percent of the funds credited to the Stem

14 Sec. 11. Section 82-331, Revised Statutes Supplement,
15 2011, is amended to read:

16 82-331 (1) There is hereby established in the state
17 treasury a trust fund to be known as the Nebraska Cultural
18 Preservation Endowment Fund. The fund shall consist of funds
19 appropriated or transferred by the Legislature, and only the earnings
20 of the fund may be used as provided in this section.

21 (2) On August 1, 1998, the State Treasurer shall transfer
22 five million dollars from the General Fund to the Nebraska Cultural
23 Preservation Endowment Fund.

24 (3) Except as provided in subsection (4) of this section,
25 it is the intent of the Legislature that the State Treasurer shall

1 transfer (a) an amount not to exceed five hundred thousand dollars
2 from the General Fund to the Nebraska Cultural Preservation Endowment
3 Fund on December 31 of 2009 and 2010 and (b) an amount not to exceed
4 five hundred thousand dollars from the General Fund to the Nebraska
5 Cultural Preservation Endowment Fund on December 31 of 2013, 2014,
6 2015, 2016, 2017, and 2018.

7 (4) Prior to the transfer of funds from any state account
8 into the Nebraska Cultural Preservation Endowment Fund, the Nebraska
9 Arts Council shall provide documentation to the budget division of
10 the Department of Administrative Services that qualified endowments
11 have generated a dollar-for-dollar match of new money, up to the
12 amount of state funds authorized by the Legislature to be transferred
13 to the Nebraska Cultural Preservation Endowment Fund. For purposes of
14 this section, new money means a contribution to a qualified endowment
15 generated after July 1, 2011. Contributions not fully matched by
16 state funds shall be carried forward to succeeding years and remain
17 available to provide a dollar-for-dollar match for state funds. For
18 an endowment to be a qualified endowment (a) the endowment must meet
19 the standards set by the Nebraska Arts Council or Nebraska Humanities
20 Council, (b) the endowment must be intended for long-term
21 stabilization of the organization, and (c) the funds of the endowment
22 must be endowed and only the earnings thereon expended. The budget
23 division of the Department of Administrative Services shall notify
24 the State Treasurer to execute a transfer of state funds up to the
25 amount specified by the Legislature, but only to the extent that the

1 Nebraska Arts Council has provided documentation of a dollar-for-
2 dollar match. ~~Funds~~ State funds not transferred shall be carried
3 forward to the succeeding year and be added to the funds authorized
4 for a dollar-for-dollar match during that year.

5 (5) The Legislature shall not appropriate or transfer
6 money from the Nebraska Cultural Preservation Endowment Fund for any
7 purpose other than the purposes stated in sections 82-330 to 82-333,
8 except that the Legislature may appropriate or transfer money from
9 the fund upon a finding that the purposes of such sections are not
10 being accomplished by the fund.

11 (6) Any money in the Nebraska Cultural Preservation
12 Endowment Fund available for investment shall be invested by the
13 state investment officer pursuant to the Nebraska Capital Expansion
14 Act and the Nebraska State Funds Investment Act.

15 (7) All investment earnings from the Nebraska Cultural
16 Preservation Endowment Fund shall be credited to the Nebraska Arts
17 and Humanities Cash Fund.

18 Sec. 12. Section 82-332, Revised Statutes Cumulative
19 Supplement, 2010, is amended to read:

20 82-332 (1) The Nebraska Arts and Humanities Cash Fund is
21 created. The fund shall consist of all funds credited from the
22 Nebraska Cultural Preservation Endowment Fund pursuant to section
23 82-331. The Nebraska Arts Council shall administer and distribute the
24 Nebraska Arts and Humanities Cash Fund. All disbursements from the
25 Nebraska Arts and Humanities Cash Fund shall be matched dollar-for-

1 dollar by sources other than state funds. The match funds shall be
2 new money generated for endowments established by the Nebraska Arts
3 Council or Nebraska Humanities Council or qualified endowments of
4 their constituent organizations, new money generated as a result of
5 seed grants to recipients, or new money generated by the Nebraska
6 Arts Council or Nebraska Humanities Council for arts or humanities
7 education. Matching funds shall also include earnings generated by
8 qualified private endowments formed in accordance with this section.
9 ~~New money used as a match shall not be limited to matching the~~
10 ~~Nebraska Arts and Humanities Cash Fund in the state fiscal year the~~
11 ~~new money is received, but it shall be used as a match no later than~~
12 ~~the subsequent fiscal year. For purposes of this section, new money~~
13 ~~means a contribution to a qualified endowment generated after July 1,~~
14 ~~2011. Contributions not fully matched by state funds shall be carried~~
15 ~~forward to succeeding years and remain available to provide a dollar-~~
16 ~~for-dollar match for state funds.~~ For an endowment to be a qualified
17 endowment (a) the endowment must meet the standards set by the
18 Nebraska Arts Council or Nebraska Humanities Council, (b) the
19 endowment must be intended for long-term stabilization of the
20 organization, and (c) the funds of the endowment must be endowed and
21 only the earnings thereon expended. An organization is a constituent
22 organization if it receives funding from the Nebraska Arts Council or
23 Nebraska Humanities Council and is tax exempt under section 501 of
24 the Internal Revenue Code. The match funds required by this section
25 shall not include in-kind contributions. The budget division of the

1 Department of Administrative Services shall approve allotment and
2 disbursement of funds from the Nebraska Arts and Humanities Cash Fund
3 only to the extent the Nebraska Arts Council has provided
4 documentation of the dollar-for-dollar match required by this
5 section. Funds from the Nebraska Arts and Humanities Cash Fund may be
6 used for the purpose of obtaining challenge grants from the National
7 Endowment for the Humanities or the National Endowment for the Arts.

8 (2) Rules and regulations of the Nebraska Arts Council
9 shall provide that the ultimate use of disbursements from the
10 Nebraska Arts and Humanities Cash Fund shall be in a ratio of seventy
11 percent to projects, endowments, or programs designated by the
12 Nebraska Arts Council and thirty percent to projects, endowments, or
13 programs designated by the Nebraska Humanities Council.

14 (3) Any money in the fund available for investment shall
15 be invested by the state investment officer pursuant to the Nebraska
16 Capital Expansion Act and the Nebraska State Funds Investment Act.

17 Sec. 13. The World Day on the Mall Cash Fund is created.
18 The fund shall consist of sums that are contributed as gifts,
19 donations, grants, or bequests to provide multicultural or diversity
20 education, training, and events. The fund shall be used by the
21 personnel division of the Department of Administrative Services for
22 the administration of multicultural or diversity education, training,
23 and events. Any money in the fund available for investment shall be
24 invested by the state investment officer pursuant to the Nebraska
25 Capital Expansion Act and the Nebraska State Funds Investment Act.

1 Sec. 14. Sections 8, 9, 10, and 16 of this act become
2 operative on July 1, 2012. The other sections of this act become
3 operative on their effective date.

4 Sec. 15. Original section 82-332, Revised Statutes
5 Cumulative Supplement, 2010, sections 13-2704, 29-3921, 58-703,
6 66-1345.04, and 82-331, Revised Statutes Supplement, 2011, and Laws
7 2011, LB378, section 14, are repealed.

8 Sec. 16. Original sections 68-965, 71-7611, and 71-8805,
9 Reissue Revised Statutes of Nebraska, are repealed.

10 Sec. 17. The following sections are outright repealed:
11 Laws 2011, LB378, sections 8 and 10.

12 Sec. 18. Since an emergency exists, this act takes effect
13 when passed and approved according to law.
