1	FOR	AN	ACT relating to the Voluntary Emergency Responders Job
2			Protection Act; to amend sections 35-1403, 35-1406, and
3			35-1407, Reissue Revised Statutes of Nebraska, and
4			section 35-1402, Revised Statutes Cumulative Supplement,
5			2010; to include members of state emergency response
6			teams established under the Emergency Management Act; to
7			harmonize provisions; and to repeal the original
8			sections.

1 Section 1. Section 35-1402, Revised Statutes Cumulative

- 2 Supplement, 2010, is amended to read:
- 3 35-1402 For purposes of the Volunteer Emergency
- 4 Responders Job Protection Act:
- 5 (1) Employee does not include a career firefighter or law
- 6 enforcement officer who is acting as a volunteer emergency responder;
- 7 (2) Employer means any person employing ten or more
- 8 employees; and
- 9 (3) Volunteer emergency responder means:
- 10 (a) An individual who has been approved by a governing
- 11 body in Nebraska to serve any volunteer fire department or volunteer
- 12 first-aid, rescue, ambulance, or emergency squad, or volunteer fire
- 13 company, association, or organization serving any city, village, or
- 14 rural or suburban fire protection district by providing fire
- 15 protection or emergency response services for the purpose of
- 16 protecting life, health, or property; and
- 17 (b) An individual who is in good standing as a volunteer
- 18 member of the Nebraska Wing of the Civil Air Patrol, the civilian
- 19 auxiliary of the United States Air Force; or -
- 20 (c) An individual who is a member of a state emergency
- 21 response team pursuant to the Emergency Management Act.
- 22 Sec. 2. Section 35-1403, Reissue Revised Statutes of
- 23 Nebraska, is amended to read:
- 24 35-1403 No employer shall terminate or take any other
- 25 disciplinary action against any employee who is a volunteer emergency

1 responder if such employee, when acting or actively deployed as a

- 2 volunteer emergency responder, is absent from or reports late to his
- 3 or her place of employment in order to respond to an emergency prior
- 4 to the time such employee is to report to his or her place of
- 5 employment.
- 6 Sec. 3. Section 35-1406, Reissue Revised Statutes of
- 7 Nebraska, is amended to read:
- 8 35-1406 At an employer's request, an employee, acting as
- 9 a volunteer emergency responder, who is absent from or reports late
- 10 to his or her place of employment in order to respond to an emergency
- 11 shall provide his or her employer, within seven days of such request,
- 12 a written statement signed by the individual in charge of the
- 13 volunteer department or another individual authorized to act for such
- 14 individual that includes the following: The fact that the employee
- 15 responded to an emergency; the date and time of the emergency; and
- 16 the date and time such employee completed his or her volunteer
- 17 emergency activities.
- 18 Sec. 4. Section 35-1407, Reissue Revised Statutes of
- 19 Nebraska, is amended to read:
- 20 35-1407 Prior to seeking protection pursuant to the
- 21 Volunteer Emergency Responders Job Protection Act, an employee acting
- 22 as a volunteer emergency responder shall provide his or her employer
- 23 with a written statement signed by the individual in charge of the
- 24 volunteer department or another individual authorized to act for such
- 25 individual notifying such employer that the employee serves as a

1 volunteer emergency responder. An employee who is or who has served

- 2 as a volunteer emergency responder shall notify his or her employer
- 3 when such employee's status as a volunteer emergency responder
- 4 changes, including termination of such status.

- 6 Reissue Revised Statutes of Nebraska, and section 35-1402, Revised
- 7 Statutes Cumulative Supplement, 2010, are repealed.
