A BILL

1 FOR AN ACT relating to appropriations; to amend Laws 2011, LB 374,
2 section 108; to provide for appropriations for nurse
3 visitation services as prescribed; to repeal the original
4 section; and to declare an emergency.
5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Original Laws 2011, LB 374, section 108, is
2 amended to read as follows:

20 There is included in the appropriation to this program
21 \$653,759 General Funds for FY2011-12 and \$653,759 General Funds for
22 FY2012-13, which shall only be used for the following purposes:
23 Reimbursement for the provision of pap smears, colposcopy, cervical
24 biopsy, cryotherapy, loop electrosurgical excision procedure (LEEP),

1 and such other treatments and procedures as may be developed for the
2 followup of abnormal pap smears; the diagnosis and treatment of
3 sexually transmitted diseases, including, but not limited to,
4 chlamydia, gonorrhoea, HPV (genital warts), and herpes; and associated
5 laboratory and equipment costs and staff training costs relating to
6 the use of colposcopy equipment. None of the General Funds provided
7 under this program shall be used to perform or facilitate the
8 performance of abortion or to counsel or refer for abortion.

9 There is included in the appropriation to this program
10 \$600,000 General Funds for FY2011-12, which shall only be used to
11 continue the existing nurse visitation services pilot program. There
12 is included in the appropriation to this program for FY2012-13
13 \$1,100,000 General Funds, which shall only be used continue and
14 expand the existing nurse visitation services pilot program.

15 Sec. 2. Original Laws 2011, LB 374, section 108, is
16 repealed.

17 Sec. 3. Since an emergency exists, this act takes effect
18 when passed and approved according to law.
