A BILL

1 FOR AN ACT relating to the Motor Vehicle Operator's License Act; to
2 amend sections 60-462, 60-462.02, 60-479, 60-479.01,
3 60-484, 60-487, 60-4,113, 60-4,114, 60-4,115, 60-4,117,
4 60-4,120, 60-4,121, 60-4,122, 60-4,127, 60-4,144,
5 60-4,149, 60-4,150, 60-4,151, and 60-4,181, Reissue
6 Revised Statutes of Nebraska; to adopt certain federal
7 regulations; to provide powers and duties for the
8 Department of Motor Vehicles regarding the design,
9 production, issuance, and renewal of and payment for
10 operators' licenses and state identification cards; to
11 provide implementation dates; to eliminate obsolete
12 provisions; to harmonize provisions; to repeal the
13 original sections; and to declare an emergency.

14 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-462, Reissue Revised Statutes of
2 Nebraska, is amended to read:

3 60-462 Sections 60-462 to 60-4,188 and sections 6 to 9 of
4 this act shall be known and may be cited as the Motor Vehicle
5 Operator's License Act.

9 department develop, implement, and maintain processes for the
10 issuance of operators' licenses and state identification cards

12 such licenses and cards and reduce identity theft, fraud, forgery,
13 and counterfeiting to the maximum extent possible with respect to
14 such licenses and cards. ~~The director shall designate an~~
15 ~~implementation date for such processes which date is on or before~~
16 ~~August 1, 2009.~~ The department shall adopt security and technology
17 practices to enhance the enrollment, production, data storage, and
18 credentialing system of such licenses and cards in order to maximize
19 the integrity of the process.

18 Sec. 6. This section applies beginning on an
19 implementation date designated by the director on or before January
20 1, 2014. The department shall retain copies of source documents
21 presented by all individuals applying for or holding operators'
22 licenses or state identification cards. Copies retained by the
23 department shall be held in secured storage and managed to meet the
24 requirements of the Uniform Motor Vehicle Records Disclosure Act and
25 sections 60-484 and 60-484.02.

1 Sec. 7. (1) This section applies beginning on an
2 implementation date designated by the director on or before January
3 1, 2014.

4 (2) Before being issued any type of operator's license or
5 a state identification card under the Motor Vehicle Operator's
6 License Act, the department shall require an applicant to present
7 valid documentary evidence that he or she has lawful status in the
8 United States. Lawful status may be shown by:

9 (a) A valid, unexpired U.S. passport;

10 (b) A certified copy of a birth certificate filed with a
11 state office of vital statistics or equivalent agency in the
12 individual's state of birth;

13 (c) A Consular Report of Birth Abroad (CRBA) issued by
14 the United States Department of State, Form FS-240, DS-1350, or
15 FS-545;

16 (d) A valid, unexpired Permanent Resident Card (Form
17 1-551) issued by the United States Department of Homeland Security or
18 Bureau of United States Citizenship and Immigration Services;

19 (e) An unexpired employment authorization document (EAD)
20 issued by the United States Department of Homeland Security, Form
21 1-766 or Form I-688B;

22 (f) An unexpired foreign passport with a valid, unexpired
23 United States visa affixed accompanied by the approved 1-94 form
24 documenting the applicant's most recent admittance into the United
25 States;

1 (g) A Certificate of Naturalization issued by the United
2 States Department of Homeland Security, Form N-550 or Form N-570;

3 (h) A Certificate of Citizenship, Form N-560 or Form
4 N-561, issued by the United States Department of Homeland Security;

5 (i) A driver's license or identification card issued in
6 compliance with the standards established by the REAL ID Act of 2005,
7 Public Law 109-13, division B, section 1, 119 Stat. 302; or

8 (j) Such other documents as the director may approve.

9 (3)(a) If an applicant presents one of the documents
10 listed under subdivision (2)(a), (b), (c), (d), (g), or (h) of this
11 section, the verification of the applicant's identity in the manner
12 prescribed in section 60-484 will also provide satisfactory evidence
13 of lawful status.

14 (b) If the applicant presents one of the identity
15 documents listed under subdivision (2)(e), (f), or (i) of this
16 section, the verification of the identity documents does not provide
17 satisfactory evidence of lawful status. The applicant must also
18 present a second document from subsection (2) above or documentation
19 issued by the United States Department of Homeland Security or other
20 federal agencies demonstrating lawful status as determined by the
21 Bureau of United States Citizenship and Immigration Services.

22 (4) An applicant may present other documents as
23 designated by the director as proof of lawful status. Any documents
24 accepted shall be recorded according to a written exceptions process
25 established by the director.

1 Sec. 8. (1) The department shall only issue an operator's
2 license or a state identification card that is temporary to any
3 applicant who presents documentation under section 60-484 and
4 subsection (2) of section 7 of this act that shows his or her lawful
5 presence in the United States is temporary. An operator's license or
6 a state identification card that is temporary shall be valid only
7 during the period of time of the applicant's authorized stay in the
8 United States or, if there is no definite end to the period of
9 authorized stay, a period of one year.

10 (2) An operator's license or state identification card
11 that is temporary shall clearly indicate that it is temporary with a
12 special notation on the front of the license or card and shall state
13 the date on which it expires.

14 (3) An operator's license or state identification card
15 that is temporary may be renewed only upon presentation of valid
16 documentary evidence that the status by which the applicant qualified
17 for the operator's license or state identification card that is
18 temporary has been extended by the United States Department of
19 Homeland Security.

20 Sec. 9. This section applies beginning on an
21 implementation date designated by the director on or before January
22 1, 2014. Before issuing any operator's license or state
23 identification card under the Motor Vehicle Operator's License Act,
24 the department may verify, with the issuing agency, the issuance,
25 validity, and completeness of each document required to be presented

1 by a person pursuant to section 60-484 and section 7 of this act.

2 Sec. 10. Section 60-487, Reissue Revised Statutes of
3 Nebraska, is amended to read:

4 60-487 (1) If any magistrate or judge finds in his or her
5 judgment of conviction that the application or ~~examiner's issuance~~
6 certificate pursuant to which the director has issued an operator's
7 license under the Motor Vehicle Operator's License Act contains any
8 false or fraudulent statement deliberately and knowingly made to any
9 officer as to any matter material to the issuance of such license or
10 does not contain required or correct information or that the person
11 to whom the license was issued was not eligible to receive such
12 license, then the license shall be absolutely void from the date of
13 issue and such motor vehicle operator shall be deemed to be not
14 licensed to operate a motor vehicle. Such license shall be at once
15 canceled of record in his or her office by the director upon receipt
16 of a copy of such judgment of conviction. The director may, upon his
17 or her own motion, summarily cancel any license for any of the
18 reasons set forth in this section if such reason or reasons
19 affirmatively appear on his or her official records.

20 (2) If the director determines, in a check of an
21 applicant's license status and record prior to issuing a commercial
22 driver's license, or at any time after the commercial driver's
23 license is issued, that the applicant falsified information contained
24 in the application, the director may summarily cancel the person's
25 commercial driver's license or his or her pending application as

1 provided in subsection (1) of this section and disqualify the person
2 from operating a commercial motor vehicle for sixty days.
