A BILL

1 FOR AN ACT relating to redistricting; to amend sections 79-311 and
2 79-312, Reissue Revised Statutes of Nebraska; to change
3 district boundaries for members of the State Board of
4 Education by the adoption of maps by reference; to
5 harmonize provisions; to repeal the original sections;
6 and to declare an emergency.

7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 79-311, Reissue Revised Statutes of
2 Nebraska, is amended to read:

3 79-311 (1) For the purpose of section 79-310, the state
4 is divided into eight districts. Each district shall be entitled to
5 one member on the board. The limits and designations of the eight
6 districts shall be as follows:

15 (2) The numbers and boundaries of the districts are
16 designated and established by maps identified and labeled as maps
17 ED11-1, ED11-2, ED11-3, ED11-4, ED11-5, ED11-5A, ED11-6, ED11-7, and
18 ED11-8, filed with the Clerk of the Legislature, and incorporated by
19 reference as part of this legislative bill.

20 (3)(a) The Clerk of the Legislature shall transfer
21 possession of the maps referred to in subsection (2) of this section
22 to the Secretary of State on the effective date of this act.

23 (b) When questions of interpretation of district
24 boundaries arise, the maps referred to in subsection (2) of this
25 section in possession of the Secretary of State shall serve as the

1 indication of the legislative intent in drawing the district
2 boundaries.

3 (c) Each election commissioner or county clerk shall
4 obtain copies of the maps referred to in subsection (2) of this
5 section for the election commissioner's or clerk's county from the
6 Secretary of State.

7 (d) The Secretary of State shall also have available for
8 viewing on his or her web site the maps referred to in subsection (2)
9 of this section identifying the boundaries for the districts.

10 Sec. 2. Section 79-312, Reissue Revised Statutes of
11 Nebraska, is amended to read:

12 79-312 ~~The descriptions of districts in~~ For purposes of
13 section 79-311, the Legislature adopts the official population
14 figures and maps are taken from the 2000-2010 Census Redistricting
15 (Public Law 94-171) TIGER/Line files-Shapefiles published by the
16 United States Department of Commerce, Bureau of the Census.

17 Sec. 3. Original sections 79-311 and 79-312, Reissue
18 Revised Statutes of Nebraska, are repealed.

19 Sec. 4. Since an emergency exists, this act takes effect
20 when passed and approved according to law.
