A BILL

1 FOR AN ACT relating to redistricting; to amend sections 32-504 and
2 32-505, Reissue Revised Statutes of Nebraska; to change
3 district boundaries of the Representatives in the
4 Congress of the United States by the adoption of maps by
5 reference; to harmonize provisions; to repeal the
6 original sections; and to declare an emergency.

7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 32-504, Reissue Revised Statutes of
2 Nebraska, is amended to read:

3 32-504 ~~(1)~~ Based on the ~~2000-2010~~ Census of Population by
4 the United States Department of Commerce, Bureau of the Census, the
5 State of Nebraska is hereby divided into three districts for electing
6 Representatives in the Congress of the United States, and each
7 district shall be entitled to elect one representative. ~~The limits~~
8 ~~and designations of the three districts shall be as follows:~~

9 ~~(1) The first district shall contain the counties of~~
10 ~~Richardson, Nemaha, Otoe, Cass, Johnson, Pawnee, Gage, Lancaster,~~
11 ~~Saunders, Seward, Butler, Dodge, Washington, Colfax, Madison, Burt,~~
12 ~~Stanton, Cuming, Thurston, Wayne, Dixon, and Dakota, that part of~~
13 ~~Sarpy County not included in the second district, and that part of~~
14 ~~Cedar County beginning at the intersection of the Cedar Dixon County~~
15 ~~line and the northern boundary of Precinct 7, follow such boundary~~
16 ~~west to the intersection of a north-south line extending north from~~
17 ~~574th Avenue, south along such line to 574th Avenue, south on 574th~~
18 ~~Avenue to 886th Road, west on 886th Road to State Highway 57, north~~
19 ~~on State Highway 57 to 887th Road, west on 887th Road to the~~
20 ~~intersection of a north-south line extending north from 570th Avenue,~~
21 ~~south along such line to 570th Avenue, south on 570th Avenue to 884th~~
22 ~~Road, west on 884th Road to 566th Avenue, south on 566th Avenue to~~
23 ~~Bow Creek, follow Bow Creek west to 883rd Road, west on 883rd Road to~~
24 ~~564th Avenue, south on 564th Avenue to 882nd Road, south on 882nd~~
25 ~~Road to 564th Avenue, south on 564th Avenue and continuing south~~

1 along a north-south line extending south from 564th Avenue to 564th
2 Avenue, south on 564th Avenue to 870th Road, west on 870th Road to
3 564th Avenue, south on 564th Avenue to the Cedar-Wayne County line,
4 east along the Cedar-Wayne County line to the Cedar-Dixon County
5 line, and north along the Cedar-Dixon County line to the point of
6 beginning;

7 (2) The second district shall contain Douglas County and
8 that part of Sarpy County beginning at the intersection of the
9 Douglas-Sarpy County line and South 156th Street, south on South
10 156th Street to Giles Road, east on Giles Road to South 132nd Street,
11 south on South 132nd Street to State Highway 370, east on State
12 Highway 370 to the western boundary of the Papillion-La Vista Public
13 School District, follow such boundary south to Schram Road, east on
14 Schram Road to the intersection of a north-south line extending north
15 from South 120th Street, south along such line to the intersection of
16 an east-west line extending west from Maass Road, east along such
17 line to South 114th Street, north on South 114th Street to Schram
18 Road, east on Schram Road to the southern corporate limits of the
19 city of Papillion, follow the southern corporate limits of the city
20 of Papillion east to State Highway 370, east on State Highway 370 to
21 South 72nd Street, south on South 72nd Street to Capehart Road, east
22 on Capehart Road to South 60th Street, south on South 60th Street and
23 continuing south along a north-south line extending south from South
24 60th Street to Platteview Road, east on Platteview Road to Dyson
25 Hollow Road, north on Dyson Hollow Road to the southern boundary of

1 ~~the Bellevue Public School District, follow such boundary east to~~
2 ~~U.S. Highway 75, south on U.S. Highway 75 to the Sarpy Cass County~~
3 ~~line, east along the Sarpy Cass County line to the Nebraska Iowa~~
4 ~~state line, north along the Nebraska Iowa state line to the Douglas-~~
5 ~~Sarpy County line, and west along the Douglas Sarpy County line to~~
6 ~~the point of beginning; and~~

7 ~~(3) The third district shall contain the counties of~~
8 ~~Jefferson, Saline, Thayer, Fillmore, York, Polk, Platte, Pierce,~~
9 ~~Knox, Antelope, Boone, Nance, Merrick, Hamilton, Clay, Nuckolls,~~
10 ~~Webster, Adams, Hall, Howard, Greeley, Wheeler, Holt, Boyd, Garfield,~~
11 ~~Valley, Sherman, Buffalo, Kearney, Franklin, Harlan, Phelps, Furnas,~~
12 ~~Gosper, Dawson, Custer, Loup, Blaine, Keya Paha, Rock, Brown, Cherry,~~
13 ~~Thomas, Logan, Lincoln, Frontier, Red Willow, Hitchcock, Hayes,~~
14 ~~McPherson, Hooker, Grant, Arthur, Keith, Perkins, Chase, Dundy,~~
15 ~~Deuel, Garden, Sheridan, Cheyenne, Morrill, Box Butte, Dawes, Sioux,~~
16 ~~Scotts Bluff, Banner, and Kimball and that part of Cedar County not~~
17 ~~included in the first district.~~

18 (2) The numbers and boundaries of the districts are
19 designated and established by maps identified and labeled as maps
20 CON11-1, CON11-1A, CON11-2, CON11-2A, CON11-3, and CON11-3A, filed
21 with the Clerk of the Legislature, and incorporated by reference as
22 part of this legislative bill.

23 (3)(a) The Clerk of the Legislature shall transfer
24 possession of the maps referred to in subsection (2) of this section
25 to the Secretary of State on the effective date of this act.

1 (b) When questions of interpretation of district
2 boundaries arise, the maps referred to in subsection (2) of this
3 section in possession of the Secretary of State shall serve as the
4 indication of the legislative intent in drawing the district
5 boundaries.

6 (c) Each election commissioner or county clerk shall
7 obtain copies of the maps referred to in subsection (2) of this
8 section for the election commissioner's or clerk's county from the
9 Secretary of State.

10 (d) The Secretary of State shall also have available for
11 viewing on his or her web site the maps referred to in subsection (2)
12 of this section identifying the boundaries for the districts.

13 Sec. 2. Section 32-505, Reissue Revised Statutes of
14 Nebraska, is amended to read:

15 32-505 ~~The descriptions of districts in~~ For purposes of
16 section 32-504, the Legislature adopts the official population
17 figures and maps are taken from the 2000-2010 Census Redistricting
18 (Public Law 94-171) TIGER/Line files-Shapefiles published by the
19 United States Department of Commerce, Bureau of the Census.

20 Sec. 3. Original sections 32-504 and 32-505, Reissue
21 Revised Statutes of Nebraska, are repealed.

22 Sec. 4. Since an emergency exists, this act takes effect
23 when passed and approved according to law.
