## LEGISLATIVE BILL 1072

Approved by the Governor April 2, 2012, with line-item vetoes overridden April 3, 2012.

Introduced by Business and Labor Committee: Lathrop, 12, Chairperson; Ashford, 20; Cook, 13; Harr, 8; Wallman, 30.

FOR AN ACT relating to claims against the state; to appropriate funds for the payment of certain claims; to provide for payment of the claims; to authorize agencies to write off certain claims as prescribed; and to declare an emergency.

Be it enacted by the people of the State of Nebraska,

Section 1.
