Section III: Fiscal Monitoring

DHHS continues to monitor the pilot project's financial statements as indicated in the December 2012 report. DHHS continues to consider NFC as a sub-recipient and no longer a contractor. NFC is also required to conduct and submit an annual A-133 audit.

DHHS also requires NFC to submit an "actual" invoice for each service provided during the month. Invoiced expenditures are recorded via N-FOCUS in order to accurately claim federal funding for Title IV-E maintenance payments. A quarterly reconciliation of invoices to the monthly financial statement continues to be a requirement.

DHHS is unable to draw down maintenance and administrative dollars for children served by the pilot project per the directive of the Federal Administration for Children and Families (ACF). NFC submitted a Cost Allocation Plan to DHHS on June 25, 2013. Subsequently, DHHS submitted this plan to ACF for review. ACF requested additional information on September 3, 2013, regarding the Cost Allocation Plan for NFC.

Below is a chart depicting the average number of children (out-of-home) and families (in-home) served by NFC.
