Nebraska Revised Statutes 81-827. Wildfire Control: Nebraska Emergency Management Agency; duties, states in part the Nebraska Emergency Management Agency shall prepare a report on or before December 1 of each year describing (a) the date and time each request to deploy a single-engine air tanker is made to the agency, (b) the date and time a single-engine was deployed in response to a request for such a tanker, (c) an explanation of the reason for any delay of more than one hour from the time of a request for deployment of a single-engine air tanker and the time of the actual deployment of such a tanker, and (d) an explanation of the reason for the denial of a request to deploy a single-engine air tanker.

I apologize for the delayed report as circumstances associated with the fall of 2013 state and Federal disaster declarations caused the agency to be remiss in meeting the deadline.

The following is the status/usage report of the single-engine air tanker in Nebraska for aerial fire suppression in the state and the related costs:
