A BILL

1 FOR AN ACT relating to handicapped parking; to amend sections
2 60-3,113.02 and 60-3,113.05, Revised Statutes Cumulative
3 Supplement, 2012; to change provisions relating to
4 permits for temporarily handicapped or disabled persons;
5 and to repeal the original sections.

6 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-3,113.02, Revised Statutes
2 Cumulative Supplement, 2012, is amended to read:

3 60-3,113.02 (1) This section applies beginning on the
4 implementation date designated by the director under section
5 60-3,113.01.

6 (2) A handicapped or disabled person or temporarily
7 handicapped or disabled person or his or her parent, legal guardian,
8 foster parent, or certifying health care provider may apply for a
9 handicapped or disabled parking permit to the department or through a
10 health care provider using a secure online process developed by the
11 department which will entitle the holder of a permit or a person
12 driving a motor vehicle for the purpose of transporting such holder
13 to park in those spaces or access aisles provided for by sections
14 18-1736 and 18-1737 when the holder of the permit will enter or exit
15 the motor vehicle while it is parked in such spaces or access aisles.
16 For purposes of this section, (a) the handicapped or disabled person
17 or temporarily handicapped or disabled person is considered the
18 holder of the permit and (b) certifying health care provider means
19 the physician, physician assistant, or advanced practice registered
20 nurse who makes the certification required in subsection (3) of this
21 section or his or her designee.

22 (3) The application process for a handicapped or disabled
23 parking permit or for the renewal of a permit under this section
24 shall include presentation of proof of identity by the handicapped or
25 disabled person or temporarily handicapped or disabled person and

1 certification by a physician, a physician assistant, or an advanced
2 practice registered nurse practicing under and in accordance with his
3 or her certification act that the person who will be the holder meets
4 the statutory criteria for qualification. An application for the
5 renewal of a permit under this section may be submitted within one
6 hundred eighty days prior to the expiration of the permit. No
7 applicant shall be required to provide his or her social security
8 number. In the case of a temporarily handicapped or disabled person,
9 the certifying physician, physician assistant, or advanced practice
10 registered nurse shall ~~indicate~~recommend that the permit for the
11 temporarily handicapped or disabled person be issued for either a
12 three-month period or a six-month period, with such recommendation to
13 be based on the estimated date of recovery, ~~or that the temporary~~
14 ~~handicap or disability will continue for a period of six months,~~
15 ~~whichever is less.~~

16 (4) The department, upon receipt of a completed
17 application for a handicapped or disabled parking permit under this
18 section, shall verify that the applicant qualifies for such permit
19 and, if so, shall deliver the permit to the applicant. In issuing
20 renewed permits, the department shall deliver each individual renewed
21 permit to the applicant. The renewed permit shall not be issued
22 sooner than ten days prior to the date of expiration, and the
23 existing permit shall be invalid upon receipt of the renewed permit.
24 A person may hold up to two permits under this section. If a person
25 holds a permit under this section, such person may not hold a permit

1 under section 60-3,113.03.

2 (5) In issuing any handicapped or disabled parking permit
3 under this section, the department shall include a notice and an
4 identification card. The notice shall contain information listing the
5 legal uses of the permit and that the permit is not transferable, is
6 to be used by the party to whom issued, is not to be altered or
7 reproduced, and is to be used only when a handicapped or disabled
8 person or a temporarily handicapped or disabled person will enter or
9 exit the motor vehicle while it is parked in a designated parking
10 space or access aisle. The notice shall also indicate that those
11 convicted of handicapped parking infractions shall be subject to
12 suspension of the permit for six months. The identification card
13 shall show the expiration date of the permit and such identifying
14 information with regard to the handicapped or disabled person or
15 temporarily handicapped or disabled person to whom the permit is
16 issued as is necessary to the enforcement of sections 18-1736 to
17 18-1741.07 as determined by the department.

19 Supplement, 2012, is amended to read:

20 60-3,113.05 (1) This section applies beginning on the
21 implementation date designated by the director under section
22 60-3,113.01.

23 (2) Permanently issued handicapped or disabled parking
24 permits issued prior to October 1, 2011, shall be valid for a period
25 ending on the last day of the month of the applicant's birthday in

1 the third year after issuance and shall expire on that day.
2 Permanently issued handicapped or disabled parking permits issued on
3 or after October 1, 2011, shall be valid for a period ending on the
4 last day of the month of the applicant's birthday in the sixth year
5 after issuance and shall expire on that day.

6 (3) All handicapped or disabled parking permits for
7 temporarily handicapped or disabled persons shall be issued for a
8 period ending ~~not more than either three months after the date of~~
9 issuance or six months after the date of issuance, with such period
10 to be based on the estimated date of recovery, but such permit may be
11 renewed one time for a similar three-month or six-month period. ~~not~~
12 ~~to exceed six months.~~ For the renewal period, there shall be
13 submitted an additional application with proof of a handicap or
14 disability.
