A BILL

1 FOR AN ACT relating to agriculture; to amend section 54-784.01,  
2 Reissue Revised Statutes of Nebraska; to change Animal  
3 Importation Act provisions relating to cattle  
4 identification; to harmonize provisions; and to repeal  
5 the original section.

6 Be it enacted by the people of the State of Nebraska,

1           Section 1. Section 54-784.01, Reissue Revised Statutes of  
2 Nebraska, is amended to read:

3           54-784.01 Sections 54-784.01 to 54-796 and section 2 of  
4 this act shall be known and may be cited as the Animal Importation  
5 Act.

6           Sec. 2. (1) Except as otherwise provided in this section,  
7 individual identification of cattle imported into Nebraska shall not  
8 be required if (a) the cattle are identified by a registered brand  
9 and accompanied by an official brand inspection certificate issued by  
10 the recognized brand inspection authority of the state of origin and  
11 (b) such cattle are imported directly from a mandatory brand  
12 inspection area of any state.

13           (2) The Department of Agriculture may require cattle  
14 imported into Nebraska to be identified by individual identification  
15 to enter the state if the Director of Agriculture determines that:

16           (a) The state of origin recognized brand registration or  
17 brand inspection procedures and documentation are insufficient to  
18 enable the tracing of individual animals to the animal's herd of  
19 origin;

20           (b) Identification by brand alone is in conflict with a  
21 standard of federal law or regulation regarding identification of  
22 cattle moved into Nebraska; or

23           (c) The cattle originate from a location that is not a  
24 tuberculosis accredited-free state or zone pursuant to 9 C.F.R. 77.7  
25 or is not designated a brucellosis Class Free or Class A state or

1 area pursuant to 9 C.F.R. 78.41, as such regulations existed on  
2 January 1, 2013.

3 (3) At no time shall a registered brand inspection  
4 certificate be used in lieu of a certificate of veterinary  
5 inspection.

6 (4) This section does not limit the authority of the  
7 State Veterinarian to issue import orders imposing additional  
8 requirements for animals imported into Nebraska from any state,  
9 country, zone, or other area, including requirements relating to  
10 identification.

11 (5) For purposes of this section:

12 (a) Individual identification means a device or method  
13 approved by the Department of Agriculture of uniquely identifying a  
14 specific animal to its herd of origin and is not synonymous with  
15 official identification; and

16 (b) Official identification means identifying an animal  
17 or group of animals using devices or methods approved by the  
18 Veterinary Services Office of the Animal and Plant Health Inspection  
19 Service of the United States Department of Agriculture, including,  
20 but not limited to, official tags, tattoos, and registered brands  
21 when accompanied by a certificate of inspection from a recognized  
22 brand inspection authority.
