A BILL

1 FOR AN ACT relating to agriculture; to amend sections 2-3965, 2-3966,
2 2-3971, 2-3975, 2-3976, 2-3977, 2-3981, 2-3982, 2-3986,
3 2-3988, and 2-3989, Reissue Revised Statutes of Nebraska;
4 to update and change provisions of the Nebraska Milk Act;
5 to repeal the original sections; and to declare an
6 emergency.

7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 2-3965, Reissue Revised Statutes of
2 Nebraska, is amended to read:

3 2-3965 (1) Sections 2-3965 to 2-3992 and section 9 of
4 this act and the publications adopted by reference in subsections (2)
5 and (3) of this section shall be known and may be cited as the
6 Nebraska Milk Act.

7 (2) The Legislature adopts by reference the following
8 official documents of the National Conference on Interstate Milk
9 Shipments as published by the United States Department of Health and
10 Human Services, United States Public Health Service/Food and Drug
11 Administration:

12 (a) Grade A Pasteurized Milk Ordinance, ~~2005—2011~~
13 Revision, as delineated in subsection (3) of this section;

14 (b) Methods of Making Sanitation Ratings of Milk
15 ~~Supplies, 2005—Shippers, 2011~~ Revision;

16 (c) Procedures Governing the Cooperative State-Public
17 Health Service/Food and Drug Administration Program of the National
18 Conference on Interstate Milk Shipments, ~~2005—2011~~ Revision; and

19 (d) Evaluation of Milk Laboratories, ~~2005—2011~~ Revision.

20 (3) All provisions of the Grade A Pasteurized Milk
21 Ordinance, ~~2005—2011~~ Revision, including footnotes relating to
22 requirements for cottage cheese, and the appendixes with which the
23 ordinance requires mandatory compliance are adopted with the
24 following exceptions:

25 (a) Section 9 of the ordinance is replaced by section

1 2-3969;

2 (b) Section 15 of the ordinance is replaced by section
3 2-3970;

4 (c) Section 16 of the ordinance is replaced by section
5 2-3974;

6 (d) Section 17 of the ordinance is not adopted; ~~and~~

7 (e) Section 3 of the ordinance, Administrative
8 Procedures, Issuance of Permits, is adopted with the following
9 modifications:

10 (i) The department may suspend a permit for a definite
11 period of time or place the holder of a permit on probation upon
12 evidence of violation by the holder of any of the provisions of the
13 Nebraska Milk Act; and

14 (ii) Decisions of the department may be appealed and such
15 appeals shall be in accordance with the Administrative Procedure Act;
16 and -

17 (f) Section 1 of the ordinance, Definitions, is adopted
18 except for paragraph W.

19 (4) Copies of the Ordinance, the Appendixes, and the
20 publications, adopted by reference, shall be filed in the offices of
21 the Secretary of State, Clerk of the Legislature, and Department of
22 Agriculture.

23 Sec. 2. Section 2-3966, Reissue Revised Statutes of
24 Nebraska, is amended to read:

25 2-3966 For purposes of the Nebraska Milk Act, unless the

1 context otherwise requires:

17 sections 2-3979 to 2-3982 as to sight and odor and that is classified
18 acceptable for somatic cells, bacterial content, drug residues, and

20 (3) Components of milk means whey, whey and milk protein
21 concentrate, whey cream, cream, butter, skim milk, condensed milk,
22 ultra-filtered milk, milk powder, dairy blends that are at least
23 fifty-one percent dairy components, and any similar milk ~~by product;~~
24 byproduct;

25 (4) C-I-P or cleaned-in-place means the procedure by

1 which sanitary pipelines or pieces of dairy equipment are
2 mechanically cleaned in place by circulation;

3 (5) Dairy products means products allowed to be made from
4 milk for manufacturing purposes and not required to be of Grade A
5 quality;

6 (6) Department means the Department of Agriculture;

7 (7) Director means the Director of Agriculture or his or
8 her duly authorized agent or designee;

9 (8) Field representative means an individual qualified
10 and trained in the sanitary methods of production and handling of
11 milk as set forth in the Nebraska Milk Act and who is generally
12 employed by a processing or manufacturing milk plant or cooperative
13 for the purpose of quality control work;

14 (9) First purchaser means a person who purchases raw milk
15 directly from the farm for processing or for resale to a processor,
16 who purchases milk products or components of milk for processing or
17 resale to a processor, or who utilizes milk from the first
18 purchaser's own farm for the manufacturing of milk products or dairy
19 products;

20 (10) Grade A Pasteurized Milk Ordinance means the
21 documents delineated in subsection (3) of section 2-3965;

22 ~~(9)~~ (11) Milk for manufacturing purposes means milk
23 produced for processing and manufacturing into products not required
24 by law to be of Grade A quality;

25 (12) Milk distributor means a person who distributes

1 milk, fluid milk, milk products, or dairy products whether or not the
 2 milk is shipped within or into the state. The term does not include a
 3 milk plant, a bulk milk hauler/sampler, or a milk producer, as such
 4 terms are defined in the Grade A Pasteurized Milk Ordinance, or a
 5 food establishment, as defined in the Nebraska Pure Food Act;

6 ~~(10)~~—(13) Probational milk means milk classified
 7 undergrade for somatic cells, bacterial content, or sediment content
 8 that may be accepted by plants for specific time periods; and

9 ~~(11)~~—(14) Reject milk means milk that does not qualify
 10 under sections 2-3979 to 2-3982.

10 August 1 thereafter a Milk Transportation Company shall pay twenty-
11 five dollars for each milk tank truck in service on July 1 of the
12 current year, but in no case shall the fee be less than one hundred
13 dollars.

14 ~~(9)(a) Beginning October 1, 2007, all~~ (2)(a) All milk or
15 components of milk produced or processed in Nebraska and milk or
16 components of milk shipped in for processing shall be subject to the
17 payment of inspection fees as provided in this subsection.

18 (b) There shall be three categories of inspection fees as
19 follows:

20 (i) The inspection fee for raw milk purchased directly
21 off the farm by first purchasers shall have a maximum inspection fee
22 of two and five-tenths cents per hundredweight for raw milk and shall
23 be paid by first purchasers;

24 (ii) The inspection fee for milk processed by a milk
25 plant shall be seventy-five percent of the fee paid by first

1 purchasers and shall be paid by the milk plant; and

2 (iii) The inspection fee for components of milk processed
3 shall be fifty percent of the fee paid by first purchasers and shall
4 be paid by the milk plant.

5 (c) All fees shall be paid on or before the ~~fifteenth~~
6 last day of the month for milk or components of milk produced or
7 processed during the preceding month. Any unpaid fee shall be
8 increased one and one-half percent each month beginning with the day
9 following the date the fee was due. Any remaining amount due,
10 including any unpaid charges previously made pursuant to this
11 section, shall be increased at the same rate on the corresponding day
12 of each succeeding month until paid. The purpose of increasing the
13 fees is to cover the administrative costs associated with collecting
14 fees, and all money collected as increased fees shall be remitted to
15 the State Treasurer for credit to the Pure Milk Cash Fund.

16 (d) The director may raise or lower the inspection fees
17 each year, but the fees shall not exceed the maximum fees set out in
18 subdivision (b) of this subsection. The director shall determine the
19 fees based on the estimated annual revenue and fiscal year-end fund
20 balance determined as follows:

21 (i) The estimated annual revenue shall not be greater
22 than one hundred seven percent of the program cash fund
23 appropriations allocated for the Nebraska Milk Act;

24 (ii) The estimated fiscal year-end cash fund balance
25 shall not be greater than seventeen percent of the program cash fund

1 appropriations allocated for the act; and

2 (iii) All fee increases or decreases shall be equally
3 distributed between categories to maintain the percentages set forth
4 in subdivision (b) of this subsection.

5 ~~(10)~~(3) If any person required to have a permit pursuant
6 to the act has been operating prior to applying for a permit, an
7 additional fee of one hundred dollars shall be paid upon application.

8 Sec. 4. Section 2-3975, Reissue Revised Statutes of
9 Nebraska, is amended to read:

10 2-3975 The director shall make and publish the results of
11 periodic surveys of milksheds to determine the degree of compliance
12 with the sanitary requirements for the production, processing,
13 handling, distribution, sampling, and hauling of milk and milk
14 products as provided in the Nebraska Milk Act. The director shall
15 have the power to adopt and promulgate reasonable rules and
16 regulations in accordance with the procedure defined in the
17 Administrative Procedure Act for the interpretation and enforcement
18 of this section. Such a survey or rating of a milkshed shall follow
19 the procedures prescribed by the United States Department of Health
20 and Human Services, United States Food and Drug Administration, in
21 its documents, as delineated in section 2-3965, entitled Methods of
22 Making Sanitation Ratings of Milk ~~Supplies, 2005 Revision, Shippers~~

2 Sec. 5. Section 2-3976, Reissue Revised Statutes of
3 Nebraska, is amended to read:

4 2-3976 All fees paid to the department in accordance with
5 the Nebraska Milk Act shall be remitted to the State Treasurer for
6 credit to the Pure Milk Cash Fund, which fund is hereby created. All
7 money credited to the fund shall be appropriated to the uses of the
8 department to aid in defraying the expenses of administering the act.
9 Any money in the fund available for investment shall be invested by
10 the state investment officer pursuant to the Nebraska Capital
11 Expansion Act and the Nebraska State Funds Investment Act. ~~Any money~~
12 ~~in the Manufacturing Milk Cash Fund on September 1, 2007, shall be~~
13 ~~transferred to the Pure Milk Cash Fund on such date.~~

14 Sec. 6. Section 2-3977, Reissue Revised Statutes of
15 Nebraska, is amended to read:

16 2-3977 (1) ~~Beginning August 1, 2008, milk~~ Milk plants or
17 any entity purchasing raw milk from producers holding a permit under
18 the Nebraska Milk Act may employ, contract with, or otherwise provide
19 for the services of a competent and qualified field representative
20 who may:

21 (a) Inform new producers about the requirements of dairy
22 farm sanitation and assist dairy producers with milk quality
23 problems;

24 (b) Collect and submit samples at the request of the
25 department; and

1 (c) Advise the department of any circumstances that could
2 be of public health significance.

3 (2) An applicant for a field representative permit shall
4 be trained in the sanitation practices for the sampling, care of
5 samples, and milk hauling requirements of the Nebraska Milk Act.
6 Prior to obtaining a field representative permit, the applicant shall
7 take and pass an examination approved by the department and shall pay
8 the permit fee set forth in section 2-3971. The permit shall expire
9 on July 31 of the year following issuance.

10 Sec. 7. Section 2-3981, Reissue Revised Statutes of
11 Nebraska, is amended to read:

12 2-3981 (1) All dairy plants using milk for manufacturing
13 purposes shall run the quality tests set out in this section in a
14 state-certified laboratory and report the results to the department
15 upon request. The test methods shall be those stated in laboratory
16 procedures.

17 (2) Milk for manufacturing purposes shall be classified
18 for bacterial content by the standard plate count or plate loop
19 count. Bacterial count limits of individual producer milk shall not
20 exceed five hundred thousand per milliliter.

21 (3) Bacterial counts for milk for manufacturing purposes
22 shall be run at least four times in six consecutive months at
23 irregular intervals at times designated by the director on
24 representative samples of each producer's milk. Whenever any two out
25 of four consecutive bacterial counts exceed five hundred thousand per

1 milliliter, the producer shall be sent a written notice by the
2 department. Such notice shall be in effect so long as two of the last
3 four consecutive samples exceed the limit of the standard set out in
4 ~~subdivision (1)~~ subsection (2) of this section. A producer sample
5 shall be taken between three and twenty-one days after the second
6 excessive count. If that sample indicates an excessive bacterial
7 count, the producer's milk shall be rejected until subsequent testing
8 indicates a bacterial count of five hundred thousand per milliliter
9 or less.

10 (4) All standards and procedures of the Grade A
11 Pasteurized Milk Ordinance, ~~2005 Revision~~, relating to somatic cells
12 shall apply to milk for manufacturing purposes.

13 (5) The industry shall test all producer's milk and bulk
14 milk pickup tankers for drug residues in accordance with Appendix N,
15 Drug Residue Testing and Farm Surveillance, of the Grade A
16 Pasteurized Milk Ordinance, ~~2005 Revision~~.

17 Sec. 8. Section 2-3982, Reissue Revised Statutes of
18 Nebraska, is amended to read:

19 2-3982 (1) Milk for manufacturing purposes shall be
20 classified for sediment content, regardless of the results of the
21 appearance and odor examination described in section 2-3980,
22 according to sediment standards as follows:

23 (a) No. 1: Acceptable, not to exceed fifty-hundredths
24 milligrams or its equivalent;

25 (b) No. 2: Acceptable, not to exceed one and fifty-

1 hundredths milligrams or its equivalent;

2 (c) No. 3: Probational, not over ten days, not to exceed
3 two and fifty-hundredths milligrams or its equivalent; and

4 (d) No. 4: Reject, over two and fifty-hundredths
5 milligrams or its equivalent.

6 (2) Methods for determining the sediment content of the
7 milk of individual producers shall be the methods described in 7
8 C.F.R. 58.134, as such section existed on July 1, ~~2006~~ 2011.

9 (3) Sediment testing shall be performed at least four
10 times every six months at irregular intervals as designated by the
11 director.

12 (4) If the sediment disc is classified as No. 1, No. 2,
13 or No. 3, the producer's milk may be accepted. If the sediment disc
14 is classified as No. 4, the milk shall be rejected. A producer's milk
15 that is classified as No. 3 may be accepted for a period not to
16 exceed ten calendar days. If at the end of ten days the producer's
17 milk does not meet acceptable sediment classification No. 1 or No. 2,
18 it shall be rejected from the market. If the sediment disc is
19 classified as No. 4, the milk shall be rejected and no further
20 shipments accepted unless the milk meets the requirements of No. 3 or
21 better.

22 Sec. 9. A facility producing milk for manufacturing
23 purposes in existence prior to July 1, 2013, which does not meet all
24 of the requirements of the Grade A Pasteurized Milk Ordinance shall
25 be acceptable for use only if it meets the requirements of sections

1 2-3983 to 2-3989. After July 1, 2013, all new facilities that produce
2 milk and facilities that produce milk that are under new ownership
3 shall be required to meet the requirements of the Grade A Pasteurized
4 Milk Ordinance.

5 Sec. 10. Section 2-3986, Reissue Revised Statutes of
6 Nebraska, is amended to read:

7 2-3986 Milk for manufacturing purposes in farm bulk tanks
8 shall be cooled to forty degrees Fahrenheit or lower within two hours
9 after milking and maintained at fifty degrees Fahrenheit or lower
10 until transferred to the transport tank. Milk offered for sale for
11 manufacturing purposes shall be in a farm bulk tank that meets all 3-
12 A ~~sanitary standards.~~ Sanitary Standards.

13 Sec. 11. Section 2-3988, Reissue Revised Statutes of
14 Nebraska, is amended to read:

15 2-3988 At a facility producing milk for manufacturing
16 purposes, utensils, milk cans, milking machines, including pipeline
17 systems, and other equipment used in the handling of milk shall be
18 maintained in good condition, shall be free from rust, open seams,
19 milkstone, or any unsanitary condition, and shall be washed, rinsed,
20 and drained after each milking, stored in suitable facilities, and
21 sanitized immediately before use. New or replacement can lids shall
22 be umbrella type. All new utensils, new farm bulk tanks, and
23 equipment shall meet 3-A ~~sanitary standards~~ Sanitary Standards and
24 comply with applicable rules and regulations of the department.
25 Equipment manufactured in conformity with 3-A Sanitary Standards

1 complies with the sanitary design and construction standards of the
2 Nebraska Milk Act.

3 Sec. 12. Section 2-3989, Reissue Revised Statutes of
4 Nebraska, is amended to read:

5 2-3989 The water supply at a facility producing milk for
6 manufacturing purposes shall be safe, clean, and ample for the
7 cleaning of dairy utensils and equipment. The water supply shall meet
8 the bacteriological standards established by the Department of Health
9 and Human Services at all times. Water samples shall be taken,
10 analyzed, and found to be in compliance with the requirements of the
11 Nebraska Milk Act prior to the issuance of a permit to the producer
12 and whenever any major change to the well or water source occurs.
13 Wells or water sources which do not meet the construction standards
14 of the Department of Health and Human Services shall be tested
15 annually, and wells or water sources which do meet the construction
16 standards of the Department of Health and Human Services shall be
17 tested every three years. Whenever major alterations or repairs occur
18 or a well or water source repeatedly recontaminates, the water supply
19 shall be unacceptable until such time as the construction standards
20 are met and an acceptable supply is demonstrated. ~~On and after~~
21 ~~October 1, 1989, all~~ All new producers issued permits under the
22 Nebraska Milk Act shall be required to meet the construction
23 standards established by the Department of Health and Human Services
24 for private water supplies.

25 Sec. 13. Original sections 2-3965, 2-3966, 2-3971,

1 2-3975, 2-3976, 2-3977, 2-3981, 2-3982, 2-3986, 2-3988, and 2-3989,
2 Reissue Revised Statutes of Nebraska, are repealed.

3 Sec. 14. Since an emergency exists, this act takes effect
4 when passed and approved according to law.
