A BILL

1 FOR AN ACT relating to cities of the first and second class; to amend
2 sections 16-313 and 17-111, Reissue Revised Statutes of
3 Nebraska; to change provisions relating to mayoral veto
4 power; to provide a time limit for issuance of a veto; to
5 provide duties; to provide certain line-item veto
6 authority; to harmonize provisions; and to repeal the
7 original sections.
8 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 16-313, Reissue Revised Statutes of
2 Nebraska, is amended to read:

3 16-313 The mayor shall have the power to approve or veto
4 any ordinance passed by the city council, and to approve or veto any
5 order, bylaw, resolution, award of or vote to enter into any
6 contract, or the allowance of any claim. If the mayor approves the
7 ordinance, order, bylaw, resolution, contract, or claim, he or she
8 shall sign it, and it shall become effective. If the mayor vetoes the
9 ordinance, order, bylaw, resolution, contract, or any item or items
10 of appropriations or claims, he or she shall return it to the city
11 council stating that the measure is vetoed. The mayor may issue the
12 veto at the meeting at which the measure passed or within seven
13 calendar days after the meeting. If the mayor issues the veto after
14 the meeting, the mayor shall notify the city clerk of the veto in
15 writing. The clerk shall notify the city council in writing of the
16 mayor's veto. Any ; ~~Provided, any ordinance, order, bylaw,~~
17 ~~resolution, award of or vote to enter into any contract, or the~~
18 ~~allowance of any claim vetoed by the mayor, may be passed over his or~~
19 ~~her veto by a vote of two-thirds of all the members elected to the~~
20 ~~council, notwithstanding his or her veto. If the mayor neglects or~~
21 ~~refuses to sign any ordinance, order, bylaw, resolution, award of or~~
22 ~~vote to enter into any contract, or the allowance of any claim, and~~
23 ~~returns the same with his objection in writing at the next regular~~
24 ~~meeting of the council, but fails to veto the measure within the time~~
25 required by this section, the same measure shall become a law

1 effective without his or her signature. The mayor may veto any item
2 or items of any appropriation bill, or any claims bill, and approve
3 the remainder thereof, and the item or items so vetoed may be passed
4 by the council over the veto as in other cases.

5 Sec. 2. Section 17-111, Reissue Revised Statutes of
6 Nebraska, is amended to read:

7 17-111 The mayor shall have power to veto or sign any
8 ordinance passed by the city council and to approve or veto any
9 order, bylaw, resolution, award of or vote to enter into any
10 contract, or the allowance of any claim. If the mayor approves the
11 ordinance, order, bylaw, resolution, contract, or claim, he or she
12 shall sign it, and it shall become effective. If the mayor vetoes the
13 ordinance, order, bylaw, resolution, contract, or any item or items
14 of appropriations or claims, he or she shall return it to the city
15 council stating that the measure is vetoed. The mayor may issue the
16 veto at the meeting at which the measure passed or within seven
17 calendar days after the meeting. If the mayor issues the veto after
18 the meeting, the mayor shall notify the city clerk of the veto in
19 writing. The clerk shall notify the city council in writing of the
20 mayor's veto. Any ; Provided, any ordinance, order, bylaw,
21 resolution, award of or vote to enter into any contract, or the
22 allowance of any claim vetoed by the mayor may be passed over his or
23 her veto by a vote of two-thirds of the members of the council. If
24 the mayor neglects or refuses to sign any ordinance, ~~and return the~~
25 ~~same with his objections in writing at the next regular meeting of~~

1 ~~the council, order, bylaw, resolution, award of or vote to enter into~~
2 ~~any contract, or the allowance of any claim, but fails to veto the~~
3 ~~measure within the time required by this section, the same measure~~
4 shall become a law effective without his or her signature. The mayor
5 may veto any item or items of any appropriation bill or any claims
6 bill, and approve the remainder thereof, and the item or items vetoed
7 may be passed by the council over the veto as in other cases.
