A BILL

1 FOR AN ACT relating to criminal procedure; to amend sections 29-4201
2 and 29-4206, Reissue Revised Statutes of Nebraska; to
3 authorize county court and district court acceptance of
4 certain written waivers and pleas; to provide a form; to
5 harmonize provisions; and to repeal the original
6 sections.

7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 29-4201, Reissue Revised Statutes of
2 Nebraska, is amended to read:

3 29-4201 It is the intent and purpose of sections 29-4201
4 to 29-4207 to authorize the usage of audiovisual court appearances
5 and certain ~~district court arraignments by writing~~ written waivers
6 and pleas in criminal proceedings consistent with the statutory and
7 constitutional rights guaranteed by the Constitution of the United
8 States and the Constitution of Nebraska.

9 Sec. 2. Section 29-4206, Reissue Revised Statutes of
10 Nebraska, is amended to read:

11 29-4206 (1) The county courts and district courts may
12 accept a written waiver of preliminary hearing and a written waiver
13 of arraignment and plea of not guilty from any defendant. The written
14 waivers shall only be accepted if the defendant is represented by
15 counsel. The ~~form~~ written waivers shall contain the necessary consent
16 and waiver of the right to a physical appearance and comply with
17 subsection (2) of this section, shall be signed by the defendant and
18 his or her counsel of record, ~~if any,~~ and shall be filed with the
19 clerk of the court.

20 (2) The written waivers authorized under subsection (1)
21 of this section shall be in substantially the following form:

15 appropriate; my right to confront accusers; to subpoena witnesses; to
16 remain silent; to counsel; to have this matter transferred to
17 juvenile court, if appropriate; and my right to be presumed innocent
18 until proven guilty beyond reasonable doubt. My attorney has also
19 advised me of the possible penalties for the violations with which I
20 am charged, and the possibility that I will be required to make
21 restitution for damages, if appropriate.

22 I understand that my attorney will notify me of all
23 appearance dates in this matter.
