1 FOR AN ACT relating to elections; to amend sections 10-703.01,  
2 23-1901.01, 32-209, 32-210, 32-405, 32-525, 32-542,  
3 32-543, 32-567, 32-608, 32-713, 32-714, 32-949.01,  
4 32-953, 32-956, 32-957, 32-1202, 79-406, 79-443, 79-451,

3 Be it enacted by the people of the State of Nebraska,

1                   Section 1. Section 10-703.01, Reissue Revised Statutes of  
2 Nebraska, is amended to read:

3                   10-703.01 In all special elections called for voting on  
4 the question of issuing bonds of the school district, the county  
5 clerk or election commissioner or, if the school district lies in  
6 more than one county, the county clerk or election commissioner in  
7 the county having the greatest number of electors entitled to vote on  
8 the question shall designate the polling places and appoint the  
9 election officials, who need not be the regular election officials,  
10 and otherwise conduct the election as provided under the Election Act  
11 except as otherwise specifically provided in this section. Any  
12 special election held under this section shall be subject to section  
13 32-405. The school district shall designate the form of ballot and  
14 reimburse the county clerk or election official for the expenses of  
15 conducting the election as provided in sections 32-1201 to 32-1208.  
16 The school district officers shall give notice of the election at  
17 least twenty days prior to the election and cause the sample ballot  
18 to be published in a newspaper of general circulation in the school  
19 district one time not more than ten days nor less than three days  
20 prior to the election, and no notice of the election shall be  
21 required to be given by the county clerk or election commissioner.  
22 The notice of election shall state where ballots for early voting may  
23 be obtained.

24                   The ballots shall be counted by the county clerk or  
25 election commissioner conducting the election and two disinterested

1 persons appointed by him or her. When the polls are closed, the  
2 receiving board shall deliver the ballots to the county clerk or  
3 election commissioner conducting the election who, with the two  
4 disinterested persons appointed by him or her, shall proceed to count  
5 the ballots.

6 Ballots for early voting shall be furnished to the county  
7 clerk or election commissioner and ready for distribution by the  
8 county clerk or election commissioner conducting the election not  
9 less than fifteen days prior to the election.

10 When a school district lies in more than one county, the  
11 county clerk or election commissioner in any other county containing  
12 part of such school district shall, upon request, certify its  
13 registration books for those precincts in which the school district  
14 is located to the county clerk or election commissioner conducting  
15 the election and shall immediately forward all requests for ballots  
16 for early voting to the county clerk or election commissioner charged  
17 with the issuing of such ballots. Not less than five days prior to  
18 the election, the school district officers shall certify to the  
19 county clerk or election commissioner conducting the election a list  
20 of all registered voters of the school district in any other county  
21 or counties qualified to vote on the bond issue.

22 All ballots cast at the election shall be counted by the  
23 same board. When all the ballots have been counted, the returns of  
24 such election shall be turned over to the school board or board of  
25 education of the district in which the election was held for the

1 purpose of making a canvass thereof.

2 The two disinterested persons appointed on the counting  
3 board shall receive wages at no less than the minimum rate set in  
4 section 48-1203 for each hour of service rendered.

6 Nebraska, is amended to read:

7 23-1901.01 (1) ~~Except as provided in subsection (2) of~~  
8 ~~this section, a county surveyor elected after November 1986~~ A person  
9 need not be a resident of the county when he or she files for  
10 election as county surveyor, but ~~a county surveyor shall reside in a~~  
11 ~~county for which he or she holds office.~~ if elected as county  
12 surveyor, such person shall reside in a county for which he or she  
13 holds office.

14 (2) ~~When there is no qualified surveyor within a county~~  
15 ~~who will accept the office of county surveyor,~~ In a county having a  
16 population of less than one hundred fifty thousand inhabitants in  
17 which the voters have voted against the election of a county surveyor  
18 pursuant to section 32-525 or in which no county surveyor has been  
19 elected and qualified, the county board of such county ~~may employ~~  
20 shall appoint a competent surveyor either on a full-time or part-time  
21 basis from any other county of the State of Nebraska to such office.  
22 In making such ~~employment,~~ appointment, the county board shall  
23 negotiate a contract with the surveyor, such contract ~~to specify the~~  
24 ~~terms and conditions of the appointment or employment,~~ including  
25 shall specify the responsibility of the appointee to carry out the

1 statutory duties of the office of county surveyor and shall specify

3 which compensation shall not be subject to section 33-116. A county  
4 surveyor ~~employed~~ appointed under this subsection shall serve the  
5 same term as that of an elected surveyor. and

6 (3) A person appointed to the office of county surveyor  
7 in any county shall not be required to reside in the county of  
8 employment. appointment.

12 act shall be known and may be cited as the Election Act.

13 Sec. 4. Section 32-209, Reissue Revised Statutes of  
14 Nebraska, is amended to read:

15 32-209 (1) The election commissioner in counties having a  
16 population of more than one hundred thousand inhabitants shall  
17 appoint a chief deputy election commissioner in the manner provided  
18 in section 32-210. The chief deputy election commissioner shall be a  
19 member of a different political party than the election commissioner,  
20 shall be a registered voter in the county and of the party he or she  
21 is to represent, and shall be a resident of such county for at least  
22 one year.

23 (2) The chief deputy election commissioner shall hold  
24 office until the term of the election commissioner expires.

25 (3) Before entering upon his or her duties, the chief

1 deputy election commissioner shall take and subscribe an oath in the  
2 form provided in section 11-101.01.

3 ~~(3)~~(4) The chief deputy election commissioner shall give  
4 bond to the State of Nebraska in the sum of five thousand dollars  
5 with security to be approved by the Governor conditioned on the  
6 faithful performance of the duties of such office.

8 perform duties assigned by the election commissioner. In the absence  
9 of the election commissioner, the chief deputy election commissioner  
10 shall perform all the duties of the election commissioner consistent

13 responsible for carrying out any directions properly made and given  
14 by the election commissioner prior to his or her absence.

17 32-210 The election commissioner in counties having a  
18 population of more than one hundred thousand inhabitants shall,  
19 within ten days after being appointed or being notified that a  
20 vacancy exists in the office of chief deputy election commissioner,  
21 notify by registered or certified mail the county chairperson of the  
22 political parties from which a chief deputy election commissioner may  
23 be appointed that an appointment needs to be made. The county  
24 chairperson of the political parties shall call a meeting of a  
25 committee comprised of the county chairperson, vice-chairperson,

1 secretary, and treasurer of the political parties within ten days  
2 after receiving the letter for the purpose of preparing a list of  
3 three or more candidates. The list shall be submitted to the election  
4 commissioner within five days after the meeting, and the election  
5 commissioner shall select a chief deputy election commissioner from  
6 the list of names of candidates submitted within ten days after  
7 receiving ~~the list. all lists. If a political party does not submit a~~  
8 list within the timeframes required by this section, the election  
9 commissioner shall select a chief deputy election commissioner from  
10 the lists received.

12 Nebraska, is amended to read:

13 32-405 Any special election under the Election Act shall  
14 be held on the first Tuesday following the second Monday of the  
15 selected month unless otherwise specifically provided. No special  
16 election shall be held under the Election Act in April, May, June,  
17 October, November, or December of an even-numbered year unless it is  
18 held in conjunction with the statewide primary or general election. A  
19 special election for a Class III, IV, or V school district which is  
20 located in whole or in part in a county in which a city of the  
21 primary or metropolitan class is located may be held in conjunction  
22 with the primary or general election for a city of the primary or  
23 metropolitan class which is governed by a home rule charter.

24 Sec. 7. Section 32-525, Reissue Revised Statutes of  
25 Nebraska, is amended to read:



1           32-525 (1) Except as provided in section 22-417 and  
2 except for counties which vote not to elect the county surveyor as  
3 provided in subsection (2) or (4) of this section, when there is a  
4 qualified surveyor within a county who will accept the office of  
5 county surveyor if elected, a county surveyor on either a full-time  
6 or part-time basis, as determined by the county board in accordance  
7 with section 23-1901, shall be elected in each county having a  
8 population of less than one hundred fifty thousand inhabitants at the  
9 statewide general election in 1990 and each four years thereafter.

10           (2)(a) Except as provided in section 22-417 and in  
11 subsection (3) of this section, in each county having a population of  
12 less than one hundred fifty thousand inhabitants, the question of  
13 electing a county surveyor in the county shall be submitted to the  
14 registered voters of the county at the statewide general election in  
15 2020. The form of submission upon the ballot shall be as follows: For  
16 election of county surveyor; Against election of county surveyor.

17           (b) If a majority of the votes cast on the question are  
18 against the election of a county surveyor in such county, the office  
19 of county surveyor shall cease as an elected office with the  
20 expiration of the term of the incumbent or shall remain as it exists  
21 if no elected official holds that office. In such counties, the  
22 office shall be filled as provided in subsection (2) of section  
23 23-1901.01.

24           (c) If a majority of the votes cast on the question are  
25 in favor of the election of a county surveyor, the office shall

1 continue to be elected as provided in subsection (1) of this section  
2 or, if no elected county surveyor is in office, a county surveyor  
3 shall be elected at the next statewide general election as provided  
4 in subsection (1) of this section.

5 (3) If a county having a population of less than one  
6 hundred fifty thousand inhabitants has an elected county surveyor in  
7 office on January 1, 2020, the county board may, prior to February 1,  
8 2020, following a public hearing, adopt a resolution to continue to  
9 elect the county surveyor for the county and not to submit the  
10 question pursuant to subsection (2) of this section.

11 (4)(a) Beginning in 2021, in each county having a  
12 population of less than one hundred fifty thousand inhabitants, the  
13 county board shall submit the question of electing a county surveyor  
14 in the county to the registered voters of the county at the next  
15 statewide general election if (i) the county board, by majority vote  
16 of all the members of the county board, adopts a resolution on or  
17 before September 1 prior to the next statewide general election to  
18 submit the question to the voters or (ii) a petition conforming to  
19 section 32-628 asking for the submission of the question to the  
20 voters is presented to the election commissioner or county clerk on  
21 or before September 1 prior to the next statewide general election  
22 signed by at least ten percent of the registered voters of the  
23 county. The election commissioner or county clerk shall verify the  
24 signatures pursuant to section 32-631 and place the question on the  
25 ballot if he or she determines that at least ten percent of the

2 (b) The form of submission upon the ballot shall be as  
3 follows: For election of county surveyor; Against election of county  
4 surveyor.

5 (c) If a majority of the votes cast on the question are  
6 against the election of a county surveyor in such county, the office  
7 of county surveyor shall cease as an elected office with the  
8 expiration of the term of the incumbent or shall remain as it exists  
9 if no elected official holds that office. In such counties, the  
10 office shall be filled as provided in subsection (2) of section  
11 23-1901.01.

12 (d) If a majority of the votes cast on the question are  
13 in favor of the election of a county surveyor, the office shall  
14 continue to be elected as provided in subsection (1) of this section  
15 or, if no elected county surveyor is in office, a county surveyor  
16 shall be elected at the next statewide general election as provided  
17 in subsection (1) of this section.

18 (5) The term of the county surveyor shall be four years  
19 or until his or her successor is elected and qualified. The county  
20 surveyor shall meet the qualifications found in sections 23-1901 and  
21 23-1901.01. The county surveyor shall be elected on the partisan  
22 ballot.

23 Sec. 8. Section 32-542, Reissue Revised Statutes of  
24 Nebraska, is amended to read:

25 ~~32-542 Three school board members shall be elected for~~

1 ~~each Class II school district at each statewide general election,~~  
2 ~~except that when~~ (1) Members of the school board of a Class II school  
3 district shall be elected at the statewide general election. The  
4 school board of a Class II school district shall have no fewer than  
5 five members and no more than nine members as provided in section  
6 79-550. The number of members to be elected at the statewide general  
7 election and the terms for which they will be elected shall be  
8 determined by the election commissioner or county clerk with the aid  
9 of the secretary of the school board. Terms shall be staggered so  
10 that approximately one-half of the members are elected to each board  
11 at each general election for terms of four years. When it becomes  
12 necessary to establish the staggering of terms by electing at-large  
13 members for terms of different duration at the same election,  
14 candidates receiving the greatest number of votes shall be elected  
15 for the longest terms. When a Class II school district is created by

18 school board shall be elected at the next statewide general election

22 elected for terms of two years.

23 (2) Each member's term of office shall begin on the date  
24 of the first regular meeting of the board in January following the  
25 statewide general election at which he or she is elected and, except

1 as otherwise provided in this section, shall continue for four years  
2 or until the member's successor is elected and qualified. ~~The term of~~  
3 ~~a board member holding office on January 1, 1997, which term would~~  
4 ~~otherwise expire before the first regular meeting of the board in~~  
5 ~~January following the statewide general election, shall be extended~~  
6 ~~to the first regular meeting of the board in January following the~~

13 section 79-549 for a Class III school district, the board of  
14 education shall consist of six members to be elected by the  
15 registered voters of the school district at the statewide primary  
16 election. Two members shall be elected at each election for a term of  
17 six years. The members shall meet the qualifications found in section  
18 79-543.

19           (2) Except as provided in subsection (1) of this section,  
20 members of the board of education of a Class III school district  
21 shall be nominated at the statewide primary election and elected at  
22 the statewide general election. The board of education of a Class III  
23 school district shall have ~~six or no fewer than five members and no~~  
24 more than nine members as provided in section 79-549 or 79-550, and  
25 the members shall be nominated and elected at large or by district or

1 ward as provided in section 32-554 or nominated by district or ward  
2 and elected at large as provided in section 79-550. The number of  
3 members to be nominated at the statewide primary election and elected  
4 at the statewide general election and the terms for which they will  
5 be nominated and elected shall be determined by the election

20 32-567 Vacancies in office shall be filled as follows:

21 (1) In state and judicial district offices and in the  
22 membership of any board or commission created by the state when no  
23 other method is provided, by the Governor;

24 (2) In county offices, by the county board;

25 (3) In the membership of the county board, by the county

1 clerk, county attorney, and county treasurer;

2 (4) In the membership of the city council, according to  
3 section 32-568 or 32-569, as applicable;

4 ~~(4)-(5)~~ In township offices, by the township board or, if  
5 there are two or more vacancies on the township board, by the county  
6 board;

7 ~~(5)-(6)~~ In offices in public power and irrigation  
8 districts, according to section 70-615;

2 Unless otherwise provided by law, all vacancies shall be  
3 filled within forty-five days after the vacancy occurs unless good  
4 cause is shown that the requirement imposes an undue burden.

5 Sec. 11. The second half of a term of office for a member  
6 of the Legislature starts on the day of the meeting of the  
7 Legislature at which members are regularly sworn in to office in the  
8 second calendar year which begins after the four-year term begins.

9 Sec. 12. Section 32-608, Reissue Revised Statutes of  
10 Nebraska, is amended to read:

11 32-608 (1) Except as provided in subsection (4) or (5) of  
12 this section, a filing fee shall be paid by or on behalf of each  
13 candidate prior to filing for office. For candidates who file in the  
14 office of the Secretary of State as provided in subdivision (1) of  
15 section 32-607, the filing fee shall be paid to the Secretary of  
16 State who shall remit the fee to the State Treasurer for credit to  
17 the Election Administration Fund. For candidates for any city or  
18 village office, the filing fee shall be paid to the city or village  
19 treasurer of the city or village in which the candidate resides. For  
20 candidates who file in the office of the election commissioner or  
21 county clerk, the filing fee shall be paid to the election  
22 commissioner or county clerk in the county in which the office is  
23 sought. The election commissioner or county clerk shall remit the fee  
24 to the county treasurer. The fee shall be placed in the general fund  
25 of the county, city, or village. No candidate filing forms shall be



1 filed until the proper payment or the proper receipt showing the  
2 payment of such filing fee is presented to the filing officer. On the  
3 day of the filing deadline, the city or village treasurer's office  
4 shall remain open to receive filing fees until the hour of the filing  
5 deadline.

6 (2) Except as provided in subsection (4) or (5) of this  
7 section, the filing fees shall be as follows:

8 (a) For the office of United States Senator, state  
9 officers, including members of the Legislature, Representatives in  
10 Congress, county officers, and city or village officers, except the  
11 mayor or council members of cities having a home rule charter, a sum  
12 equal to one percent of the annual salary ~~such candidate will receive~~  
13 ~~if he or she is elected and qualifies as of November 30 of the year~~  
14 preceding the election for the office for which he or she files as a  
15 candidate;

16 (b) For directors of public power and irrigation  
17 districts in districts receiving annual gross revenue of forty  
18 million dollars or more, twenty-five dollars, and in districts  
19 receiving annual gross revenue of less than forty million dollars,  
20 ten dollars;

21 (c) For directors of reclamation districts, ten dollars;  
22 and

23 (d) For Regents of the University of Nebraska, members of  
24 the State Board of Education, and directors of metropolitan utilities  
25 districts, twenty-five dollars.

1           (3) All declared write-in candidates shall pay the filing  
2 fees that are required for the office at the time that they present  
3 the write-in affidavit to the filing officer. Any undeclared write-in  
4 candidate who is nominated or elected by write-in votes shall pay the  
5 filing fee required for the office within ten days after the canvass  
6 of votes by the county canvassing board and shall file the receipt  
7 with the person issuing the certificate of nomination or the  
8 certificate of election prior to the certificate being issued.

9           (4) No filing fee shall be required for any candidate  
10 filing for an office in which a per diem is paid rather than a salary  
11 or for which there is a salary of less than five hundred dollars per  
12 year. No filing fee shall be required for any candidate for  
13 membership on a school board, on the board of an educational service  
14 unit, on the board of governors of a community college area, on the  
15 board of directors of a natural resources district, or on the board  
16 of trustees of a sanitary and improvement district.

17           (5) No filing fee shall be required of any candidate  
18 completing an affidavit requesting to file for elective office in  
19 forma pauperis. A pauper shall mean a person whose income and other  
20 resources for maintenance are found under assistance standards to be  
21 insufficient for meeting the cost of his or her requirements and  
22 whose reserve of cash or other available resources does not exceed  
23 the maximum available resources that an eligible individual may own.  
24 Available resources shall include every type of property or interest  
25 in property that an individual owns and may convert into cash except:

1                   (a) Real property used as a home;  
2                   (b) Household goods of a moderate value used in the home;  
3                   and

4                   (c) Assets to a maximum value of three thousand dollars  
5                   used by a recipient in a planned effort directed towards self-  
6                   support.

7                   (6) If any candidate dies prior to an election, the  
8                   spouse of the candidate may file a claim for refund of the filing fee  
9                   with the proper governing body prior to the date of the election.  
10                  Upon approval of the claim by the proper governing body, the filing  
11                  fee shall be refunded.

12                  Sec. 13. Section 32-616, Revised Statutes Cumulative  
13                  Supplement, 2012, is amended to read:

14                  32-616 (1) Any registered voter who was not a candidate  
15                  in the primary election and who was not registered to vote with a  
16                  party affiliation on or ~~before~~after March 1 and before the general  
17                  election in the calendar year of the general election may have his or  
18                  her name placed on the general election ballot for a partisan office  
19                  by filing petitions as prescribed in sections 32-617 to 32-621 or by  
20                  nomination by political party convention or committee pursuant to  
21                  section 32-627 or 32-710.

22                  (2) Any candidate who was defeated in the primary  
23                  election and any registered voter who was not a candidate in the  
24                  primary election may have his or her name placed on the general  
25                  election ballot if a vacancy exists on the ballot under subsection

1 (2) of section 32-625 and the candidate files for the office by  
2 petition as prescribed in sections 32-617 and 32-618, files as a  
3 write-in candidate as prescribed in section 32-615, or is nominated

7 Nebraska, is amended to read:

8 32-713 (1) The certificates of appointment for  
9 presidential electors shall be served by the Governor on each person  
10 appointed. The Governor shall notify the presidential electors to be  
11 at the State Capitol at noon on the first Monday after the second  
12 Wednesday in December after appointment and report to the Governor at  
13 his or her office in the capitol as being in attendance. The Governor  
14 shall serve the certificates of appointment by registered or  
15 certified mail. In submitting this state's certificate of  
16 ascertainment as required by 3 U.S.C. 6, the Governor shall certify  
17 this state's presidential electors and state in the certificate that:

18 (a) The presidential electors will serve as presidential  
19 electors unless a vacancy occurs in the office of presidential  
20 elector before the end of the meeting at which the presidential  
21 electors cast their votes, in which case a substitute presidential  
22 elector will fill the vacancy; and

23 (b) If a substitute presidential elector is appointed to  
24 fill a vacancy, the Governor will submit an amended certificate of
