A BILL

1 FOR AN ACT relating to the Concealed Handgun Permit Act; to amend  
2 section 69-2430, Reissue Revised Statutes of Nebraska; to  
3 provide for an expedited permit process as prescribed for  
4 victims of domestic violence; and to repeal the original  
5 section.  
6 Be it enacted by the people of the State of Nebraska,

1                   Section 1. Section 69-2430, Reissue Revised Statutes of  
2 Nebraska, is amended to read:

3                   69-2430 (1) Application for a permit to carry a concealed  
4 handgun shall be made in person at any Nebraska State Patrol Troop  
5 Headquarters or office provided by the patrol for purposes of  
6 accepting such an application except as provided in subsection (4) of  
7 this section. The applicant shall present a current Nebraska motor  
8 vehicle operator's license, Nebraska-issued state identification  
9 card, or military identification card and shall submit two legible  
10 sets of fingerprints for a criminal history record information check  
11 pursuant to section 69-2431. The application shall be made on a form  
12 prescribed by the Superintendent of Law Enforcement and Public  
13 Safety. The application shall state the applicant's full name, motor  
14 vehicle operator's license number or state identification card  
15 number, address, and date of birth and contain the applicant's  
16 signature and shall include space for the applicant to affirm that he  
17 or she meets each and every one of the requirements set forth in  
18 section 69-2433. The applicant shall attach to the application proof  
19 of training and proof of vision as required in subdivision (3) of  
20 section 69-2433.

21                   (2) A person applying for a permit to carry a concealed  
22 handgun who gives false information or offers false evidence of his  
23 or her identity is guilty of a Class IV felony.

24                   ~~(3)(a) Until January 1, 2010, the permit to carry a~~  
25 ~~concealed handgun shall be issued by the Nebraska State Patrol within~~

1 ~~five business days after completion of the applicant's criminal~~  
2 ~~history record information check, if the applicant has complied with~~  
3 ~~this section and has met all the requirements of section 69-2433.~~

4 ~~(b) Beginning January 1, 2010, (3) Except as provided in~~  
5 ~~subsection (4) of this section, the permit to carry a concealed~~  
6 ~~handgun shall be issued by the Nebraska State Patrol within forty-~~  
7 ~~five days after the date an application for the permit has been made~~  
8 ~~by the applicant if the applicant has complied with this section and~~  
9 ~~has met all the requirements of section 69-2433.~~

10 ~~(4) Application may be made on an expedited basis, upon~~  
11 ~~the recommendation of a peace officer, for any applicant who is a~~  
12 ~~victim of a misdemeanor crime of domestic violence as that term is~~  
13 ~~defined in section 28-1206. In such a case, application may be made~~  
14 ~~by the applicant in person at the sheriff's office of the county in~~  
15 ~~which such person resides or at the police department of the city or~~  
16 ~~village in which such person resides and the Nebraska State Patrol~~  
17 ~~shall issue the permit to carry a concealed handgun within five days~~  
18 ~~after the date an application for the permit has been made by the~~  
19 ~~applicant if the applicant has complied with this section and has met~~  
20 ~~all the requirements of section 69-2433.~~

21 ~~(4)-(5) An applicant denied a permit to carry a concealed~~  
22 ~~handgun may appeal to the district court of the judicial district of~~  
23 ~~the county in which he or she resides or the county in which he or~~  
24 ~~she applied for the permit pursuant to the Administrative Procedure~~  
25 ~~Act.~~
