17 The unexpended General Fund appropriation balance existing on June
18 30, 2015, is hereby reappropriated.

19 Included in the salary limitations provided by this section is
20 \$3,672,087 for FY2015-16 and \$3,672,087 for FY2016-17 for Revolving Fund
21 salaries for program classifications 390 and 563, that shall not be
22 limited to the amounts shown.

23 The Department of Administrative Services shall monitor the
24 appropriations and expenditures for this program according to the
25 following program classifications:

14 Revolving Fund expenditures shall not be limited to the amounts
15 shown.

16 It is the intent of the Legislature that the Department of
17 Correctional Services investigate the feasibility of leasing the former
18 Lancaster County jail facility located in Air Park and owned by the
19 Airport Authority of the City of Lincoln, Nebraska, and consider making
20 this facility a community corrections facility instead of a minimum-
21 security facility. The department shall issue a report to the
22 Appropriations Committee of the Legislature electronically on this
23 subject by January 1, 2016.

24 It is the intent of the Legislature that the Department of
25 Correctional Services reduce mandatory overtime at the department's
26 facilities. The department shall examine reducing mandatory overtime by
27 studying its pay structure, including, but not limited to, adopting a pay
28 structure that allows employees to advance through the pay line, adopting
29 a step plan or a similar-type plan, or by adopting another method that
30 gives incentives for employees to remain employed by the department. The
31 department may conduct a salary survey to see if the department's

1 salaries are competitive with other entities which it competes with for
2 employees. The department shall issue a report to the Appropriations
3 Committee of the Legislature electronically on this subject by January 1,
4 2016.

5 It is the intent of the Legislature that the Department of
6 Correctional Services implement a needs assessment regarding behavioral
7 and mental health treatment and staffing. The needs assessment shall be
8 completed by appropriately trained mental health professionals. The
9 assessment shall include:

- 10 (1) Review and summary of relevant existing data sources;
- 11 (2) A detailed review of need factors in the Department of
12 Correctional Services population including risk behaviors, mental health
13 needs, behavioral health needs, and diagnosis;
- 14 (3) A detailed review of existing treatment and analysis of the
15 adequacy of that treatment based on:
 - 16 (a) Professional standards of care;
 - 17 (b) Best practices;
 - 18 (c) Availability of programming aligned with mental health needs and
19 diagnosis (using valid instrumentation); and
 - 20 (d) Availability in different facilities and levels of custody; and
- 21 (4) Analysis of needs, based on data gathered regarding:
 - 22 (a) Staffing needs to meet professional standards of care;
 - 23 (b) Needs related to developing new or different treatment based on
24 needs analysis; and
 - 25 (c) Needs related to achieving an appropriate level of service that
26 meets the goals of institutional and community safety and community
27 integration.

28 The department shall issue a report to the Appropriations Committee
29 of the Legislature electronically on this subject by January 1, 2016.

30 There is included in the appropriation to this program for FY2015-16
31 \$5,000,000 General Funds, which shall only be used to contract with

1 county jail facilities to house Department of Correctional Services
2 facilities inmates on a temporary basis. If the department estimates that
3 the need to contract with county jail facilities to house department
4 facilities inmates still exists in FY2016-17, the department may request
5 General Funds for this purpose. It is the intent of the Legislature that
6 no further funding be provided after FY2016-17 to contract with county
7 jail facilities to house Department of Correctional Services facilities
8 inmates.

9 It is intended that the Department of Correctional Services shall
10 maintain a Department Contingency Fund and a Department Equipment Fund.
