3 Section 1. Section 8-716, Reissue Revised Statutes of Nebraska, is
4 amended to read:

5 8-716 No institution incorporated under the laws of this state which
6 is or becomes a member of a Federal Home Loan Bank shall be exempt from
7 any taxes of this state, including any contributions required to be paid
8 under sections 48-648 to 48-654 and sections 63 to 66 of this act.

9 Sec. 2. Section 25-1912, Reissue Revised Statutes of Nebraska, is
10 amended to read:

11 25-1912 (1) The proceedings to obtain a reversal, vacation, or
12 modification of judgments and decrees rendered or final orders made by
13 the district court, including judgments and sentences upon convictions
14 for felonies and misdemeanors, shall be by filing in the office of the
15 clerk of the district court in which such judgment, decree, or final
16 order was rendered, within thirty days after the entry of such judgment,
17 decree, or final order, a notice of intention to prosecute such appeal
18 signed by the appellant or appellants or his, her, or their attorney of
19 record and, except as otherwise provided in sections 25-2301 to 25-2310
20 and ~~7~~ 29-2306~~7~~ and subsection (4) of section 48-638 ~~48-641~~, by depositing
21 with the clerk of the district court the docket fee required by section
22 33-103.

23 (2) A notice of appeal or docket fee filed or deposited after the
24 announcement of a decision or final order but before the entry of the
25 judgment, decree, or final order shall be treated as filed or deposited
26 after the entry of the judgment, decree, or final order and on the date
27 of entry.

1 (3) The running of the time for filing a notice of appeal shall be
2 terminated as to all parties (a) by a timely motion for a new trial under
3 section 25-1144.01, (b) by a timely motion to alter or amend a judgment
4 under section 25-1329, or (c) by a timely motion to set aside the verdict
5 or judgment under section 25-1315.02, and the full time for appeal fixed
6 in subsection (1) of this section commences to run from the entry of the
7 order ruling upon the motion filed pursuant to subdivision (a), (b), or
8 (c) of this subsection. When any motion terminating the time for filing a
9 notice of appeal is timely filed by any party, a notice of appeal filed
10 before the court announces its decision upon the terminating motion shall
11 have no effect, whether filed before or after the timely filing of the
12 terminating motion. A new notice of appeal shall be filed within the
13 prescribed time after the entry of the order ruling on the motion. No
14 additional fees are required for such filing. A notice of appeal filed
15 after the court announces its decision or order on the terminating motion
16 but before the entry of the order is treated as filed on the date of and
17 after the entry of the order.

18 (4) Except as otherwise provided in subsection (3) of this section,

25 notice of appeal and the depositing of such docket fee shall be deemed

1 the Supreme Court a transcript certified as a true copy of the
2 proceedings contained therein. The Supreme Court shall, by rule, specify
3 the method of ordering the transcript and the form and content of the
4 transcript. Neither the form nor substance of such transcript shall
5 affect the jurisdiction of the Court of Appeals or Supreme Court.

12 amended to read:

13 48-301 For purposes of sections 48-302 to 48-313:

14 (1) Employment means (a) service for wages or (b) being under a
15 contract of hire, written or oral, express or implied. Employment, other
16 than detasseling, does not include any employment for which the employer
17 is not liable for payment of the combined tax or payment in lieu of
18 contributions under section 48-648 or, 48-649, or 48-660.01 or section
19 48-649 and sections 63 to 66 of this act; and

20 (2) Detasseling means the removal of weeds, off-type and rogue
21 plants, and corn tassels in hand pollinating and in any other engagement
22 in hand labor in the production of seed.

23 Sec. 4. Section 48-601, Revised Statutes Cumulative Supplement,
24 2014, is amended to read:

25 48-601 Sections 48-601 to 48-683 and sections 28, 30 to 46, and 63
26 to 66 of this act shall be known and may be cited as the Employment
27 Security Law.

28 Sec. 5. Section 48-602, Revised Statutes Supplement, 2015, is
29 amended to read:

30 48-602 For purposes of the Employment Security Law, unless the
31 context otherwise requires:

1 (1) Base period means the first four of the last five completed
2 calendar quarters immediately preceding the first day of an individual's
3 benefit year, except that if the individual is not monetarily eligible
4 for unemployment benefits as determined pursuant to section 28 of this
5 act subdivision (5) of section 48-627 based upon wages paid during the
6 first four of the five most recently completed calendar quarters, the
7 department shall make a redetermination of monetary eligibility based
8 upon an alternative base period which consists of the last four completed
9 calendar quarters immediately preceding the first day of the claimant's
10 benefit year;

11 (2) Benefits means the money payments payable to an individual with
12 respect to his or her unemployment;

13 (3) Benefit year, with respect to any individual, means the one-year
14 period beginning with the first day of the first week with respect to
15 which the individual first files a valid claim for benefits, and
16 thereafter the one-year period beginning with the first day of the first
17 week with respect to which the individual next files a valid claim for
18 benefits after the termination of his or her last preceding benefit year.
19 Any claim for benefits made in accordance with section 48-629 shall be
20 deemed to be a valid claim for the purpose of this subdivision if the
21 individual has been paid the wages for insured work required under
22 section 28 of this act 48-627. For the purposes of this subdivision a
23 week with respect to which an individual files a valid claim shall be
24 deemed to be in, within, or during that benefit year which includes the
25 greater part of such week;

26 (4) Calendar quarter means the period of three consecutive calendar
27 months ending on March 31, June 30, September 30, or December 31, or the
28 equivalent thereof as the Commissioner of Labor may by rule and
29 regulation prescribe;

30 (5) Client means any individual, partnership, limited liability
31 company, corporation, or other legally recognized entity that contracts

1 with a professional employer organization to obtain professional employer
2 services relating to worksite employees through a professional employer
3 agreement;

4 (6) Combined tax means the employer liability consisting of
5 contributions and the state unemployment insurance tax;

6 (7) Combined tax rate means the rate which is applied to wages to
7 determine the combined taxes due;

8 (8) Commissioner means the Commissioner of Labor;

9 (9) Contribution rate means the percentage of the combined tax rate
10 used to determine the contribution portion of the combined tax;

11 (10) Contributions means that portion of the combined tax based upon
12 the contribution rate portion of the combined tax rate which is deposited
13 in the state Unemployment Compensation Fund as required by sections
14 48-648 and 48-649 and sections 63 to 66 of this act;

15 (11) Department means the Department of Labor;

16 (12) Employment office means a free public employment office or
17 branch thereof, operated by this state or maintained as a part of a
18 state-controlled system of public employment offices, including public
19 employment offices operated by an agency of a foreign government;

20 (13) Fund means the Unemployment Compensation Fund established by
21 section 48-617 to which all contributions and payments in lieu of
22 contributions required and from which all benefits provided shall be
23 paid;

24 (14) Hospital means an institution which has been licensed,
25 certified, or approved by the Department of Health and Human Services as
26 a hospital;

27 (15) Institution of higher education means an institution which: (a)
28 Admits as regular students only individuals having a certificate of
29 graduation from a high school or the recognized equivalent of such a
30 certificate; (b) is legally authorized in this state to provide a program
31 of education beyond high school; (c) provides an educational program for

1 which it awards a bachelor's degree or higher or provides a program which
2 is acceptable for full credit toward such a degree, a program of
3 postgraduate or postdoctoral studies, or a program of training to prepare
4 students for gainful employment in a recognized occupation; and (d) is a
5 public or other nonprofit institution; notwithstanding any of the
6 foregoing provisions of this subdivision, all colleges and universities
7 in this state are institutions of higher education for purposes of this
8 section;

9 (16) Insured work means employment for employers;

10 (17) Leave of absence means any absence from work: (a) Mutually and
11 voluntarily agreed to by the employer and the employee; (b) mutually and
12 voluntarily agreed to between the employer and the employee's bargaining
13 agent; or (c) to which the employee is entitled to as a matter of state
14 or federal law;

15 (18) Paid vacation leave means a period of time while employed or
16 following separation from employment in which the individual renders no
17 services to the employer but is entitled to receive vacation pay equal to
18 or exceeding his or her base weekly wage;

19 (19) Payments in lieu of contributions means the money payments to
20 the Unemployment Compensation Fund required by sections ~~48-649~~, 48-652,
21 48-660.01, and 48-661 and section 66 of this act;

22 (20) Professional employer agreement means a written professional
23 employer services contract whereby:

24 (a) A professional employer organization agrees to provide payroll
25 services, employee benefit administration, or personnel services for a
26 majority of the employees providing services to the client at a client
27 worksite;

28 (b) The agreement is intended to be ongoing rather than temporary in
29 nature; and

30 (c) Employer responsibilities for worksite employees, including
31 those of hiring, firing, and disciplining, are shared between the

1 professional employer organization and the client by contract. The term
2 professional employer agreement shall not include a contract between a
3 parent corporation, company, or other entity and a wholly owned
4 subsidiary;

5 (21) Professional employer organization means any individual,
6 partnership, limited liability company, corporation, or other legally
7 recognized entity that enters into a professional employer agreement with
8 a client or clients for a majority of a client's workforce at a client
9 worksite. The term professional employer organization does not include an
10 insurer as defined in section 44-103 or a temporary help firm;

11 (22) State includes, in addition to the states of the United States
12 of America, any dependency of the United States, the Commonwealth of
13 Puerto Rico, the Virgin Islands, and the District of Columbia;

14 (23) State unemployment insurance tax means that portion of the
15 combined tax which is based upon the state unemployment insurance tax
16 rate portion of the combined tax rate and which is deposited in the State
17 Unemployment Insurance Trust Fund as required by sections 48-648 and
18 48-649 and sections 63 to 66 of this act;

19 (24) State unemployment insurance tax rate means the percentage of
20 the combined tax rate used to determine the state unemployment insurance
21 tax portion of the combined tax;

22 (25) Temporary employee means an employee of a temporary help firm
23 assigned to work for the clients of such temporary help firm;

24 (26) Temporary help firm means a firm that hires its own employees
25 and assigns them to clients to support or supplement the client's
26 workforce ~~work force~~ in work situations such as employee absences,
27 temporary skill shortages, seasonal workloads, and special assignments
28 and projects;

29 (27) Unemployed means an individual during any week in which the
30 individual performs no service and with respect to which no wages are
31 payable to the individual or any week of less than full-time work if the

1 wages payable with respect to such week are less than the individual's
2 weekly benefit amount, but does not include any individual on a leave of
3 absence or on paid vacation leave. When an agreement between the employer
4 and a bargaining unit representative does not allocate vacation pay
5 allowance or pay in lieu of vacation to a specified period of time during
6 a period of temporary layoff or plant shutdown, the payment by the
7 employer or his or her designated representative will be deemed to be
8 wages as defined in this section in the week or weeks the vacation is
9 actually taken;

10 (28) Unemployment Trust Fund means the trust fund in the Treasury of
11 the United States of America established under section 904 of the federal
12 Social Security Act, 42 U.S.C. 1104, as such section existed on January
13 1, 2015, which receives credit from the state Unemployment Compensation
14 Fund;

15 (29) Wages, except with respect to services performed in employment
16 as provided in subdivisions (4)(c) and (d) of section 48-604, means all
17 remuneration for personal services, including commissions and bonuses,
18 remuneration for personal services paid under a contract of hire, and the
19 cash value of all remunerations in any medium other than cash. The
20 reasonable cash value of remuneration in any medium other than cash shall
21 be estimated and determined in accordance with rules and regulations
22 adopted and promulgated ~~prescribed~~ by the commissioner. Wages includes
23 tips which are received while performing services which constitute
24 employment and which are included in a written statement furnished to the
25 employer pursuant to section 6053(a) of the Internal Revenue Code as
26 defined in section 49-801.01.

27 With respect to services performed in employment in agricultural
28 labor as is provided in subdivision (4)(c) of section 48-604, wages means
29 cash remuneration and the cash value of commodities not intended for
30 personal consumption by the worker and his or her immediate family for
31 such services. With respect to services performed in employment in

1 domestic service as is provided in subdivision (4)(d) of section 48-604,
2 wages means cash remuneration for such services.

3 The term wages does not include:

4 (a) The amount of any payment, including any amount paid by an
5 employer for insurance or annuities or into a fund to provide for such
6 payment, made to, or on behalf of, an individual in employment or any of
7 his or her dependents under a plan or system established by an employer
8 which makes provision for such individuals generally or for a class or
9 classes of such individuals, including any amount paid by an employer for
10 insurance or annuities or into a fund to provide for any such payment, on
11 account of (i) sickness or accident disability, except, in the case of
12 payments made to an employee or any of his or her dependents, this
13 subdivision (i) shall exclude from wages only payments which are received
14 under a workers' compensation law, (ii) medical and hospitalization
15 expenses in connection with sickness or accident disability, or (iii)
16 death;

17 (b) The payment by an employer, without deduction from the
18 remuneration of the employee, of the tax imposed upon an employee under
19 section 3101 of the Internal Revenue Code as defined in section
20 49-801.01;

21 (c) Any payment on account of sickness or accident disability, or
22 medical or hospitalization expenses in connection with sickness or
23 accident disability, made by an employer to, or on behalf of, an
24 individual after the expiration of six calendar months following the last
25 calendar month in which such individual worked for such employer;

26 (d) Any payment made to, or on behalf of, an individual or his or
27 her beneficiary (i) from or to a trust described in section 401(a) of the
28 Internal Revenue Code as defined in section 49-801.01 which is exempt
29 from tax under section 501(a) of the Internal Revenue Code as defined in
30 section 49-801.01 at the time of such payment unless such payment is made
31 to an employee of the trust as remuneration for services rendered as such

1 employee and not as a beneficiary of the trust or (ii) under or to an
2 annuity plan which, at the time of such payment, meets the requirements
3 of section 401 of the Internal Revenue Code as defined in section
4 49-801.01;

5 (e) Any payment made to, or on behalf of, an employee or his or her
6 beneficiary (i) under a simplified employee pension as defined by the
7 commissioner, (ii) under or to an annuity contract as defined by the
8 commissioner, other than a payment for the purchase of such contract
9 which is made by reason of a salary reduction agreement, whether
10 evidenced by a written instrument or otherwise, (iii) under or to an
11 exempt governmental deferred compensation plan as defined by the
12 commissioner, (iv) to supplement pension benefits under a plan or trust,
13 as defined by the commissioner, to take into account some portion or all
14 of the increase in the cost of living since retirement, but only if such
15 supplemental payments are under a plan which is treated as a welfare
16 plan, or (v) under a cafeteria benefits plan;

17 (f) Remuneration paid in any medium other than cash to an individual
18 for service not in the course of the employer's trade or business;

19 (g) Benefits paid under a supplemental unemployment benefit plan
20 which satisfies the eight points set forth in Internal Revenue Service
21 Revenue Ruling 56-249 as the ruling existed on January 1, 2015, and is in
22 compliance with the standards set forth in Internal Revenue Service
23 Revenue Rulings 58-128 and 60-330 as the rulings existed on January 1,
24 2015; and

25 (h) Remuneration for service performed in the employ of any state in
26 the exercise of his or her duties as a member of the Army National Guard
27 or Air National Guard or in the employ of the United States of America as
28 a member of any military reserve unit;

29 (30) Week means such period of seven consecutive days as the
30 commissioner may by rule and regulation prescribe;

31 (31) Week of unemployment with respect to any individual means any

1 week during which he or she performs less than full-time work and the
2 wages payable to him or her with respect to such week are less than his
3 or her weekly benefit amount;

4 (32) Wholly owned subsidiary means a corporation, company, or other
5 entity which has eighty percent or more of its outstanding voting stock
6 or membership owned or controlled, directly or indirectly, by the parent
7 entity; and

8 (33) Worksite employee has the same meaning as the term covered
9 employee in section 48-2702.

10 Sec. 6. Section 48-603.01, Revised Statutes Supplement, 2015, is
11 amended to read:

12 48-603.01 (1) For purposes of the Employment Security Law, unless
13 the context otherwise requires, the term employer shall include any
14 Indian tribe for which services in employment as provided in subdivision
15 (4)(a) of section 48-604 are performed.

16 (2) The term employment shall include service performed in the
17 employ of an Indian tribe, as defined in 26 U.S.C. 3306(u), as such
18 section existed on January 1, 2015, if such service is excluded from
19 employment as defined in the Federal Unemployment Tax Act solely by
20 reason of 26 U.S.C. 3306(c)(7), as such section existed on January 1,
21 2015, and is not otherwise excluded from employment under the Employment
22 Security Law. For purposes of this section, the exclusions from
23 employment in subdivisions (6)(f) and (6)(g) of section 48-604 shall be
24 applicable to services performed in the employment of an Indian tribe.

25 (3) Benefits based on service in employment defined in this section
26 shall be payable in the same amount, on the same terms, and subject to
27 the same conditions as benefits payable on the basis of other covered
28 employment under the Employment Security Law. Section 35 of this act
29 ~~Subdivision (8) of section 48-628~~ shall apply to services performed in an
30 educational institution or educational service agency owned or operated
31 by an Indian tribe.

1 (4)(a) Indian tribes or tribal units, subdivisions, subsidiaries, or
2 business enterprises wholly owned by such Indian tribes, subject to the
3 Employment Security Law, shall pay combined tax under the same terms and
4 conditions as all other subject employers, unless they elect to make
5 payments in lieu of contributions equal to the amount of benefits
6 attributable to service in the employ of the Indian tribe.

7 (b) Indian tribes electing to make payments in lieu of contributions
8 shall make such election in the same manner and under the same conditions
9 as provided in section 66 of this act ~~subdivision (7) of section 48-649~~
10 pertaining to state and local governments subject to the Employment
11 Security Law. Indian tribes shall determine if reimbursement for benefits
12 paid will be elected by the tribe as a whole, by individual tribal units,
13 or by combinations of individual tribal units.

14 (c) Except as provided in subsection (7) of this section, Indian
15 tribes or tribal units shall be billed for the full amount of benefits
16 attributable to service in the employ of the Indian tribe or tribal unit
17 on the same schedule as other employing units that have elected to make
18 payments in lieu of contributions.

19 (d) At the discretion of the commissioner, any Indian tribe or
20 tribal unit that elects to become liable for payments in lieu of
21 contributions shall be required within thirty days after the effective
22 date of its election to:

23 (i) Execute and file with the commissioner a surety bond approved by
24 the commissioner; or

25 (ii) Deposit with the commissioner money or securities on the same
26 basis as other employers with the same election option.

27 (5)(a)(i) Failure of the Indian tribe or tribal unit to make
28 required payments, including assessments of interest and penalty, within
29 ninety days of receipt of the bill will cause the Indian tribe to lose
30 the option to make payments in lieu of contributions, as described in
31 subsection (4) of this section, for the following tax year unless payment

1 in full is received before combined tax rates for the next tax year are
2 computed.

3 (ii) Any Indian tribe that loses the option to make payments in lieu
4 of contributions due to late payment or nonpayment, as described in
5 subdivision (5)(a)(i) of this section, shall have such option reinstated
6 if, after a period of one year, all combined taxes have been paid timely
7 and no combined tax, payments in lieu of contributions for benefits paid,
8 penalties, or interest remain outstanding.

9 (b)(i) Failure of the Indian tribe or any tribal unit thereof to
10 make required payments, including assessments of interest and penalty,
11 after all collection activities deemed necessary by the commissioner have
12 been exhausted will cause services performed for such tribe to not be
13 treated as employment for purposes of subsection (2) of this section.

14 (ii) The commissioner may determine that any Indian tribe that loses
15 coverage under subdivision (5)(b)(i) of this section may have services
16 performed for such tribe again included as employment for purposes of
17 subsection (2) of this section if all contributions, payments in lieu of
18 contributions, penalties, and interest have been paid.

19 (6) Notices of payment and reporting delinquency to Indian tribes or
20 their tribal units shall include information that failure to make full
21 payment within the prescribed timeframe:

22 (a) Will cause the Indian tribe to be liable for taxes under the
23 Federal Unemployment Tax Act, as the act existed on January 1, 2015;

24 (b) Will cause the Indian tribe to lose the option to make payments
25 in lieu of contributions; and

26 (c) Could cause the Indian tribe to be excepted from the definition
27 of employer, as provided in subsection (1) of this section, and services
28 in the employ of the Indian tribe, as provided in subsection (2) of this
29 section, to be excepted from employment.

30 (7) Extended benefits paid that are attributable to service in the
31 employ of an Indian tribe and not reimbursed by the federal government

1 shall be financed in their entirety by such Indian tribe.

2 (8) If an Indian tribe fails to make payments required under this
3 section, including assessments of interest and penalty, within ninety
4 days after a final notice of delinquency, the commissioner shall
5 immediately notify the United States Internal Revenue Service and the
6 United States Department of Labor.

7 Sec. 7. Section 48-604, Revised Statutes Cumulative Supplement,
8 2014, is amended to read:

9 48-604 As used in the Employment Security Law, unless the context
10 otherwise requires, employment shall mean:

11 (1) Any service performed, including service in interstate commerce,
12 for wages under a contract of hire, written or oral, express or implied;

13 (2) The term employment shall include an individual's entire
14 service, performed within or both within and without this state if (a)
15 the service is localized in this state, (b) the service is not localized
16 in any state but some of the service is performed in this state and the
17 base of operations or, if there is no base of operations, then the place
18 from which such service is directed or controlled is in this state or the
19 base of operations or place from which such service is directed or
20 controlled is not in any state in which some part of the service is
21 performed but the individual's residence is in this state, (c) the
22 service shall be deemed to be localized within a state if (i) the service
23 is performed entirely within such state or (ii) the service is performed
24 both within and without such state, but the service performed without
25 such state is incidental to the individual's service within the state,
26 for example, is temporary or transitory in nature or consists of isolated
27 transactions;

28 (3) Services performed outside the state and services performed
29 outside the United States as follows:

30 (a) Services not covered under subdivision (2) of this section and
31 performed entirely without this state, with respect to no part of which

1 contributions are required under an unemployment compensation law of any
2 other state or of the federal government, shall be deemed to be
3 employment subject to the Employment Security Law if the commissioner
4 approves the election of the employer, for whom such services are
5 performed, that the entire service of such individual shall be deemed to
6 be employment subject to such law;

7 (b) Services of an individual wherever performed within the United
8 States or Canada if (i) such service is not covered under the employment
9 compensation law of any other state or Canada and (ii) the place from
10 which the service is directed or controlled is in this state; and

11 (c)(i) Services of an individual who is a citizen of the United
12 States, performed outside the United States except in Canada in the
13 employ of an American employer, other than service which is deemed
14 employment under subdivisions (2) and (3)(a) and (b) of this section or
15 the parallel provisions of another state's law, if:

16 (A) The employer's principal place of business in the United States
17 is located in this state;

18 (B) The employer has no place of business in the United States, but
19 the employer is an individual who is a resident of this state; the
20 employer is a corporation or limited liability company which is organized
21 under the laws of this state; or the employer is a partnership or a trust
22 and the number of the partners or trustees who are residents of this
23 state is greater than the number who are residents of any other state; or

24 (C) None of the criteria of subdivisions (A) and (B) of this
25 subdivision are met, but the employer has elected coverage in this state
26 or, the employer having failed to elect coverage in any state, the
27 individual has filed a claim for benefits based on such service under the
28 laws of this state.

29 (ii) American employer, for the purposes of this subdivision, shall
30 mean: (A) An individual who is a resident of the United States; (B) a
31 partnership if two-thirds or more of the partners are residents of the

1 United States; (C) a trust if all the trustees are residents of the
2 United States; or (D) a corporation or limited liability company
3 organized under the laws of the United States or of any state.

4 (iii) The term United States for the purpose of this section
5 includes the states, the District of Columbia, the Virgin Islands, and
