1 1. Strike the original sections and all amendments thereto and
2 insert the following new sections:

3 Section 1. Section 43-279.01, Revised Statutes Cumulative
4 Supplement, 2014, is amended to read:

5 43-279.01 (1) When the petition alleges the juvenile to be within
6 the provisions of subdivision (3)(a) of section 43-247 or when
7 termination of parental rights is sought pursuant to subdivision (6) of
8 section 43-247 and the parent, custodian, or guardian appears with or
9 without counsel, the court shall inform the parties of the:

10 (a) Nature of the proceedings and the possible consequences or
11 dispositions pursuant to sections 43-284, 43-285, and 43-288 to 43-295;

12 (b) Right of the parent to engage counsel of his or her choice at
13 his or her own expense or to have counsel appointed if the parent is
14 unable to afford to hire a lawyer;

15 (c) Right of a stepparent, custodian, or guardian to engage counsel
16 of his or her choice and, if there are allegations against the
17 stepparent, custodian, or guardian or when the petition is amended to
18 include such allegations, to have counsel appointed if the stepparent,
19 custodian, or guardian is unable to afford to hire a lawyer;

20 (d) Right to remain silent as to any matter of inquiry if the
21 testimony sought to be elicited might tend to prove the party guilty of
22 any crime;

23 (e) Right to confront and cross-examine witnesses;

24 (f) Right to testify and to compel other witnesses to attend and
25 testify;

26 (g) Right to a speedy adjudication hearing; and

27 (h) Right to appeal and have a transcript or record of the

1 proceedings for such purpose.

2 (2) The court shall have the discretion as to whether or not to
3 appoint counsel for a person who is not a party to the proceeding. If
4 counsel is appointed, failure of the party to maintain contact with his
5 or her court-appointed counsel or to keep such counsel advised of the
6 party's current address may result in the counsel being discharged by the
7 court.

8 (3) After giving the parties the information prescribed in
9 subsection (1) of this section, the court may accept an in-court
10 admission, an answer of no contest, or a denial from any parent,
11 custodian, or guardian as to all or any part of the allegations in the
12 petition. The court shall ascertain a factual basis for an admission or
13 an answer of no contest.

14 (4) In the case of a denial, the court shall allow a reasonable time
15 for preparation if needed and then proceed to determine the question of
16 whether the juvenile falls under the provisions of section 43-247 as
17 alleged. After hearing the evidence, the court shall make a finding and
18 adjudication to be entered on the records of the court as to whether the
19 allegations in the petition have been proven by a preponderance of the
20 evidence in cases under subdivision (3)(a) of section 43-247 or by clear
21 and convincing evidence in proceedings to terminate parental rights. The
22 court shall inquire as to whether any party believes an Indian child is
23 involved in the proceedings prior to the advisement of rights pursuant to
24 subsection (1) of this section. If an Indian child is involved, the
25 standard of proof shall be in compliance with the Nebraska Indian Child
26 Welfare Act, if applicable.

27 (5) If the court shall find that the allegations of the petition or
28 motion have not been proven by the requisite standard of proof, it shall
29 dismiss the case or motion. If the court sustains the petition or motion,
30 it shall allow a reasonable time for preparation if needed and then
31 proceed to inquire into the matter of the proper disposition to be made

1 of the juvenile.

2 Sec. 2. Section 43-512.04, Reissue Revised Statutes of Nebraska, is
3 amended to read:

4 43-512.04 (1) An action for child support or medical support may be
5 brought separate and apart from any action for dissolution of marriage.
6 The complaint initiating the action shall be filed with the clerk of the
7 district court and may be heard by the county court or the district court
8 as provided in section 25-2740. Such action for support may be filed on
9 behalf of a child:

10 (a) Whose paternity has been established (i) by prior judicial order
11 in this state, (ii) by a prior determination of paternity made by any
12 other state or by an Indian tribe as described in subsection (1) of
13 section 43-1406, or (iii) by the marriage of his or her parents as
14 described in section 42-377 or subsection (2) of section 43-1406; or

15 (b) Whose paternity is presumed as described in section 43-1409 or
16 subsection (2) of section 43-1415.

17 (2) The father, not having entered into a judicially approved
18 settlement or being in default in the performance of the same, may be
19 made a respondent in such action. The mother of the child may also be
20 made a respondent in such an action. Such action shall be commenced by a
21 complaint of the mother of the child, the father of the child whose
22 paternity has been established, the guardian or next friend of the child,
23 the county attorney, or an authorized attorney.

24 (3) The complaint shall set forth the basis on which paternity was
25 previously established or presumed, if the respondent is the father, and
26 the fact of nonsupport and shall ask that the father, the mother, or both
27 parents be ordered to provide for the support of the child. Summons shall
28 issue against the father, the mother, or both parents and be served as in
29 other civil proceedings, except that such summons may be directed to the
30 sheriff of any county in the state and may be served in any county. The
31 method of trial shall be the same as in actions formerly cognizable in

1 equity, and jurisdiction to hear and determine such actions for support
2 is hereby vested in the district court of the district or the county
3 court of the county where the child is domiciled or found or, for cases
4 under the Uniform Interstate Family Support Act if the child is not
5 domiciled or found in Nebraska, where the parent of the child is
6 domiciled.

7 (4) In such proceeding, if the defendant is the presumed father as
8 described in subdivision (1)(b) of this section, the court shall make a
9 finding whether or not the presumption of paternity has been rebutted.
10 The presumption of paternity created by acknowledgment as described in
11 section 43-1409 may be rebutted as part of an equitable proceeding to
12 establish support by genetic testing results which exclude the alleged
13 father as being the biological father of the child. A court in such a
14 proceeding may order genetic testing as provided in sections 43-1414 to
15 43-1418.

16 (5) If the court finds that the father, the mother, or both parents
17 have failed adequately to support the child, the court shall issue a
18 decree directing him, her, or them to do so, specifying the amount of
19 such support, the manner in which it shall be furnished, and the amount,
20 if any, of any court costs and attorney's fees to be paid by the father,
21 the mother, or both parents. Income withholding shall be ordered pursuant
22 to the Income Withholding for Child Support Act. The court may require
23 the furnishing of bond to insure the performance of the decree in the
24 same manner as is provided for in section 42-358.05 or 43-1405. Failure
25 on the part of the defendant to perform the terms of such decree shall
26 constitute contempt of court and may be dealt with in the same manner as
27 other contempts. The court may also order medical support and the payment
28 of expenses as described in section 43-1407.

31 43-1406 (1) A determination of paternity made by any other state or

1 by an Indian tribe as defined in section 43-1503, whether established
2 through voluntary acknowledgment, genetic testing, tribal law, or
3 administrative or judicial processes, shall be given full faith and
4 credit by this state.

5 (2) A child whose parents marry is legitimate.

8 43-1501 Sections 43-1501 to 43-1516 and sections 9 and 15 of this
9 act shall be known and may be cited as the Nebraska Indian Child Welfare

11 Sec. 5. Section 43-1502, Reissue Revised Statutes of Nebraska, is
12 amended to read:

13 43-1502 The purpose of the Nebraska Indian Child Welfare Act is to
14 clarify state policies and procedures regarding the implementation by the
15 State of Nebraska of the federal Indian Child Welfare Act, ~~25 U.S.C. 1901~~
16 ~~et seq.~~ It shall be the policy of the state to cooperate fully with
17 Indian tribes in Nebraska in order to ensure that the intent and
18 provisions of the federal Indian Child Welfare Act are enforced. This
19 cooperation includes recognition by the state that Indian tribes have a
20 continuing and compelling governmental interest in an Indian child
21 whether or not the Indian child is in the physical or legal custody of a
22 parent, an Indian custodian, or an Indian extended family member at the
23 commencement of an Indian child custody proceeding or the Indian child
24 has resided or is domiciled on an Indian reservation. The state is
25 committed to protecting the essential tribal relations and best interests
26 of an Indian child by promoting practices consistent with the federal
27 Indian Child Welfare Act and other applicable law designed to prevent the
28 Indian child's voluntary or involuntary out-of-home placement.

29 Sec. 6. Section 43-1503, Revised Statutes Cumulative Supplement,
30 2014, is amended to read:

31 43-1503 For purposes of the Nebraska Indian Child Welfare Act,

1 except as may be specifically provided otherwise, ~~the term:~~

2 (1) Active efforts shall mean and include, but not be limited to:

3 (a) A concerted level of casework, both prior to and after the
4 removal of an Indian child, exceeding the level that is required under
5 reasonable efforts to preserve and reunify the family described in
6 section 43-283.01 in a manner consistent with the prevailing social and
7 cultural conditions and way of life of the Indian child's tribe or tribes
8 to the extent possible under the circumstances;

9 (b) A request to the Indian child's tribe or tribes and extended
10 family known to the department or the state to convene traditional and
11 customary support and services;

12 (c) Actively engaging, assisting, and monitoring the family's access
13 to and progress in culturally appropriate and available resources of the
14 Indian child's extended family members, tribal service area, Indian tribe
15 or tribes, and individual Indian caregivers;

16 (d) Identification of and provision of information to the Indian
17 child's extended family members known to the department or the state
18 concerning appropriate community, state, and federal resources that may
19 be able to offer housing, financial, and transportation assistance and
20 actively assisting the family in accessing such community, state, and
21 federal resources;

22 (e) Identification of and attempts to engage tribally designated
23 Nebraska Indian Child Welfare Act representatives;

24 (f) Consultation with extended family members known to the
25 department or the state, or a tribally designated Nebraska Indian Child
26 Welfare Act representative if an extended family member cannot be
27 located, to identify family or tribal support services that could be
28 provided by extended family members or other tribal members if extended
29 family members cannot be located;

30 (g) Exhaustion of all available tribally appropriate family
31 preservation alternatives; and

1 (h) When the department or the state is involved in a proceeding
2 under the act, the department or the state shall provide a written report
3 of their attempts to provide active efforts to the court at every hearing
4 involving an Indian child. This report shall be sent to the Indian
5 child's tribe or tribes within three days after being filed with the
6 court and shall be deemed to be admissible evidence of active efforts in
7 proceedings conducted under the act;

8 (2) Best interests of the Indian child shall include:

9 (a) The Indian child's best interests are served by the use of
10 practices in compliance with the federal Indian Child Welfare Act, the
11 Nebraska Indian Child Welfare Act, and other applicable laws that are
12 designed to prevent the Indian child's voluntary or involuntary out-of-
13 home placement; and

14 (b) Whenever an out-of-home placement is necessary, placing the
15 child, to the greatest extent possible, in a foster home, adoptive
16 placement, or other type of custodial placement that reflects the unique
17 values of the Indian child's tribal culture and is best able to assist
18 the child in establishing, developing, and maintaining a political,
19 cultural, and social relationship with the Indian child's tribe or tribes
20 and tribal community;

21 (3 ~~1~~) Child custody proceeding shall mean and include:

22 (a) Foster care placement which shall mean any action removing an
23 Indian child from his or her parent or Indian custodian for temporary or
24 emergency placement in a foster home or institution or the home of a
25 guardian or conservator where the parent or Indian custodian cannot have
26 the child returned upon demand, but where parental rights have not been
27 terminated;

28 (b) Termination of parental rights which shall mean any action
29 resulting in the termination of the parent-child relationship;

30 (c) Preadoptive placement which shall mean the temporary placement
31 of an Indian child in a foster home or institution after the termination

1 of parental rights, but prior to or in lieu of adoptive placement;~~and~~

2 (d) Adoptive placement which shall mean the permanent placement of
3 an Indian child for adoption, including any action resulting in a final
4 decree of adoption; and -

5 (e) Voluntary foster care placement which shall mean a non-court-
6 involved proceeding in which the department or the state is facilitating
7 a voluntary foster care placement or in-home services to families at risk
8 of entering the foster care system. An Indian child, parent, or tribe
9 involved in a voluntary foster care placement shall only be provided
10 protections as provided in subsection (4) of section 43-1505 and sections
11 43-1506 and 43-1508.

12 Such term or terms shall not include a placement based upon an act
13 which, if committed by an adult, would be deemed a crime or upon an
14 award, in a divorce proceeding, of custody to one of the parents;

15 (4) The department or the state shall mean the applicable state
16 social services entity that is involved with the provision of services to
17 Indian children, specifically the Department of Health and Human Services
18 and the Office of Probation Administration in certain cases;

19 (5 2) Extended family member shall be as defined by the law or
20 custom of the Indian child's primary tribe or, in the absence of such
21 laws or customs of the primary tribe, the law or custom of the Indian
22 child's other tribes or, in the absence of such law or custom ~~tribe or,~~
23 in the absence of such law or custom, shall mean be a person who has
24 reached the age of eighteen and who is the Indian child's parent,
25 grandparent, aunt or uncle, clan member, band member, sibling, brother-
26 in-law or sister-in-law, niece or nephew, cousin, or stepparent;

27 (6) Federal Indian Child Welfare Act shall mean the federal Indian
28 Child Welfare Act of 1978, 25 U.S.C. 1901 et seq.;

29 (7 3) Indian shall mean means any person who is a member of an
30 Indian tribe, or who is an Alaska Native and a member of a regional
31 corporation defined in section 7 of the Alaska Native Claims Settlement

1 Act, 43 U.S.C. 1606;

2 (8 4) Indian child shall mean ~~means~~ any unmarried person who is
3 under age eighteen and is either (a) a member of an Indian tribe or (b)
4 is eligible for membership in an Indian tribe and is the biological child
5 of a member of an Indian tribe;

6 (9) Indian child's primary tribe shall mean, in the case of an
7 Indian child that is a member or eligible for membership in multiple
8 tribes, the tribe determined by the procedure enumerated in subsection
9 (4) of section 43-1504;

10 (10 5) Indian child's tribe or tribes shall mean ~~means~~ (a) the
11 Indian tribe or tribes in which an Indian child is a member or eligible
12 for membership ~~or (b) in the case of an Indian child who is a member of~~
13 ~~or eligible for membership in more than one tribe, the Indian tribe with~~
14 ~~which the Indian child has the more significant contacts;~~

15 (11 6) Indian custodian shall mean ~~means~~ any Indian person who has
16 legal custody of an Indian child under tribal law or custom or under
17 state law or to whom temporary physical care, custody, and control has
18 been transferred by the parent of such child;

19 (12 7) Indian organization shall mean ~~means~~ any group, association,
20 partnership, limited liability company, corporation, or other legal
21 entity owned or controlled by Indians or a majority of whose members are
22 Indians;

23 (13 8) Indian tribe shall mean ~~means~~ any Indian tribe, band, nation,
24 or other organized group or community of Indians recognized as eligible
25 for the services provided to Indians by the secretary because of their
26 status as Indians, including any Alaska Native village as defined in
27 section 3(c) of the Alaska Native Claims Settlement Act, as amended, 43
28 U.S.C. 1602(c);

29 (14 9) Parent means any biological parent or parents of an Indian
30 child or any Indian person who has lawfully adopted an Indian child,
31 including adoptions under tribal law or custom. It does not include the

1 unwed father when paternity has not been acknowledged or established;

2 (15) Qualified expert witness shall mean one of the following
3 persons, in descending priority order although a court may assess the
4 credibility of individual witnesses:

5 (a) A member of the Indian child's tribe or tribes who is recognized
6 by the tribal community as knowledgeable in tribal customs as they
7 pertain to family and childrearing practices;

8 (b) A member of another tribe who is recognized to be a qualified
9 expert witness by the Indian child's tribe or tribes based on his or her
10 knowledge of the delivery of child and family services to Indians and the
11 Indian child's tribe or tribes;

12 (c) A lay expert witness that possesses substantial experience in
13 the delivery of child and family services to Indians and extensive
14 knowledge of prevailing social and cultural standards and childrearing
15 practices within the Indian child's tribe or tribes;

16 (d) A professional person having substantial education and
17 experience in the area of his or her specialty who can demonstrate
18 knowledge of the prevailing social and cultural standards and
19 childrearing practices within the Indian child's tribe or tribes; or

20 (e) Any other professional person having substantial education in
21 the area of his or her specialty;

22 (16 10) Reservation shall mean means Indian country as defined in 18
23 U.S.C. 1151 and any lands, not covered under such section, title to which
24 is either held by the United States in trust for the benefit of any
25 Indian tribe or individual or held by any Indian tribe or individual
26 subject to a restriction by the United States against alienation or a
27 federally designated or established service area which means a geographic
28 area designated by the United States where federal services and benefits
29 furnished to Indians and Indian tribes are provided or which is otherwise
30 designated to constitute an area on or near a reservation;

31 (17 11) Secretary shall mean means the Secretary of the United

1 States Department of the Interior;

2 (18 12) Tribal court shall mean ~~means~~ a court with jurisdiction over
3 child custody proceedings and which is either a Court of Indian Offenses,
4 a court established and operated under the code or custom of an Indian
5 tribe, or any other administrative body of a tribe which is vested with
6 authority over child custody proceedings; and

7 (19 13) Tribal service area shall mean ~~means~~ a geographic area, as
8 defined by the applicable Indian tribe or tribes, in which tribal
9 services and programs are provided to Indians ~~Native American people~~.

10 Sec. 7. Section 43-1504, Reissue Revised Statutes of Nebraska, is
11 amended to read:

12 43-1504 (1) An Indian tribe shall have jurisdiction exclusive as to
13 this state over any child custody proceeding involving an Indian child
14 who resides or is domiciled within the reservation of such tribe, except
15 when ~~where~~ such jurisdiction is otherwise vested in the state by existing
16 federal law. When an Indian child is a ward of a tribal court, the Indian
17 tribe shall retain exclusive jurisdiction, notwithstanding the residence
18 or domicile of the child.

19 (2) In any state court proceeding for the foster care placement of,
20 or termination of parental rights to, an Indian child not domiciled or
21 residing within the reservation of the Indian child's tribe, the court,
22 in the absence of good cause to the contrary, shall transfer such
23 proceeding to the jurisdiction of the primary tribe, absent objection by
24 either parent, upon the petition of either parent or the Indian custodian
25 or the Indian child's tribe, except that such transfer shall be subject
26 to declination by the tribal court of such tribe.

27 (3) In any state court proceeding for the foster care placement of,
28 or termination of parental rights to, an Indian child, the Indian
29 custodian of the child and the Indian child's tribe or tribes shall have
30 a right to intervene at any point in the proceeding regardless of whether
31 the intervening party is represented by legal counsel. The Indian child's

1 tribe or tribes and their counsel are not required to associate with
2 local counsel or pay a fee to appear pro hac vice in a child custody
3 proceeding under the Nebraska Indian Child Welfare Act. Representatives
4 from the Indian child's tribe or tribes have the right to fully
5 participate in every court proceeding held under the act.

6 (4) If the Indian child is eligible for membership or enrolled in
7 multiple Indian tribes and more than one Indian tribe intervenes in a
8 state court proceeding for the foster care placement of, or termination
9 of parental rights to, an Indian child, the Indian child's primary tribe
10 shall be determined in the following manner:

11 (a) A unanimous agreement between the applicable Indian tribes
12 designating which Indian tribe shall be the Indian child's primary tribe
13 in the underlying state court proceeding, within thirty days of
14 intervention by an additional tribe or tribes;

15 (b) The Indian tribes should seek to consult the parents of the
16 Indian child and an Indian child over the age of twelve, when
17 practicable, prior to entering into such an agreement; or

18 (c) If a unanimous agreement cannot be reached by the Indian tribes
19 within thirty days, the Indian child's primary tribe shall be determined
20 by the state court based upon which Indian tribe with which the Indian
21 child has more significant contacts.

22 (5) 4) The State of Nebraska shall give full faith and credit to the
23 public acts, records, and judicial proceedings of any Indian tribe
24 applicable to Indian child custody proceedings to the same extent that
25 the state gives full faith and credit to the public acts, records, and
26 judicial proceedings of any other entity.

27 Sec. 8. Section 43-1505, Reissue Revised Statutes of Nebraska, is
28 amended to read:

29 43-1505 (1) In any involuntary proceeding in a state court, when the
30 court knows or has reason to know that an Indian child is involved, the
31 party seeking the foster care placement of, or termination of parental

1 rights to, an Indian child shall send a notice conforming to the
2 requirements of 25 C.F.R. 23.11 to notify the parents, the parent or
3 Indian custodian, and the Indian child's tribe or tribes, by certified or
4 registered mail with return receipt requested, of the pending proceedings
5 and of their right of intervention. If the identity or location of the
6 parent or Indian custodian and the tribe or tribes cannot be determined,
7 such notice shall be given to the secretary in like manner, who may
8 provide the requisite notice to the parent or Indian custodian and the
9 tribe or tribes. No foster care placement or termination of parental
10 rights proceedings shall be held until at least ten days after receipt of
11 notice by the parent or Indian custodian and the tribe or tribes or the
12 secretary. The parent or Indian custodian or the tribe or tribes shall,
13 upon request, be granted up to twenty additional days to prepare for such
14 proceeding.

15 (2) In any case in which the court determines indigency, the parent
16 or Indian custodian shall have the right to court-appointed counsel in
17 any removal, placement, or termination proceeding. The court may, in its
18 discretion, appoint counsel for the child upon a finding that such
19 appointment is in the best interests ~~interest~~ of the Indian child. When
20 state law makes no provision for appointment of counsel in such
21 proceedings, the court shall promptly notify the secretary upon
22 appointment of counsel and request from the secretary, upon certification
23 of the presiding judge, payment of reasonable attorney's fees and
24 ~~expenses~~ out of funds which may be appropriated.

25 (3) Each party to a foster care placement or termination of parental
26 rights proceeding under state law involving an Indian child shall have
27 the right to examine all reports or other documents filed with the court
28 upon which any decision with respect to such action may be based.

29 (4) Any party seeking to effect a foster care placement of, or
30 termination of parental rights to, an Indian child under state law shall
31 satisfy the court that active efforts have been made to provide remedial

1 services and rehabilitative programs designed to prevent the breakup of
2 the Indian family or unite the parent or Indian custodian with the Indian
3 child and that these efforts have proved unsuccessful. Any written
4 evidence showing that active efforts have been made shall be admissible
5 in a proceeding under the Nebraska Indian Child Welfare Act. Prior to the
6 court ordering placement of the child in foster care or the termination
7 of parental rights, the court shall make a determination that active
8 efforts have been provided or that the party seeking placement or
9 termination has demonstrated that attempts were made to provide active
10 efforts to the extent possible under the circumstances.

11 (5) The court shall not order ~~No~~ foster care placement under this
12 section may be ordered in such proceeding in the absence of a
13 determination by the court, supported by clear and convincing evidence,
14 including testimony of qualified expert witnesses, that the continued
15 custody of the child by the parent or Indian custodian is likely to
16 result in serious emotional or physical damage to the child.

17 (6) The court shall not order ~~No~~ termination of parental rights
18 under this section may be ordered in such proceeding in the absence of a
19 determination by the court, supported by evidence beyond a reasonable
20 doubt, including testimony of qualified expert witnesses, that the
21 continued custody of the child by the parent or Indian custodian is
22 likely to result in serious emotional or physical damage to the child.

23 Sec. 9. (1) Notice of an involuntary proceeding in state court
24 involving an Indian child shall conform with the requirements of 25
25 C.F.R. 23.11 and shall contain the following additional information, to
26 the extent it is known, and if this additional information is unknown, a
27 statement indicating what attempts have been made to locate the
28 information:

29 (a) The name and last-known address of the Indian child;

30 (b) The name and address of the Indian child's parents, paternal and
31 maternal grandparents, and Indian custodians, if any;

1 (c) The tribal affiliation of the parents of the Indian child or, if
2 applicable, the Indian custodians;

3 (d) A statement as to whether the Indian child's residence or
4 domicile is on the tribe's reservation;

5 (e) An identification of any tribal court order affecting the
6 custody of the Indian child to which a state court may be required to
7 accord full faith and credit; and

8 (f) A copy of the motion for foster care placement of the Indian
9 child and any accompanying affidavits in support thereof if such
10 documents exist.

11 (2) A copy of the notice of an involuntary proceeding in state court
12 involving an Indian child, as described in subsection (1) of this
13 section, shall be filed with the court within three days after issuance.

14 Sec. 10. Section 43-1506, Reissue Revised Statutes of Nebraska, is
15 amended to read:

16 43-1506 (1) When any parent or Indian custodian voluntarily consents
17 (a) to a foster care placement or (b) to relinquishment or termination of
18 parental rights, such consent shall not be valid unless executed in
19 writing and recorded before a judge of a court of competent jurisdiction
20 and accompanied by the presiding judge's certificate that the terms and
21 consequences of the consent were fully explained in detail and were fully
22 understood by the parent or Indian custodian. The court shall also
23 certify that either the parent or Indian custodian fully understood the
24 explanation in English or that it was interpreted into a language that
25 the parent or Indian custodian understood. Any consent given prior to, or
26 within ten days after, birth of the Indian child shall not be valid.

27 (2) When the department or the state offers the parent, Indian
28 child, or Indian custodian services through a voluntary foster care
29 placement or in-home services and the department or the state knows or
30 has reason to know that an Indian child is involved, the department or
31 the state shall notify the parent or Indian custodian and the Indian

1 child's tribe or tribes, by telephone call, facsimile transmission,
2 email, or registered mail with return receipt requested, of the provision
3 of services and any pending child custody proceeding. If the identity or
4 location of the parent or Indian custodian and the tribe or tribes cannot
5 be determined, such notice shall be given to the secretary and the
6 appropriate area director listed in 25 C.F.R. 23.11 in like manner who
7 may provide the requisite notice to the parent or Indian custodian and
8 the tribe or tribes. Notice shall be provided within five days after the
9 initiation of voluntary services.

10 (3) When the department or the state offers the parent or Indian
11 custodian services through a voluntary foster care placement or in-home
12 services, the Indian custodian of the child and the Indian child's tribe
13 or tribes have a right to participate in, provide, or consult with the
14 department or the state regarding the provision of voluntary services.

15 (4) When the department or the state offers the parent or Indian
16 custodian services through a voluntary foster care placement or in-home
17 services, the department or the state shall provide remedial services and
18 rehabilitative programs designed to prevent the breakup of the Indian
19 family or unite the parent or Indian custodian with the Indian child
20 until these efforts have proved unsuccessful.

21 (5) Prior to any voluntary relinquishment or termination of parental
22 rights proceeding in which the department or the state is a party or was
23 providing assistance to a parent or Indian custodian, the department or
24 the state or its designee shall submit the following information, in
25 writing, to the court if it has not previously been provided:

26 (a) The jurisdictional authority of the court in the proceeding;

27 (b) The date of the Indian child's birth and the date of any
28 voluntary consent to relinquishment or termination;

29 (c) The age of the Indian child at the time voluntary consent was
30 given;

31 (d) The date the parent appeared in court and was informed by the

1 judge of the terms and consequences of any voluntary consent to
2 relinquishment or termination;

16 (6 2) Any parent or Indian custodian may withdraw consent to a
17 foster care or voluntary foster care placement under state law at any
18 time and, upon such withdrawal, the child shall be returned to the parent
19 or Indian custodian.

20 (7 3) In any voluntary proceedings for termination of parental
21 rights to, or adoptive placement of, an Indian child, the consent of the
22 parent may be withdrawn for any reason at any time prior to the entry of
23 a final decree of termination or adoption, as the case may be, and the
24 child shall be returned to the parent.

25 (8 4) After the entry of a final decree of adoption of an Indian
26 child in any state court, the parent may withdraw consent thereto upon
27 the grounds that consent was obtained through fraud or duress and may
28 petition the court to vacate such decree. Upon a finding that such
29 consent was obtained through fraud or duress, the court shall vacate such
30 decree and return the child to the parent. No adoption which has been
31 effective for at least two years may be invalidated under the provisions

1 of this subsection unless otherwise permitted under state law.
