Re: Developmental Disabilities Court-Ordered Custody Act Report

Dear Mr. O'Donnell,

Per Neb. Rev. Stat. §71-1134, the Division of Developmental Disabilities is submitting this communication as the annual Developmental Disabilities Court-Ordered Custody Act (DDCOCA) report.

When an individual has been adjudicated as a person "in need of court-ordered custody and treatment" under the DDCOCA, the Department of Health and Human Services is required to "evaluate" the individual and develop "a plan for custody and treatment...in the least restrictive alternative." If the court approves the plan, such custody and treatment will continue until an annual review hearing before the same court, where the plan may be continued, revised or discontinued, depending on the circumstances.

During the 2014-2015 fiscal year, \$1,605,487.90 was spent to provide evaluations and/or services to individuals affected by the Developmental Disabilities Court Ordered Custody Act. Attached is a summary of the cases.
