This bill, as amended, would require certain law enforcement agencies to adopt policies on the use of body-worn cameras, provide that recordings from such cameras are not public records, and prohibit certain conduct involving such recordings.

The Supreme Court estimates a minimal fiscal impact relating to grand juries. The Supreme Court also notes that the transcript required by the bill would be a county expenditure. See their response following for additional details.
