Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill extends the Nebraska Children's Commission through June 30, 2019. The Commission is scheduled to sunset on June 30, 2016. This bill directs the Commission to develop a system of care plan from preventative through treatment services for the child welfare system based on relevant data and evidence-based practices. The bill also repeals the requirement for agencies to submit separate budgets for program serving children.

The cost to continue the Commission at its current level is \$190,121 annually.
