- 1 A BILL FOR AN ACT relating to the International Fuel Tax Agreement Act;
- 2 to amend section 66-1418, Revised Statutes Cumulative Supplement,
- 3 2014; to eliminate obsolete provisions relating to trip permits; and
- 4 to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 66-1418, Revised Statutes Cumulative Supplement,
2 2014, is amended to read:

3 ~~66-1418 (1) This subsection applies until the implementation date~~
4 ~~designated by the director pursuant to subsection (2) of this section.~~
5 ~~The department shall provide for a trip permit to be issued. Such trip~~
6 ~~permits shall be issued for a fee of twenty dollars and shall be valid~~
7 ~~for a period of seventy-two hours. The carrier enforcement division~~
8 ~~designated under section 60-1303 shall act as an agent for the department~~
9 ~~in collecting the fees prescribed in this section and shall remit all~~
10 ~~such fees collected to the State Treasurer for credit to the Highway Cash~~
11 ~~Fund. Such trip permits shall be available at weighing stations operated~~
12 ~~by the carrier enforcement division and at various vendor stations as~~
13 ~~determined appropriate by the carrier enforcement division. Trip permits~~
14 ~~shall be obtained at the first available location, whether that is a~~
15 ~~weighing station or a vendor station. The vendor stations shall be~~
16 ~~entitled to collect and retain an additional fee of ten percent of the~~
17 ~~fee collected pursuant to this section as reimbursement for the clerical~~
18 ~~work of issuing the permits.~~

19 ~~(2) This subsection applies beginning on an implementation date~~
20 ~~designated by the director. The director shall designate an~~
21 ~~implementation date which is on or before January 1, 2015. A trip permit~~
22 ~~shall be issued before any person required to obtain a trip permit enters~~
23 ~~this state. The trip permit shall be issued by the director through~~
24 ~~Internet sales from the department's web site. The trip permit shall be~~
25 ~~issued for a fee of twenty dollars and shall be valid for a period of~~
26 ~~seventy-two hours. The fee collected by the director shall be remitted to~~
27 ~~the State Treasurer for credit to the Highway Cash Fund.~~
