- 1 A BILL FOR AN ACT relating to health and human services; to amend section
- 2 71-208, Reissue Revised Statutes of Nebraska, and section 71-202.01,
- 3 Revised Statutes Cumulative Supplement, 2014; to define a term; to
- 4 change provisions relating to prerequisites to admission to and
- 5 graduation from barber schools or colleges as prescribed; to
- 6 harmonize provisions; and to repeal the original sections.
- 7 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 71-202.01, Revised Statutes Cumulative
- 2 Supplement, 2014, is amended to read:
- 3 71-202.01 For purposes of the Barber Act, unless the context
- 4 otherwise requires:
- 5 (1) Barber shall mean any person who engages in the practice of any
- 6 act of barbering;
- 7 (2) Barber pole shall mean a cylinder or pole with alternating
- 8 stripes of red, white, and blue or any combination of them which run
- 9 diagonally along the length of the cylinder or pole;
- 10 (3) Barber shop shall mean an establishment or place of business
- 11 properly licensed as required by the act where one or more persons
- 12 properly licensed are engaged in the practice of barbering but shall not
- include barber schools or colleges;
- (4) Barber school or college shall mean an establishment properly
- 15 licensed and operated for the teaching and training of barber students;
- 16 (5) Board shall mean the Board of Barber Examiners;
- 17 (6) Manager shall mean a licensed barber having control of the
- 18 barber shop and of the persons working or employed therein;
- 19 (7) License shall mean a certificate of registration issued by the
- 20 board;
- 21 (8) Barber instructor shall mean a teacher of the barber trade as
- 22 provided in the act;
- 23 (9) Assistant barber instructor shall mean a teacher of the
- 24 barbering trade registered as an assistant barber instructor as required
- 25 by the act;
- 26 (10) Registered or licensed barber shall mean a person who has
- 27 completed the requirements to receive a certificate as a barber and to
- 28 whom a certificate has been issued;
- 29 (11) Secretary of the board shall mean the director appointed by the
- 30 board who shall keep a record of the proceedings of the board;—and
- 31 (12) Student shall mean a person attending an approved, licensed

- 1 barber school or college, duly registered with the board as a student
- 2 engaged in learning and acquiring any and all of the practices of
- 3 barbering, and who, while learning, performs and assists any of the
- 4 practices of barbering in a barber school or college; and -
- 5 (13) Postsecondary barber school or college shall mean an
- 6 establishment properly licensed and operated for the teaching and
- 7 training of barber students who have successfully completed high school
- 8 <u>or its equivalent as determined by successfully passing a general</u>
- 9 educational development test prior to admittance.
- Sec. 2. Section 71-208, Reissue Revised Statutes of Nebraska, is
- 11 amended to read:
- 12 71-208 The Legislature finds that, through licensing of barber
- 13 schools, the Board of Barber Examiners approves barbering programs which
- 14 lead to a certificate or diploma in Nebraska. No barber school or college
- of barbering shall be approved by the board unless (1)(a) a barber school
- 16 or college that operates as a postsecondary barber school or college
- 17 requires, as a prerequisite to admission, high school graduation or its
- 18 equivalent as determined by successfully passing a general educational
- 19 development test or (b) a barber school or college that does not operate
- 20 as a postsecondary barber school or college requires, as a prerequisite
- 21 to graduation from such school or college, high school graduation or its
- 22 equivalent as determined by successfully passing a general educational
- 23 development test, as a prerequisite to graduation it requires graduation
- 24 from high school or its equivalent as determined by successfully passing
- 25 a general educational development test, (2) as a prerequisite to
- 26 graduation it requires a course of instruction of not less than two
- 27 thousand one hundred hours, to be completed in a period of not less than
- one year, of not more than ten hours in any one working day, and (3) the
- 29 barber school or college meets the standards of the Barber Act and any
- 30 rules and regulations of the board. Such course of instruction shall
- 31 include scientific fundamentals for barbering, hygiene, massaging,

- 1 sterilization, haircutting, and shaving, except that when a <u>barber</u> school
- 2 or college of barbering is a part of a high school accredited by the
- 3 State Board of Education or the University of Nebraska, the Board of
- 4 Barber Examiners shall provide in its rules and regulations that credit
- 5 in the <u>barber school or college</u> school of barbering shall be given for
- 6 hours spent and courses pursued in the high school and that credit shall
- 7 be given for courses in barbering taken in high school prior to formal
- 8 enrollment in such <u>barber school or college</u> school of barbering.

- 10 Nebraska, and section 71-202.01, Revised Statutes Cumulative Supplement,
- 11 2014, are repealed.
