- A BILL FOR AN ACT relating to the Public Accountancy Act; to amend sections 1-113, 1-118, 1-119, 1-121, and 1-136.04, Reissue Revised Statutes of Nebraska, and section 1-136.02, Revised Statutes Cumulative Supplement, 2014; to change provisions relating to an advisory committee, certified public accountant reexamination provisions, the examination fee, and accounting experience; and to repeal the original sections.

- 3 1-113 (1) The board shall appoint an advisory committee consisting
- 4 of at least seven members. A majority of the members shall be appointed
- 5 as representatives of the postsecondary educational institutions of
- 6 Nebraska engaged in the instruction of accounting and auditing, including
- 7 the University of Nebraska, the Nebraska state colleges, and private
- 8 universities and colleges. One member of the advisory committee shall be
- 9 a certified public accountant who is a member of the board.
- 10 (2) The advisory committee shall meet at the direction of the board
- 11 least annually and shall advise the board upon the rules and regulations
- 12 for section 1-116 relating to educational requirements. The board may
- 13 also consult the advisory committee on any other issues which it deems
- 14 appropriate.

- 25 section 1-136 to a holder of a reciprocal certificate issued under
- 26 section 1-124 upon a showing that:
- 27 (a) He or she meets all current requirements in this state for
- 28 issuance of a permit at the time the application is made; and
- 29 (b) At the time of the application for a permit the applicant,
- 30 within the ten years immediately preceding application, meets the
- 31 experience requirement in subdivision (1)(a) or (b) of this section.
