- 5 sections.

- 3 60-331.02 Handicapped or disabled person means any individual with a
- 4 severe visual or physical impairment which limits personal mobility and
- 5 results in an inability to travel unassisted more than two hundred feet
- 6 without stopping or without the use of a wheelchair, crutch, walker, or
- 7 prosthetic, orthotic, or other assistant device, any individual whose
- 8 personal mobility is limited as a result of respiratory problems, any
- 9 individual who has a cardiac condition to the extent that his or her
- 10 functional limitations are classified in severity as being Class III or
- 11 Class IV, according to standards set by the American Heart Association,
- 12 and any individual who has permanently lost all or substantially all the
- 13 use of one or more limbs.
- 14 Sec. 2. Section 60-3,113.05, Revised Statutes Cumulative Supplement,
- 15 2014, is amended to read:
- 16 60-3,113.05 (1) Permanently issued handicapped or disabled parking
- 17 permits issued prior to October 1, 2011, shall be valid for a period
- 18 ending on the last day of the month of the applicant's birthday in the
- 19 third year after issuance and shall expire on that day. Permanently
- 20 issued handicapped or disabled parking permits issued on or after October
- 21  $\frac{1}{1}$  shall be valid for a period ending on the last day of the month
- 22 of the applicant's birthday in the sixth year after issuance and shall
- 23 expire on that day.
- 24 (2) All handicapped or disabled parking permits for temporarily
- 25 handicapped or disabled persons shall be issued for a period ending
- 26 either three months after the date of issuance or six months after the
- 27 date of issuance, with such period to be based on the estimated date of
- 28 recovery, but such permit may be renewed one time for a similar three-
- 29 month or six-month period. For the renewal period, there shall be
- 30 submitted an additional application with proof of a handicap or
- 31 disability.
