1 A BILL FOR AN ACT relating to the Motor Vehicle Registration Act; to  
2 amend section 60-3,104, Revised Statutes Cumulative Supplement,  
3 2014; to eliminate provisions regarding film vehicles; to harmonize  
4 provisions; to repeal the original section; and to outright repeal  
5 sections 60-327 and 60-383, Reissue Revised Statutes of Nebraska.  
6 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-3,104, Revised Statutes Cumulative Supplement,  
2 2014, is amended to read:

3 60-3,104 The department shall issue the following types of license

22 section 60-3,116;

23           (27 ~~28~~) Personalized message license plates for motor vehicles and  
24 cabin trailers, except commercial motor vehicles registered for over ten  
25 tons gross weight, issued pursuant to sections 60-3,118 to 60-3,121;

26           (28 ~~29~~) Prisoner-of-war license plates issued pursuant to section  
27 60-3,123;

28           (29 ~~30~~) Purple Heart license plates issued pursuant to section  
29 60-3,125;

30           (30 ~~31~~) Recreational vehicle license plates issued pursuant to  
31 section 60-3,151;

1           (31 ~~32~~) Repossession license plates issued pursuant to section  
2 60-375;

3           (32 ~~33~~) Special interest motor vehicle license plates issued  
4 pursuant to section 60-3,135.01;

5           (33 ~~34~~) Specialty license plates issued pursuant to sections  
6 60-3,104.01 and 60-3,104.02;

7           (34 ~~35~~) Trailer license plates issued for trailers owned or operated  
8 by the state, counties, municipalities, or school districts issued  
9 pursuant to section 60-3,106;

10          (35 ~~36~~) Trailer license plates issued pursuant to section 60-3,100;

11          (36 ~~37~~) Trailers exempt pursuant to section 60-3,108;

12          (37 ~~38~~) Transporter license plates issued pursuant to section  
13 60-378;

14          (38 ~~39~~) Trucks or combinations of trucks, truck-tractors, or  
15 trailers which are not for hire and engaged in soil and water  
16 conservation work and used for the purpose of transporting pipe and  
17 equipment exclusively used by such contractors for soil and water  
18 conservation construction license plates issued pursuant to section  
19 60-3,149;

20          (39 ~~40~~) Utility trailer license plates issued pursuant to section  
21 60-3,151; and

22          (40 ~~41~~) Well-boring apparatus and well-servicing equipment license  
23 plates issued pursuant to section 60-3,109.

24          Sec. 2. Original section 60-3,104, Revised Statutes Cumulative  
25 Supplement, 2014, is repealed.

26          Sec. 3. The following sections are outright repealed: Sections  
27 60-327 and 60-383, Reissue Revised Statutes of Nebraska.
